During 1809, there cleared 434 vessels, (87,825 tons) manned by 4174 men-carrying away the following, among other articles, viz. 198221 bushels wheat, 19467 barrels flour, 32915 qut. biscuit, 54347 bushels peas, 7540 do. oats, 3478 do. barley, 28090 do. flaxfeed, 2783 tierces and bbls. pork, 1766 do. beef, 10143 ps. oak timber, 23699 do. pine do. 257 do. walnut, &c. 8052518 ps. staves and head. 27461 stave end, 262480 boards and plank, 6848 handspikes, 8424 oars, 3064 malts, 269 bowsprits, 2570 pine spars, 134850 hoops, 39000 thingles, 30942 calks pot and pearl alhes, 406 bales cotton wool, 276792 ikins of various animals, &c. &c. &c. -Of the above 434 veffels, 23 remain in the Province by the early fetting in of (Boston Centinel.) the winter.
