

PROCLAMATION FOR PARDONING DESERTERS FROM HIS MAJESTY'S LAND FORCES.

WAR-OFFICE, Office, October 24, 1809

HEREAS it has been most humbly submitted to the KING, whether on the joyful occasion of His Majesty's entering into the fiftieth year of his reign, it might not be desirable to distinguish so nemorable an epoch by an act of grace to all deferters; and his Majefly having graciously approved of his free pardon being extended to all fuch deferters from his Land Forces as shall deliver themselves up within two months from the 25th instant, these are publicly to declare his Majesty's benevolent intention; and to direct that all deserters surrendering themselves to the Commanding Officer of any Regiment, or to any of the Superintending Field-Officers of the Recruiting Service, whose Stations are mentioned in the margin hereof;* to the Commandant of the Army Depot in the Isle of Wight; or, where there is no Military Post, to a Magistrate, shall be pardoned, and they are hereby pardoned accordingly.

Such Deserters, if from the Regular Forces, being ablebodied men, and fit for Service, shall be sent to the Regiments from which they respectively deserted, or be appointed to such Regiments in the United Kingdom as His Majesty may be pleased to command; and when so placed, shall not be liable to be claimed by any other corps to which they may formerly have belonged; and if from the Militia, shall be fent to the Regiments to which they respectively belonged, &c. &c. &c.

His Majesty has further been pleased to direct, that Deserters now actually in confinement as such, shall have the benefit of this his Royal Pardon.
