ARMY OF ST. DOMINGO. GENERAL STAFF.

St. Domingo, 11th Nov. 1808. Head-Quarters, ORDERS OF THE DAY.

The General in Chief is no more, he fell a victim to his blind confidence. Let us pay to his memory the just tribute of tears and praise we owe to him. - But let not grief enervate our fouls: I do not conceal from you your danger, it is worthy of your courage. Preserve the attitude you have taken-Providence and the genius of France hover over us. Let us hope every thing-nothing is impossible to a firm and decided will.

BARQUIER. (Signed) Brigadier General Barquier is naturally called to fucceed General Ferrand, and accordingly he takes the command in chief of the army, and the reins of administration. The present orders of the day shall be read to the troops affembled during the day, in their respective quarters.

> BOSTON. JANUARY 6. FROM EUROPE.

Yesterday arrived at this port, the schooner Jane, Capt. HALL, in 35 days from Oporto. Sailed from that place on the 29th of November. About ten days before his departure intelligence had been received from Corunna, that a great battle had been fought between the Spanish troops and People, contending for the Independence of their Country, and their invaders, the French, in which the former suffered a defeat, with the loss of 30,000. This news had not been officially received at Oporto, but was credited by some. The Portuguese, however, appeared to be in good spirits. The action, it was said, took place near Pampeluna.

If it should prove correct, that a battle, so disastrous for the world, has taken place, it must have been fought early in November-and our next arrival from England will probably furnish the particulars.

Letters from Oporto to the 25th of November, are silent

as to the above information.

BONAPARTE was said to be on the Spanish Frontiers with an army of 200,000, and the French army engaged was reported at 150,000.

JANUARY 7. Since mail, we learn that the Non-Intercourse bill, and bill for enforcing the Embargo, both passed the House of Representatives of Congress, on Friday. The Non-Intertercourse bill to take effect on the 1st of June.

> NEW-YORK, JANUARY 3. VERY LATE FROM SPAIN.

By the arrival of the British Brig Henry, from Malaga, the Editors of the New-York Gazette have received Madrid papers to the 8th, and Malaga papers to the 16th of November, from which the subsequent Translations are made. It does not appear, that there has been any material change in the position of the different armies, since our former advices -- nor that any general battle had been fought. The Madrid Gazettes are completely filled day after day, with donations from individuals for the use of the armybut one sentiment seems to pervade the breast of every individual Spaniard-all are anxious to evince their determination of losing their all, rather than submit to the tyrant of Europe. Capt. Hanney is the bearer of Dispatches from our charge des affaires, at Malaga, to the Secretary of State.

VIC, IN CATALONIA, OCTOBER 24.

We are endeavoring to concentrate the enemy, and in particular the line at Barcelona, from whence persons of the first respectability assure us, that the general quarters are about to be removed to Sorria, a mile and a half from Barcelona, to confine the French still more, who, it is said, are much divided among themselves.

GERONA, OCTOBER 30.

Last week 3000 men stationed at Rosellon appointed to protect the coast, and go to Bayonne, to reinforce the army of Navarre, with 600 mountaineers, accompanied by some gens d'armes, most of whom were hand-cuffed, on the second day's journey, from Perpignan, mutinied, curfing their regenerator, Bonaparte, attributing to his ambition all their misfortunes, laid down their arms; after killing some of the gens d'armes, liberated themselves.

ARANJUEZ, NOVEMBER 4. General Palafox, a member of the central government, with the Count Montejo, have gone to Catalonia to review the troops and ground, and proportionate the needful for the defence of the country, and to expel the enemy.

The central government have decreed that each Vivrevnati, of which there are five in South America, shall send two Deputies to the General Government. They have also directed that their President Count Florida Blanca shall have in his service the Royal Body Guards.

The Marquis de la Romana has set out from Villacassin and Vittoria to take command of the 9000 men who arrived from the Baltic, and landed at St. Andero, and form

part of the army of Gen. Blake,

MADRID, NOVEMBER 1. The French attacked our line on the Ebro by Logrona, Lodosa, and Lerin; the two first points very feebly-At the last point General Moncey charged with his whole division, which was refisted by the riflemen from Cadiz, who suffered severely. General Blake dislodged the enemy at Zarnoza, with great loss, and pursued the enemy to Vingara, by which means the road to Izun is cut off, leaving the French no other means of getting to France but that of Roncesvallos. From the ardor of our troops, we anticipate the most brilliant result. They with for nothing more than for a general battle. Such is the impetuofity of the troops that their commanders can hardly restrain them,

NOVEMBER 4 .- The celebrated Valdes and Count de a Quintarilla, have taken the oath as Deputies to the central government from the kingdom of Leon.

The army of Gallicia, on the 26th ult. attacked, and continued on the 27th, dislodging the French from all their

polls-and on the 28th, occupied the polition of Durango. When the post set off, the French continued retreating, and ours purfuing them. The refult will doubtless be glorious to our arms.

HALIFAX, JANUARY 6.

Accounts from Washington to the 25th ult. mention that, the Non-Intercourse having been agreed to by the House of Representatives, a Committee was appointed to draft a Bill for that purpose: - The time when it was to take place was not determined on.

A late English paper says, that at the conference at Erfurth, were present-two Emperors-five Kings, and seventy-one Princes and Princesses.

A letter from St. Croix, dated November 19, says-"In a few weeks Martinique will be added to the number of captured Illands, as well as Guadaloupe, as it is supposed little opposition will be made-A force of from 8 to 10,000 men will go against them"-Bos. Pap.

A fleet of about 100 fail of merchantmen from Gottenburgh, &c. arrived in England October 30.

A pilot-boat schooner full of men, and under French colors, arrived at Norfolk on the 17th ult. 20 days from the city of St. Domingo.

The French national schooner Calibre, 3 guns, 66 men, and the national schooner Flor de la Mar, were sent into Jamaica November 24.

The schooner Nancy left Barbadoes December 6 :-- The Maffer reports, that there were nearly 10,000 troops at that Island, in readiness for the Expedition. Five ships of the line had lately arrived there from England, -Provisions were plenty -and feveral American vellels had been taken attempting to carry supplies to the French Islands.

The Chesterfield packet, with upwards of 40 passengers on board, failed from New-York for Falmouit, on the . 15th ult.

H. M. ships Melpomene and Diamond, from Vera Cruz for Cadiz, with 5.000,000 dollars on board, were spoken December 4, las. 30 33.
