BONAPARTE IN AMERICA. We have heard of a farce called " Bonaparte in En. gland." This was performed many seasons on the theatre of Europe; and though the manager announced it as a deep tragedy, it turned out to be nothing more than a ridiculous farce. It gave the English no uneas siness; on the contrary it afforded them a great deal of amusement: they laughed at the managers and at the folly of the piece, and set the power of the actors at defiance. This, we fear, will not be the case, now the piece is to be acted on our stage. Bonaparte in America, is like to be a tragedy. The first act is now performing. In obedience to the order of his Imperial Majesty all goods which have left Great-Britain or her dependencies since the 2d of February, are to be seized and confiscated. There are now a number of vessels, with valuable cargoes, cruizing off this port which cannot come in, without being subjected to the continental system. Our ports are now in the same situation as those of France. They are closed against all free trade. Nothing can be done in the commercial line, but what is carried on under the Emperor's licence. We are as much a dependency of France as Denmark, Sweden, or any other of his Majesty's conquered dominions. The second act of the drama will be a law, such a one as was recommended by Mr. Gallatin, and reported by Mr. Eppes at the last session of Congress. The third act will be the burning of British goods, and raising of conscripts to fight under the banners of the Emperor for the liberty of the seas. Of the fourth and fifth acts any one can judge who has lived to see such tragedies performed in Europe. The catastrophe will close with the annihilation of our government and liberties, and a reduction of our country to a province of the great empire.-N. Y. Ev. Post.

A PROCLAMATION. TATHEREAS by an Act of Parliament passed in the forty-eighth year of His present MAJESTY's Reign, power is given to the Governor, Lieutenant-Governor, or Commander in Chief, with the advice and consent of His MAJESTY's Council, to allow the importation of certain enumerated articles from the United States of America into this Province, for the purpose of re-exporting the same.

I have therefore thought fit, with the advice and consent of His MAJESTY's Council, to publish this Proclamation, hereby authorising and empowering British Subjects, for the space of Six Months from the date hereof, to import and bring into this Province, from the United States of America, in British built ships or vessels, owned and navigated according to Law: Scantling, Planks, Staves, Heading, Boards, Shingles, Hoops, or Squared Timber of any sort; Horses, Neat-Cattle, Sheep, Hogs, Poultry, or Live Stock of any sort; Bread, Biscuit, Flour, Pease, Beans, Potatoes, Wheat, Rice, Oats, Barley or Grain of any sort; and British Subjects, during the same period, are hereby authorised and empowered to export in British ships, owned and navigated as aforesaid, all or any of the said herein before enumerated articles to any other of His Majesty's Colonies or Plantations.
