this ship, led on by Lieutenant Conoly, without a man being hurt.

"The Captain of a vessel arrived from Carlsham reports, that upwards of 50 ships laden with colonial products have been detained in that port, and their cargoes conveyed under a strong escort into the interior."

Extract of a letter from Stralsund, May 1. "There is great activity employed here in making preparations of defence to oppose the English in case they should actempt a descent. The garrison will be reinforced. We are constructing, new batteries, and daily expect some gun-hoats from Sweden."-(Abeille du Nord, May 7, 1811.) "PRESBURG, APRIL 12.

"The mission of M. Fenton, the Russian agent to the Turkish head-quarters at Schumla, has not succeeded. The Grand Vizier declared, that peace could not be re-established between Russia and the Porte, unless the Court of St. Petersburgh would renounce its pretensions upon Wallachia and Moldavia, and withdraw her troops from Servia.

"PLYMOUTH, MAY 18. "A Prussian vessel arrived here yesterday from Memel; by which is learnt a most extraordinary circumstance, and if true, shews the cunning of Bonaparte in its true colours. The master says, it was confident, ly asserted, that a plan was laid by the emissaries of Bonaparte to carry off to Paris Frederick King of Prussia; he escaped at fifteen minutes notice, and it is said has got into Russia in safety."

The Fame, Phillips, of and from Penzance, in her passage to Gibraltar, fell in with, in lat. 42. 36. long. 9, 50. (date not mentioned) a French 74 gun ship, full of troops, steering S. W. and was detained a few hours.

By the arrival of the brig Sir George Prevost, intelligence of great moment was received—the capture of Almeida and Badajos by the Allied Armies and the severe defeat of the respective forces under Massena and Soult, near those places .- A Liverpool paper of the 30th of May, had been obtained by the Jason frigate, from a brig bound to Quebec - We have been favored by a Gentleman of this town, with the following extracts made from it by his attentive and intelligent correspondent at St. John's:

GLORIOUS NEWS!!

BATTLE BETWEEN GENERAL BERESFORD AND MAR-

SHAL SOULT. FALL OF ALMEIDA.

A bloody, and most desperate battle has been fought at a place called Albohera, near Budajos, between the Allied Armies, under the command of General Beres. ford, and the French Army commanded by General Soult. The latter, it appears, had formed the resolution of raising the siege of Badajos, and with this view he marched his whole force, (28,000 strong) towards that fortress. General Beresford opposed to Soult, the British, Spanish, and Portuguese. The engagement took place on the 16th. The French were the assailants, and the conflict was maintained on both sides with the most undaunted courage and bravery; but the enemy were repulsed with immense slaughter. The brunt of the battle fell peculiarly hard upon the Spaniards; who are said to have fought incredibly well: "four thousand of those brave fellows," says an article from Lisbon, " were our advanced guard: they fought and died like the old Spartan band-every man of them fell, and each was killed on the spot on which he fought."

Almeida has likewise fallen into the hands of the Allied Army, under Lord Wellington: it was abandoned by the enemy on the 10th, and taken possession of by our troops on the 11th instant. There appears only to have been 1000 men in the garrison before it was evacuated-part of them were taken in their attempt to

Lord Wellington's despatch, dated Villa Formosa, May 8, details the engagement of Fuentes de Honor, which was very obstinate. This desputch confirms the report of Joseph Bonaparte having gone to Paris.

A concluding desputch of the 10th, says, the enemy retired on the 8th to the woods between Espija Gallegos and Fuentes de Honor-in which position the whole army were collected on that day and yesterday, with the exception of that part of the second corps—which continued opposite Almeida. Last night the whole broke up and retired across the Azava, covering their retreat by their numerous cavalry, and this day the whole have retired across the Agueda, leaving Almeida to its fate. The second corps retired by the bridge of Barba del Puerco and the ford of Val de Espina on the Agueda. Our advanced posts are upon the Azava and on the lower Agueda, and the army will be to-morrow in the cantonments on the Duas Casas.

WELLINGTON. (Signed)

An official letter from Lord Wellington, of the 15th May, gives an account of the buttle of Barba del Puerco; and another on the 18th mentions that the enemy had blown up the works at Almeida, and retired to Barba del Puerco, with considerable loss.

In this engagement General Nightingule was wounded slightly; Lieut. Col. Williams, do.; Lieut. Colonel Cameron, 79th, killed.

Soult broke up from Gillena on the 9th May, and at Zafra effected a junction with Gen. Latour Maubourg, which increased his number to 22,000. General Ballasteros fell back, joined General Blake, and, on the 13th, Marshal Beresford and Castanos concentrated their forces at Valverda, where they were joined by Ge. neral Blake.

On the 16th, Marshal Soult attacked the combined army at Albohera, and, after an obstinate action, was repulsed with great loss-abandoning his wounded, and retiring to a position in sight of the British advanced posts.

The loss on the part of the Allies is not specified, but understood to be very severe-Major General Hogh. ton, killed; Major General Cole, and W. Stewart, slightly wounded; Lieut. Colonels Sir W. Myers and Duckworth, killed.

ELVAS, May 18, Seven P. M. The battle lasted six hours and a half; the enemy had two Generals killed - one wounded. At eight this morning General Hoghton was buried.

The first intelligence of the engagement with General Beresford and Soult, reached the Admiralty yester. day afternoon in the following telegraphic despatch: " The French Marshal, Soult, with 25,000 men, attacked Marshal Beresford on the 16th instant, but was

repulsed with great loss." Despatches confirming this highly interesting and tru-

ly important affair, are said to have arrived in London, from Marshal Beresford.

HORSE-GUARDS, MAY 25, 1811. His Royal Highness the Commander in Chief has been pleased to appoint Lieut. Col. Henry Torrens, of the 98th regiment to be his Military Secretary.

The Atalante, sloop of war, from Bermuda, with despatches for Col. BARCLAY, our Consul at New-York, anchored within Sandy-Hook on the 17th ult, and sail. ed from thence the 20th-We have been favored by her officers with New-York papers to the 19th ult. from which we have made a few extracts.

On the 9th May, His Majesty's Ships Eurydice. Capt. Bradshaw, and Atalante, Capt. Hickey, off Cape Henry, fell in with the American frigate United States. Commodore Decatur, and while Captains Bradshaw and Decatur were exchanging friendly salutations, a shot was fired from the United States-immediately our ships prepared to fire, when Commodore Decatur hailed, and gave his word and honor that the firing of the gun was the effect of accident-Capt. Bradshaw then sent his Lieutenant on board the United States, where the Commodore again, in the presence of his ship's company, declared it to have been an accident-with which declaration Capt. Bradshaw was satisfied.

The conduct of Capt. Bradshaw throughout this affair, was well tempered with dignity and moderationand the result honorable to his country and himself.

Our gallant Tars have again distinguished themselves in the Adriatic Sea-His Majesty's Ships Amphion. Active, Cerberus and Volage, were attacked on the 13th April, near the Island of Lissa, by a combined French and Italian squadron, comprising 5 frigates, 1 corvette. and 4 smaller vessels—they fought 6 hours, and the action terminated in the total defeat of the enemy, the capture of two frigates, and destruction of another .-We have given the official details of this glorious achievement, extracted from a London paper of the 20th May, received via Newfoundland.

The Bream brought despatches from Mr. Foster. who had touched at Bermuda, in His Majesty's Ship Minerva, on his way to the United States, on the 20th ult .- He was expected to leave Bermuda the moment

the wind became favorable.
