again taking a position, and endeavouring to maintain the line of the Tagus. With this design General Marmont began to move from Salamanca towards Avila, on the 26th and 27th ult. whither he intended to transfer his head-quarters, while a part of his army was to be cantoned at Talavera de la Reyna, Drouet, with 5000 men, also took the same direction on the 16th.

Advices were yesterday received from Monte Video to the 11th of April. Capt, Eliot, it is said, disgust. ed with the treatment he received from the Governor of the place, had sailed with the vessels under his command for the Brazils. The British Merchants at Buenos Ayres, considering their trade as no longer secure, were preparing, with all expedition, to leave the country.

Lord Wellington's last despatch, we understand, confirms the account by the Lisbon Mail, of the move. ment of a division of Marmont's army to the South ward; and apprizes Ministers, that Sir B. Spencer had, in consequence, been ordered to march with his division to reinforce Sir W. Beresford.

A letter received at Lloyd's, from a gentleman possessing the best means of information, confirms the ac-

count of the arrival of Gen. Lauriston at St. Petersburgh, adding, that all differences between the Russian and French Governments are amicably settled. The communication alluded to further says, that the great. est strictness prevaits at Mecklenburgh, and all the ports of Pomerania. Domiciliary visits had been paid, and great danger was apprehended for any vessel touching at any of those places.

JUNE 19. Government has given notice to the merchants, that no Baltic import-licences will be granted for any vessel chartered in any foreign port, unless she shall have been chartered on or before the 15th of August; nor any vessel be licenced to proceed to the Baltic from any port in the United Kingdom in ballast, but on condition that she shall clear out before the last day of June.

The Board of Trade, in their notice to the Merchants of the regulations with regard to the Baltic licences, state, that they have been adopted with the avowed object of preventing the recurrence of the difficulties which occurred last year, as to the renewal of licences; it being now distinctly understood, that no renewal of the licences for the Paltic Trade will take place.

A letter from Koningsburgh, of the 20th of May, rays, "The Poles every where are well disposed to Russia, and ill-disposed to France. There might be easily raised an army of 150,000 fine men, accustomed to hardships."

Letters from our squadron in Basque-roads, represent the enemy as making the greatest exertions in the equipment of their ships in Brest, Aix-roads, &c. In the former place, two sail of the line and four frigates are lying ready to start, as soon as an opportunity preseuts itself, by our blockading ships being driven off the coast. The master of a French sloop, captured on her passage from Brest to Isle Dieu, states, that several hundred Danish, Norwegian, and other foreign seamen, had arrived at Brest, to man the different ships, and that a large number more of the same description were on their way for that place. The master of the Arrow schooner, hir. Hoy, while chasing a French chasse-maree, in the boat of that vessel, on the 5th ult. in Bas. que-roads, was shot through the heart. His comrades and brother Officers, as a token of respect for his gallant conduct on that and every other occasion, brought his body home, and it was interred at Plymouth on Friday, attended by all the Officers of the ship, and a number of private friends.

June 20. The Fox, and seventeen other American vessels, were yesterday finally condemned in the Admiralty Court, upon the ground that no official communication had been made to it of the repeal of the enemy's Decrees of Blockade.

Massena arrived in Paris the 8th June-Marmont

succeeded him in the command. A morning paper says that ministers have accounts of General Desolles having joined Marshal Soult on the 2d inst. with 9000 men, and that Drouet also joined him on the 6th, with 8000.—By what conveyance this intelligence was received is not mentioned, and we

conceive the statement to be unfounded. The main body of Soult's army had retreated to Lierena; an advanced division of it engaged a part of the Allied Army, under Gen. Lumley, near Usagre, and received a severe defeat.

All the little ports of Prussia to the mouth of the Peene, have been occupied by French troops. The artillery for their defence is drawn from the Prussian arsenals. Lauriston, the new French minister, has arrived at St. Petersburgh.

An Anholt mail has brought intelligence from our Fleet to the 4th inst, and we learn with great satisfaction, that Sir James Saumarez, after having collected all the British ships, had proceeded up the Baltic with several hundred sail. This naturally gives rise to the idea of a good understanding subsisting between us and the Emperor Alexander.

> BOSTON, JULY 25. OF LATEST FROM FRANCE.

By the arrival at New-York, of the pilot boat schooner Matchless, Kelly, in 32 days from Bordeaux, a confirmation is received of the release of all the sequestered American vessels and their cargoes that had arrived in French ports after the 2d of November .-Massena and his aids had passed through Bordeaux on the 6th of June on their way to Paris. The young King of Rome was christened on the 9th June. There were no accounts at Bordeaux when Capt. Kelly sailed, of any new battle having been fought in Spain or Portugal, nor had war been declared by Russia against France. Captain Kelly has brought despatches from Mr. Russell the Charge d'Affairs at Paris to the Secre-

tary of State.

This intelligence, which is much the latest that has been received from any quarter of Europe, puts to silence the ridiculous tale in the last Chronicle, of a great battle having been fought a short time after the affair at Albuera, in which the British lost 12,000 men. We were apprised of the falsehood of this tale, by the previously received accounts from the seat of war; and the Chronicle editors, if they had been disposed to examine them, to look at their maps and count dates, could have gained all the information, necessary, in detecting the imposition.

CT NAVAL ENGAGEMENT.

NEW-YORK, JULY 22 .- Capt. Bulkley arrived here last evening, informs, that on Saturday last, off the Capes of the Delaware, 40 miles from the land, he witnessed an engagement between two ships of war, which continued from 4 till half past 6 P. M. when one of the ships struck. After the engagement, an officer from one of them came on board Captain B's schooner, the Ann Eliza, who proved to be an officer from the British sloop of war Atalante, Capt. Hickey, who informed that the ship that had just struck to the Ata. lante, was the French frigate Interprenante, of 32 guns, bound from Brest to New-York, with despatches and some cargo. The Atalante had 1 man killed, and 4 wounded. The Interprenante had 30 killed and wounded-The Atalante mounts 18 guns. Captain Bulkley did not learn how long the French ship had been out, or what became of the despatches.

> BOSTON, JULY 19. BRITISH AMBASSADOR.
