From the Combined Armies, late and important. We are indebted to a very respectable gentleman of this city, for the following extract of a letter, dated LISBON, OCTOBER 6, 1811.

"Lord Wellington has invested Ciudad Rodrigo with his whole army; notwithstanding which, about the first of October, Gen. Mortier, with 10,000 men forced their passage into the town. The next day a hody of 4000 cavalry, made a dash on the English army, and completely destroyed a whole light division.

Lord Wellington's head-quarters were precipitately removed to Guarda, where he remained on the 3d of October; but the combined army was in a few days expected at the lines."

Latest from England—The Oronoke is below in 32 days from Liverpool. The passengers have arrived in a pilot-boat. We have been favoured with the perusal of a file of London papers to the 29th of September, three days later than we had before received.

A paper of the 26th states: that "the affairs of Sicily had latterly assumed the most unfavorable aspect, and there is every reason to suppose, that scenes of the darkest complexion in regard to the government of that kingdom will very speedily be disclosed." Lord William Bentinck, whose mission has been unsuccessful, has returned to England in the Cephalus frigate. It is said that his Lordship left his family in Sicily; hence the inference that he will soon return thither.

It is said in a paper of the 27th, that preparations are making at Rotterdam, for the arrival of Bonaparte.

LONDON, SEPTEMBER 26. There is every reason to believe that the most important events are on the eve of taking place on the frontiers of Spain. We have seen a letter from an officer of high rank in the army of Lord Wellington, dated at head-quarters, the 4th inst. which states that the whole army was then concentrated in the neighbourhood of Ciudad Rodrigo, and that the meditated grand operation could not be many days delayed, from the difficulty that must naturally be experienced in providing the necessary forage for the immense number of fine cavalry which had just arrived to assist in the projected enterprise—the precise number of the operations about to be undertaken the writer does not pretend to be acquainted with—as Lord Wellington never discloses his plans even to those officers most in his confidence; but he expresses a persuasion from the formidable disposition that had been made of our forces that a general engagement would very shortly take place. From all that we have been able to learn upon the subject, we are inclined to think that the opinion of this officer is perfectly correct. We believe that Lord Wellington is determined to give immediate battle to Marmont, and from the admirable plan he has formed for that purpose, there is every reasonable ground of hope that the result will prove alike glorious to the allied arms, and substantially beneficial to the common cause.

Some more papers from Germany have been received, but none of later dates than those by the Anholt Mail of yesterday. An article dated Vienna, the 18th last, states that the Russians were ready to cross the Danube again, should circumstances require it, and that there was a report at Bettegrade of the renewal of the conferences between them and the Turks.

There is said to be an Embargo on the French ports; and it is suspected to have been laid as a preliminary step to the sailing of the Scheldt fleet, which amounts to 21 sail of the line. The general belief is, that it will attempt to go North about: though some persons think it will try to pass down the British Channel.

Our Gazettes from Messina, which are to the beginning of last month, notice some movements among the troops of Joachim, which may have arisen from the disaffection and disturbances in the Island.

"Advices from Naples," we are told, "state, that the Regiments of Real Corso, Prenupe Reale, and Real Sannita, have left that city, and have taken the direction of Calabria to replace some other regiments which are to occupy a new position in the same province."

This circumstance, after the protracted inactivity of the Neapolitan forces, deserve some attention, connected as it may be with the particulars to which we have adverted.

The withdrawing Sir John Stuart, was consequent on the appointment to the chief command of Lord W. Bentinck. His Lordship having now returned, the Anglo-Sicilian army is left under the orders of General Maitland, with the perfect approbation, we hear, of all the forces of which it is composed.

SEPTEMBER 29. The accounts we received last night from Windsor, we are happy to say, represents the reports of the Docters to the Queen's Council to be of a more favorable

nature than that of the preceding week. A Privy Council is expected to be holden at the Treasury Chambers on Tuesday next, for the further prorogation of Parliament till the 13th of November, to assemble then for the despatch of business. The urgent necessity of additional supplies is stated as the ground acknowledged by Ministers for the adoption of this measure. The Prince Regent is expected to preside in person at the Council.

The West, India Coffee Planters would be very materially benefited by the adoption of a measure which has been suggested by their Agent for the consideration of Ministers-namely, to direct the general consumption of coffee in the navy, and to grant permission for its exportation from the colonies in neutral shipping, in return for supplies imported in such vessels: The conduct of the Sicilian Court is not difficult to be accounted for-the Queen of Sicily is aunt to the Emperor of Austria; and the Emperor of Austria is father_in_law to Bonaparte.

Our port letters of yesterday, we regret to state, furnish a melancholy catalogue of shipwrecks caused by the severe equinoxial gales which have prevailed

during the last three days. Within the last few days the following arms and military stores have been sent from the Tower, to be shipped for Malta and Spain:-15,000 stand of arms, 3,000,000 ball cartridges, 3000 barrels of powder, 50 tons of lead, one ship load of rockets, 2000 pistols,

From Stockholm, we learn, that only one of the murderers of Count Ferzen has been sentenced to suffer death; the others are to receive very slight punishment.

SURVEYOR GENERAL OF WOODS DEPARTMENT. FREDERICTON, 16th SPPTEMBER, 1811. The following extract from the Statutes for the preservation of His MAJESTY's Timber in America is republished in order that no person may plead ignorance thereof-And Notice is hereby given that the Acts herein referred to will be strictly carried into

execution, in this Province. Y 8 Geo. I. ch. 12, it is enacted, That every Person who shall presume to cut down, fell or destroy any White Pine Tree, within His MAJESTY's Province of Nova-Scotia, or any other of the Colonies in America, or be aiding and assisting therein, shall for every such offence forfeit and pay the following sums,

For every White Pine Tree of Twelve Inches diameter, and three foot growth,

from the earth, - - £ 500 From 12 to 18 inches, 10 0 0 18 to 24 20 0 0 50 0 0 To be recovered in the Courts of Admiralty.

It is further enacted, That all White Pine Trees, Masts and Logs made from such Trees, which shall be found cut or felled without Licence, shall be forfeited and seized for the King.

By 2d Geo. ch. 35, it is enacted, That no Person within the Province of Nova-Scotia, or any other of the Colonies that now belong or hereafter shall belong to the Crown of Great-Britain, shall presume to cut down, fell or destroy any White Pine Trees, notwith. standing the said trees do grow within the Limits of any Township laid out, or to be laid out hereafter, without His MAJESTY'S Royal Licence for so doing first had and obtained, on Penalty of the forfeitures mentioned in Act 8, Geo. 1.

All Persons therefore who shall cut down, fell or destroy, any White Pine Trees within the limits of this Province without Licence (contrary to the true intent and meaning of the said Acts) shall be prosecuted as the Law directs.

And all Persons are hereby cautioned against cutting Trees of any kind upon the Lands reserved for the use of the Crown, or committing any other depredations thereon, as they would avoid the penalty of the Law in that case made and provided.
