ANOTHER NATION EXTINCT. LONDON, September 18.—Napoleon's Conservative Senate in Paris have decreed, that Prussia shall be annexed to the French Empire; and the event has been proclaimed at Berlin. Poor Frederick William is gone on a water-drinking excursion into Germany; and his numerous family are to become pensioners on the Corsicau's bounty. What a world and age we live in ! The French custom-house officers have ordered that all the ships in the Hanseatic ports shall be provided with the flags and insignia of France.

### WAR OPERATIONS.

The Montpelier paper of Nov. 19, states the following:--" A letter from a gentleman at Plattsburgh, received in town yesterday, mentions that all the militia had left there for Sharsee, to encamp in the woods, where fuel was plenty. The regular troops were about to march for the French Mills. Many of the Militia and regulars were sick, and numbers dying daily."

The Burlington paper, of same date, gives the following additional news of military operations :

"General Dearborn arrived at Plattsburgh, N. Y. on Sunday last from Greenbush.

"The army of Plattsburgh had marching orders read on Saturday the 14th inst. and on Monday following the camp was broken up. "The drafted militia under Gen. Ormes, have left Swanton for Champlain, (a township in Clinton county, N. Y. and joins the British Province) where they are to join the army from Plattsburgh. #### THE BORDER WAR.

CAMP, BUFFALO, (N. Y. end of lake Erie.) Oct. 26. We are making preparations for another descent on Canada, though there is an *armistice* existing on the river between the lakes. We have nearly 2000 men, and depend upon it, we shall be in Canada by the middle of November.

### LATEST FROM THE LAKES.

Our little fleet on the lakes, consisting of the brig Oneida and 7 schooners under the command of Com. Chauncy, went into Kingston Bay on the British side on the 8th inst. and after a severe cannonade from the Fort, returned to Sacket's harbour, with two prizes— Capt. Brock, of the 49th regiment, (nephew of the late Gen. Brock) was taken prisoner in one of the prizes. Com, Chauncy returned again to Kingston the next day.

LATEST FROM ST. DOMINGO.

Capt. Lyon, of the Spanish brig Baylen, who arrived at New-York from St. Domingo, informs us, that a few days before he sailed, there was a severe battle between the armies of Petion and Christophe, in which the latter was defeated with considerable loss. He also stated, that a day or two after the battle, Christo. phe was killed in a quarrel with one of his aids.

A PROCLAMATION. TATHEREAS the United States of America have Declared WAR against HIS MAJESTY, I have thought fit, by and with the advice of HIS MAJESTY'S COUNCIL, to publish this Proclamation; and I do hereby order and direct that all Citizens of the said United States who may be writin the limits of the Province, do without delay give information of their respective names and places of residence to one of the Magistrates, or to the Officer commanding any Military Post in the District of the County in which they res. pectively reside, to be by such Magistrate or Officer transmitted to me with all convenient speed, and do also conform to such directions as may by such Magistrate or Officer be given for their inoffensive conduct; and I do hereby further order and direct that no Citizen of the said United States do depart from this Province without permission first obtained from a Magistrate or from the Officer commanding in the District in which such Citizen may be at the time of his departure; and that all Citizens of the said United States who may at any time be found within this Province, and who shall refuse or neglect to observe and obey these several orders and directions, shall be treated as Prisoners of War, and all Magistrates and other Officers, Civil, and Military, are hereby required to take the necessary steps for carrying these orders and directions into immediate effect.
