

WASHINGTON, NOVEMBER 6.
HOUSE OF REPRESENTATIVES, November 5.
 The following Message was received from the President of the United States, by Mr. Coles, his secretary:
To the Senate and House of Representatives of the United States.

The bill intituled "An Act supplementary to the acts heretofore passed on the subject of an uniform rule of naturalization," which passed the two houses at the last session of Congress, having appeared to me liable to abuse by aliens having no real purpose of effectuating a naturalization, and therefore not been signed, and having been presented at an hour too near the close of the session to be returned with objections for reconsideration, the bill failed to become a law. I recommend that provision be now made in favor of aliens entitled to the contemplated benefit, under such regulations as will prevent advantage being taken of it for improper purposes. The enemies of America.—The British, the Indians and the Algerines, are now all at war with America—and as they will doubtless do all they possibly can against us, it remains for Americans to say how far they shall be successful!—Shall we take part with them against our own government? Or support our own government in its struggle with them? Which ought every American to do?

Extract of a letter from an officer in the 6th regiment, dated Plattsburgh Cantonment, October 27.

"We have just received word that our militia at Shaftstown, which is 18 miles from this, have taken two English Captains, and two Lieutenants and 37 privates, together with a great quantity of blankets, clothing, ammunition and a number of guns, besides a quantity of silver plate and presents for the Indians. We expect to march very soon for Montreal!! Gen. Chandler, from Massachusetts, has joined us this morning with 1400 regulars. We were furnished this morning with flints and 60 rounds of fixed ammunition. Our two companies that went out from Greenbush to Niagara, has shewn a specimen to the world how the 6th regiment will fight. Capt. Nelson, of the State of N. York, and Capt. M'Chesney, of the state of N. Jersey, have fallen victims to the enemy; and poor Ensign Dubois, of Newburgh, and Lieut. Buck are severely wounded. Dubois, Buck, and Wendell, are the only officers living out of the two companies that left us and went on with the army to the westward.

NEW-YORK, NOVEMBER 11.

There are now embodied according to accounts and under pay and rations, about 12,000 militia in the states of Kentucky and Ohio, 2000 in Pennsylvania, and 1500 in Virginia. In the states of New-York, Vermont, &c. a like number, including regulars and militia. At the present moment we have to support and pay nearly 30,000 men. With all this force shall we take Canada this fall?—Doubtful. One company of the Pennsylvania volunteers with the captain and some other officers, have deserted and gone home.

The Pastora frigate, Captain don Sanches de Morilla, arrived at St. Juan de Porto Rico, on the 28th ult.—After obtaining a supply of water, fresh provisions and a pilot, she proceeded on the following day for La Vera Cruz. She sailed from Vigo on the 16th of July, in company with three other vessels of War, having 5 transports with 4000 troops on board under their protection destined for South America; the troops were to be landed at Vera Cruz, and the men of War to proceed home with specie for the Spanish Government. The Pastora, had separated from her consorts in a gale of Wind about ten days previous to her calling at Porto Rico.

We have another item of proof of the total incapacity of the present Administration to conduct the war with honor or success. Letters have this day arrived from Kentucky, stating the failure of General HOPKIN's expedition against the Wabash tribes. His men were disbanded for want of provisions.

THE WASTING WAR.

General Dearborn and suite have left Greenbush for Plattsburgh. Whether on an excursion of idle parade, or to keep on to Montreal, our neighbors the Yankees, may perhaps guess—we cannot.

The troops—excepting we believe one detachment—

which have been paraded at Lewistown, &c. have fallen back to Buffalo. The Militia volunteers, sick of their summer game of *play-soldier*, are making tracks homewards by forced marches.

Letters from the Plattsburgh army, say the British forces have left the vicinity of the lines, and retired into comfortable winter quarters.

The "Army of Canada," at Plattsburgh, makes the greatest show of the pomp and circumstance of War. The regulars there are estimated at from 4 to 5000 bayonets. The Militia are principally volunteers—"lives and fortunes" folks.—Little account is made of them;—when the cold weather sets in, they will be volunteering it to their fire sides. Of the regulars there are two companies of artillery, and one of light artillery, with a fine field train, and a few excellent officers;—there is one company of dragoons, well commanded and well mounted; and the 6th, 9th, 11th, 15th, 16th, 21st and 25th regiments of the line. They form two brigades, commanded by Brigadiers Bloomfield and Chandler. The whole, of course, will be commanded by Major-General Dearborn. What will the American People—who must pay every cent of these wasting war charges—say, if it should turn out, after all this parade, and cost, androdomontade, that instead of advancing forwards to Montreal, one of the first orders of General Dearborn should be to advance backwards and take up snug quarters in Greenbush?

BOSTON, NOVEMBER 18.
LATEST FROM PORTUGAL.

Letters from Lisbon to the 28th September have been received in Philadelphia.—On the 18th of that month Marquis WELLINGTON was at Burgos, in old Castile, and had been joined by Gen. CASTANOS, with 18,000 Spaniards from Gallacia. These letters add, that Massena had not entered Spain. ¶ We doubt the accuracy of this last particular. He certainly passed Bayonne for Spain early in September.

The British Packet Swallow, of 18 guns, Captain Morfin, was captured by the President frigate, Commodore Rodgers, (the Congress in Co.) on the 15th ult. and arrived at Baltimore the 11th inst. She was from Jamaica for Falmouth, with the mail, and had on board specie to the amount of 200,000 dollars, which was taken on board the President. ¶ A letter from Commodore Rodgers, dated at sea, 17th October, states the squadron had not fallen in with any British vessels since leaving Boston, (October 7.) The United States and Argus had parted Co. 12th October.

We are sorry to state the loss of His Majesty's brig Plumper on her way from Halifax to this port; she went on shore on Saturday morning last about four o'clock, a little below Dipper Harbor, and almost immediately after went to pieces;—the Commander Lieut. Bray, the master, two midshipmen, and 38 seamen, together with several passengers, we lament to add, were unfortunately drowned.—Mr. Stephen Hall, midshipman, and Mr. Simpson, pilot, with 28 seamen, providentially got on shore, much bruised. The Plumper had specie on board to the amount of nearly 30,000 dollars, which it is believed will be saved.

Sailed, yesterday, H. M. schooner Bream, and government sloop Brunswick, for Dipper Harbor, to the assistance of part of the late crew of the Plumper.

Extract of a letter from a gentleman at St. Andrews, to the Editor, dated the 3d inst.

"There was a smart firing in the Bay the day before yesterday, supposed to be the Bream engaged with some privateers, of the result we are not yet informed."
