AT the Court at Carlton-House, the 31st of July 1812. PRESENT. His Royal Highness the PRINCE REGENT in Council.

TT is this day ordered, by His Royal Highness the Prince Regent, in the name and on the behalf of His Majesty, and by and with the advice of His Majesty's Privy Council, that no ships or vessels belonging to any of His Majesty's subjects be permitted to enter and clear out for any of the ports within the territories of the United States of America, until further order: And His Royal Highness is further pleased, in the name and on the behalf of His Majesty, and by and with the advice aforesaid, to order, that a general embargo or stop be made of all ships and vessels whats -ever, belonging to the citizens of the United States of America, now within, or which shall hereafter come into any of the ports, harbors, or roads, within any part of His Majesty's dominions, together with all persons and effects on board all such ships and vessels; and that the Commanders of His Majesty's ships of war and privateers do detain and bring into port all ships and vessels belonging to the citizens of the U. States of America, or bearing the flag of the said U. States, except such as may be furnished with British licences, which vessels are allowed to proceed according to the tenor of the said licences; but that the utmost care be taken for the preservation of all and every part of the cargoes on board any of the said ships or vessels, so that no damage or embezzlement whatever be sustained; and the Commanders of His Majes. ty's ships of war and privateers are hereby instructed to detain and bring into port every such ship and vessel accordingly, except such as above excepted; And the Right Honorable the Lords Commissioners of His Majesty's Treasury; the Lords Commissioners of the Admiralty, and Lord Warden of the Cinque Ports, are to give the necessary directions herein as to them may CHETWYND. respectively appertain. Extract of a Letter from the Earl of Bathurst, one of His Majesty's Principal Secretaries of State, to His Honor the President, dated Doconing-Street, 10th August, 1812. PUBLISHED BY AUTHORITY. ## HALIFAX, OCTOBER 5. LOSS OF THE BARBADOES FRIGATE.

His Majesty's Ship Barbadoes, of 28 guns, Captain Huskisson, sailed from Bermuda on the 15th ult. with 3 vessels under her convoy, for St. John's N. F .---About 10 o'clock on Sunday night the 27th inst. the' wind blowing hard, with a heavy sea and hazy weather, the ship struck on the N. W. Bar of Sable Island-and, notwithstanding every exertion, was completely lost .----Two of the convoy, schooner Emeline, with a cargo of sugar, and sloop Swift, with rum, also went on shore, and soon went to pieces .- The Captain, Officers, and crew of the frigate, with the exception of one man, and those also of the merchant vessels, were fortunately saved, as was also, the cargo of the Swift, and part of the provisions, &c. of His Majesty's ship. Ships Nymphe, Belvidera and Acasta, on the 30th ult. cruising off Boston Bay -and lately captured the American ship Melantho, from Chili, bound to New-York, and ordered her for this place. The Acasta has taken an American ship from Africa bound to New-York.
