

August on the Grand Bank, a frigate under English colors, which inquired particularly after the Jamaica fleet, [Probably the Constitution.]
The privateer Orlando, Babson has arrived at Gloucester, having four prizes, two of them however, it is expected have been retaken. The prizes secured are a small lumber sloop and schooner, from St. Johns for Halifax, which she cut out of a convoy of 68 vessels.
Boston alone has lost in six weeks 130,000 dollars in privateering stock and more than 300 sailors. All the prizes made by these same privateers do not exceed 30,000 dollars.

RUSSIA AND FRANCE.

At the date of the last accounts from the North, the Emperor Alexander and the Emperor Napoleon were at a distance only of 150 miles from each other, both accompanied by numerous and powerful armies; the former contending for existence and independence, the latter for the gratification of ambition and universal dominion.

**PORTLAND, AUGUST 24.
LATEST NEWS.**

The New-York Gazette of Wednesday last, gives an extract of a letter received by an arrival at New-London, dated Greenock, July 13th, which mentions that the news of this country's having issued letters of marque and reprisal against Great-Britain, had just been received at that place—and that France had declared war against Russia.

The ship Magdalin, arrived at New-York, with a cargo of dry goods valued at £400,000 sterling. She sailed from Liverpool, July the 6th; at that date all the American ships had obtained protecting licenses; about 30 would be ready to sail before the account of the war would reach that place.

The English papers state that Louis Bonaparte, late King of Holland, died at Gratz, about the middle of June.

Letters from Memel mention that the French Cavalry had entered that place.

H. M. Ships Maidstone, Spartan and Idian, with a fleet of merchantmen, arrived on Tuesday last from New-Brunswick.—The Rosina, mast-ship, is one of the fleet, on board of her are Lieutenant-General HUNTER, his Lady, and Family.

Wednesday, arrived, the American brig Prudence, from Ireland, bound to New-York, prize to H. M. S. Morgiana.

Thursday H. M. Brig Laura, from Barbados, 13 days; and

Brig Union, Tulloch, from Liverpool, Great-Britain bound to Newfoundland—She was taken by the Dolphin, privateer, and re-taken by the Morgiana.

Saturday, ship Osborne, from Gibraltar, bound to New-Brunswick—She was captured by the Teazer, privateer, and re-captured by the Emulous; and American ship Union, from Liverpool, Great-Britain bound to Boston, prize to the Emulous.
