after a heavy shower of balls cut away the jib-sheets, when my vessel lost her way; about the same time the signal halyards was shot away again and the colours fell in the water, which gave the enemy fresh courage, who boarded me on the starboard bow; when I was obliged to surrender to their superior numbers. The sloop proved to be the INCREASE, of Bristol, who had been fitted out with 6 guns and 80 men to take the schooner Bream, which had burnt a number of coasters, and the Increase being a coaster made an excellent decoy as well as a good sailer. What is most wonderful to relate, is, that there is above 300 bails in our hull and spars, the sails and rigging of both vessels wonderfully cut to pieces, a number of balls through our hats and cloaths, yet there is not a man either killed or wounded on either side."

Yesterday arrived at this port the ship Sophia, Capt. Patterson, in the remarkable short passage of 38 days from Gottenburgh. This vessel was not boarded on her passage -neither did she bring any Newspapers. From Captain Yeardsley, one of the passengers we learn that the Crown Prince Bernadotte was in Stockholm, and was expect. ed in Gottenburgh, when the vessel sailed. The late accounts of his being in Pomerania, must therefore be incorrect.] Dantzic still held out, at least no account of its being taken had been received. The garrison consisted of 4000 men. About 50 sail of English Transports arrived at Gottenburgh the first of April, they were taking in Artillery, suposed for Dantzic or Copenhagen. An expedition was fitting out for Pomerania, as was supposeddestination not certainly known,

It is reported they also took another schooner-This picaroon we understand had a regular commission from the President of the United States.

We have the gratification of laying before our readers this day, news the most pleasing and satisfactory; from Quebec we have received papers to the 27th May, containing a General Order, announcing the destruc. tion of General Harrison's Army, by the British forces under the gallant General Proctor, and from Halifax we have received papers to the 9th inst. from which we have copied the highly interesting details of the American Frigate CHESAPEAKE, Capt. LAWRENCE, by His Majesty's Ship SHAN-NON, Capt. BROKE, after a short but severe action of only eleven minutes. We have also received Boston papers to the 1st. inst. but they contain nothing of importance.

Arrived, Wednesday the Privateer Dart, Capt. Harris, from a cruise of 17 daysbringing in with her the following prizes: Ship Cuba, Prize-master Ross, from New-York bound to Portland-laden with 1600 barrels of flour. Privateer built schooner Washington, Prize-master Owen, from Portland bound to Boston-laden with lumber. Friday, H. M. schooner Bream, Lieut. Hare, from a cruise-she has captured and brought in with her the American Privateer sloop Wasp, Irvin, of Salem, 2 guns and 33 men. Last week the privateer whaleboat Wea. zel, Daniel Snow, commander, mounting 1 gun, and manned with 8 men, from Castine, went into Beaver Harbour, where they plundered the unoffending inhabitants of that 10th June, 1813.

" I wish to inform you for the good of the public, that on the night of the 8th inst. there came to my house 12 or 15 men in a boat, and with a crow-bar broke open the door, and robbed me of 300 wt. of sugar, nearly a barrel of coffee, 200 wt. dryed meat, my wife and daughters clothes, two pair of boots, all my fishing lines, part of a barrel of molasses, part of a cask of nails, a large trunk filled with small articles, one piece of homespun flannel, one piece of wildbore, one piece of dowlas, one and a half gross cod hooks, several dozen padlocks several gross of buttons, two guns and four or five pounds of powder, with a number of other articles not mentioned.

"They then went to Capt. Young's house and robbed him of 10 barrels of sugar, 7 pieces of broad cloth, 6 pieces of cotton; and all his wife and childrens clothes-they also took Capt. Cross' boat, fishing lines, &c. -after loading Capt. Cross' boat and their own with the plunder, they departed, saying they were sorry they had not more boats to load."

Extract of a Letter from Kingston, Upper Canada, dated 7th May, 1813.

"The day before yesterday two companies of the King's Regiment arrived here from York, which were in the engagement at that place on the 28th of April. In York there were only 350 men; being two companies of the King's Regiment, one company of the Newfoundland Fencible Infantry and one company of the Glengary, with two 9-pounders, and three 18-pounders, without by the enemy with 13 sail of armed ships, amongst them were two frigates of the largest size, many brigs, &c. all mounting extremely heavy metal. The enemy landed 2500 men, who were kept in close action for five hours, chiefly by the grenadier company of the King's Regiment, but they being overpowered by numbers were obliged to retreat .- Capt. M'NEALE, of the grenadier company was unfortunately killed,-therewere about 70 men killed and wounded, 36 of the wounded was left in the Hospital at York. The two companies of the King's Regiment engaged at York with the enemy, were on their march for Fort George, and
