miles below, where they fought the day before, one man was killed, and another wounded slightly; it is said that two Indians were killed; the Rangers were greatly out-numbered and compelled to retreat.

On the 8th instant, Fort Madison was attacked; the enemy commenced by firing on a party going out to cut wood, one soldier was killed another mortally wounded, since dead, a brisk fire instantly took place from the garrison, which secured the safe retreat of the remainder of the party; the firing was kept up by the enemy on the garrisc; about an hour, when they retired.-They fired under cover of the ravine that leads to the river about an hundred paces from the fort. About one hundred Indians were seen, no doubt some retired under cover of the river bank; one Indian was seen killed, another badly wounded, but the extent of the injury received by them is not known; two days before the attack, a detachment ordered out by Gen. Howard, of upwards of forty men in an armed boat, under Lieutenant Shaw, arrived with the contractor's boat, carrying supplies for the garrison.

On the 10th inst. about 150 Missouri Rangers, discovered three Indian canoes, descending the Mississippi, immediately below Fort Madison, and fired on them, which was returned; the canoes steered off to an Island opposite; a warm fire was kept up until the canoes struck the Island, in these canoes there were it is believed between 20 and 30 Indians, and it is thought that not more than two or three escaped.

There was no injury received by the Rangers; it is not yet known to what nation these Indians belonged, but by some it is thought they are the same party that attacked Fort Madison on the 8th, who were descending to attack our frontier settlement. From the 4th inst. to the 10th inclusive our troops have had four contests with the enemy on our frontier, our loss is six killed and two wounded; and we have every reason to believe that they have lost between 20 and 30 killed: of the number of wounded no correct opinion can be formed. It is stated in the affair of the 10th that when the canoes struck the Island that a blue cloth was raised, which was taken for a flag, the Rangers ceased firing, the cloth was taken down and a gun fired at the Rangers by the Indian who raised it, and the firing commenced again on our side until the enemy disappeared.

Some of the Indians finding the climate of Michigan too warm, have removed to the Mississippi, where they have commenced the work of death; from the measures taken by government we entertain strong hopes that their attempts on our frontier

will be foiled.

GIMPORTANT.

KINGSTON, (JA.) JULY 22, 1813. The following communication from the Intendant General of Porto-Rico has been received by His Grace the Duke of Manchester, and by him transmitted to the Mayor, for the information of those concerned .-

Porto-Rico, March 17, 1813. Sin, -I have lately arrived as Intendant General to this Island with a Commission from the Spanish Government, acting in the name of our King Ferdinand the Seventh, and I think it one of my duties to give your Excellency a full testimony of my true res-

pect, and high consideration. Wishing to promote by every means the welfare of this Island, and shew the hearty friendship due by all Spaniards to our great and generous Ally, I am determined and empowered by my Government to grant the benefits of a free trade between this and the neighbouring British possessi-

ons, on the largest scale.

"Therefore I desire, with your Excellency's good pleasure, it be made notorious by the public papers, through your dependencies, that all English vessels and boats will be friendly admitted in every port and harbour of this island without obtaining as heretofore a licence in each case, and that all shackles are knocked off, both for the importation of British goods and the exportation of all Kinds of produce and merchandize, gold and silver money not excepted. The duties will be moderated. British sub. jects can enter hereinto, and perform all kinds of contracts with those of this Island, both faithfully fulfilled, under the loyalty of the Spanish honor, and the protection of Government; and all kind of freedom and assistance will be granted to their persons and interests.

"Expecting those sentiments and liberal behaviour will meet your Excellency's approbation, and that the same will be observed with Spanish subjects from this Island, trading in your ports, agreeably to the British Laws. I have the honor to be, &c. &c.

The British privateer Fly, Capt. Clements, has been captured by the U. States brig Enterprize, and carried into Portsmouth.

We understand that Boston papers to the 27th ult. have been received in town since our last-but in consequence of their having been carried over the Bay shortly after their arrival, we are disappointed in making any extracts from them.

We have been favored, since our last, with a Quebec Handbill of the 18th ult. containing the following pleasing information.

> ->>8--HEAD-QUARTERS,

KINGSTON, 14th AUGUST, 1813. By accounts from Sir James L. YEO, dated off York, at half past 1 P. M. on the 11th (Wednesday) the following particulars have been transmitted to His Excellency the Commander of the forces of the capture and loss of four of the enemy's armed schooners.

On Tuesday evening, 10th inst. Commodore CHAUNCEY got under way from his anchotage off the mouth of the Niagara River, and with a fine breeze from the eastward stood towards our fleet, which was becalmed off the Post at 12 Mile Creek.

At sunset a breeze coming off the land gave us the wind of the enemy, when our squadron stood for them, on which they immediately bore away from us under as much sail as their schooners could carry to keep up with their larger vessels. The enemy's Madison, Oneida and six schooners-two schooners being placed to windward for the purpose of raking the masts of our squadron as it should come up. - At eleven the squadron got within gun-shot of the schooners, when they opened a brisk fire, and from their going so fast, it was more than an hour before the Wolfe, our headmost ship could pass them-At this time the rest of the squadron was two or three miles astern of the

Wolfe, and on her coming up with the Ma. dison and Pike, they put before the wind and made sail, firing their stern chase guns. Sir James YEO finding it impossible to get the squadron up with the enemy, as the Wolfe was the only Ship which could keep up with them, made sail between them and the two schooners to windward, which he captured, and which proved to be the Julia and Growler, each mounting one long 32, and one long 12-pounder, with a complement of forty men. Two of the enemy's largest schooners the Scourge of 10 guus, and the Hamilton of 9 guns upset on the 9th in carrying sail to keep from our squadron, and all on board perished, in numbers about 100. By this loss and the capture of the two schooners, the enemy's squadron has been reduced to ten vessels and ours increased to eight. It is ascertained that the Pike mounts 28 long 24-pounders and 420 men, and the Madison 22 32.pound carronades and 340 men. Nine boat loads of troops were taken on board of the enemy's squadron, on Monday the 9th, for the purpose of repelling boarders.

Extract of a letter from a gentleman in Fredericton, to his friend in this City.

"From a correspondent at Quebec, under date of the 21st ult. I have been informed, that the American fleet was cooped up in the River Niagara by our fleet, and that Sir George Prevost had left Kingston with 1500 regulars for Fort George, with the determination to assault that place, and by one decisive blow complete the entire discomfiture of the enemy."
