BLOCKADING SQUADRONS.

Of the Chesapeake. The accounts are numerous of the progress made by this squadron in carrying the war into the vicinity of the place where it was so improvidently and wickedly declared. At the last dates it was within 60 or 70 miles of Washington: The object had not been developed, unless it were to create alarm, bustle and expense; and in all these it appeared to be ably seconded by the exaggerated accounts of the alarmists. Many thousands of the militia were in arms; but there has not been any serious fighting.

Of the Delaware. The late accounts make no mention of this squadron. Of New-York. A small force continu-

ed off the Hook.

Of New-London. The small force in the Sound was off New-London, at last dates; after having passed down Sound as far as Faulkner's island, and having captured the sloops President, and Polly, Justin, from New-York for Providence, laden with flour. Its boats have been repulsed in two attempts to destroy a new vessel in Killingsworth, Chesapeake Squadron.

NORFOLK, JULY 9 .- Since the evacuation of Hampton, the enemy has been gradu. ally disappearing from our waters. The shipping up James River have all come down at different times within a few days past, and many of them have gone to sea.

The recent movements of the enemy have induced a general belief, that he intends to withdraw the principal part of his force from this place, (leaving a sufficiency to maintain the blockade) for the purpose of making an attack at some other point.

Two deserters who came into Hampton within a day or two, inform that all the enemy's troops, and the greater part of their shipping, would depart from hence with all possible speed for New London, which place they intended to attack, with a view of getting at the United States and Macedonian frigates.

July 10 .- The enemy has remained quiet in Hampton Roads, since our last, with out having made, as far as we can learn, the smallest movement.

Blockading of New London. We noticed in our last the official particulars of the dismissal of the militia of Connecticut from the garrison near New-London, by an act of the general government. To the mandates of this act, Gov. Smith has promptly and implicitly obeyed, and the militia are disbanded, and gone home, leaving the city and the frigates at the mercy of such an enemy's force, as may think itself com-

petent to possess either. At the last date, it was stated, that the fleet were landing horses on Block. Island, and that in any attack, on New London, Artillery and cavalry would be employed-That a flag had been sent in from the Ramilies, and there now being no guard at the mouth of the Harbor, the flag was brought to near Fort Trumbull, by Capt. Vandevison.

HALIFAX, JULY 26. Arrived, Monday, H. M. Brig Nimrod, Capt. Mitchell, from a cruise, with the American Privateer Ship York-Town, Capt. Ricker, prize to H. M. Ships Poictiers, Maidstone, and Nimrod brig; also, H. M. Packet Manchester, Captain Elphinstone, from Falmouth, 34 days; and Ship Louisa, from Newfoundland, 11 days, bound to Greenock-The two latter had been captured by the York-Town, and were on the 18th inst. re-captured by the above Ships of War, near Cape Sable.

The York-Town mounts 20 long twelvepounders, and had, at the time of capturing the Manchester, 116 men on board. The Packet engaged her for some time, but was at last obliged to surrender; she, however, did considerable damage to the privateerdisabled her mainmast, injured her rigging, and one of her shots entered the privateer between wind and water, which circumstances obliged the privateer to give up her cruise and return to port-The injury sustained by the Packet, was also great; her rigging and sails were much cut up, and 3 of her crew severely wounded. She had the June Mail for this place, which was sunk. Capt. Elphinstone and his passengers (Capt. Sabine of the Royal Artillery, and Mr. Bell, of New-Brunswick) speak very highly of the conduct of Capt. Ricker towards them subsequent to the capture of the Packetit was every thing that was handsome.

Wednesday, a small American schooner, with flour and bread, sent in by La Hogue, Thursday, H. M. S. Statira, Capt. Stackpole; schooner Marion-Scotland, Price, 14

days from Antigua. Friday, H. M. Brig L'Epervier, with the Trade from St. Thomas-sailed July 3, with near 300 sail for England, &c. under convoy of H. M. S. Cressy, 74, having Admiral Sir A. Cochrane and family on board. H. M. schooner Pictou, Lieut. Stephens,

with brig Isabella from Algesiras for Bos, ton, under Spanish colors-cargo, wire and silks-sailed June 4. The Pictou has recaptured sloop Ringdove from hence for Newfoundland, taken by American privateer Polly.

Yesterday, H. M. brig Borer, from a cruise to the eastward; ship Martha-Brae, Gibson, from Cork, 43 days; brig Æolus, from St. John, N. F. 9 days, and a ship under Swedish colors, from New-York, bound to a southern port of the United States, detained by H. M. S. Statira.

Sailed, Thursday, H. M. S. Acasta and Nimrod brig, on a cruise; and Emulous, brig, from the Beach, with a convoy to the Westward,

The Martha Brae sailed from Cork the 7th June, under Convoy of His Majesty's Ship Majestic, Rear Admiral Griffith, Capt. Skipsey, and five other Ships of War, with about 100 Sail of Merchantmen, bound to Newfoundland, Quebec, Nova-Scotia, and New-Brunswick-parted company on the 10th July, in thick weather.

In our last we gave the official Details of a very severe action fought between the Allies and French on the 2d of May, Lutzen, with the subsequent operations of the contending Armies down to the 16thand from London Papers to the 12th June, received by the Manchester Packet, which arrived here on Monday Evening last, we have extracted the particulars of an equally severe action which took place near Baut. zen on the 21st May, in which the Allies were unsuccessful, being overpowered by numbers, and obliged to retreat-on the 29th May the advanced guard of the French Army was within seven leagues of Breslaw -and the Allies were retiring towards Schweidnitz.

A Letter from St. John's N. F. of the 14th inst. received yesterday by the Æolus, says:

"We have here London News to the 16th ult,-Bonaparte had concluded an armistice for six weeks, with the Allies, and the terms as to demarcation seem such anxious for spell as the French. If so there is every fear that Bonaparte will in the end of the campaign be victorious."

Another Letter states that the armistice was concluded the 6th June.
