DECATOR, in the United States, with the - Macedonian and Hornet were yesterday chased into that harbor by a British 74 and frigate-that they had come to anchor off Market-wharf, and that the British were at anchor off the Light House. Ere the U. States made the harbor the British frigate fired at her, which was returned by the U. States. It is understood to be Commodore Decatur's intention to land upon Groton iside many of his guns (which are at present useless, the ships being already stretched along to that shore) to be manned by the mititia-thus situated he is determined, in conjunction with the forts to repel the approach of the enemy, which no doubt he will have an opportunity of endeavoring to do, as soon as the British are reinforced from the Hook, if not before. The citizens of New-London are in terrible consternation. Gen. Williams of N. L. ordered out two regiments which were yesterday collecting. Our Governor sent this morning from this place, an additional quantity of munitions of war.

New. Sondon is situated on the river

of the King's and Major Drummond of the 104th regt.

Commodore Sir James Yeo, conducted the brigades of Boats to the attack, and accompanying the troops on their advance directed the co-operation of the gun-boats. The enemy had a few days before received strong reinforcements of troops by the report of the prisoners and a corps of 500 men, arrived the night preceding the at. tack; and from every source of information his force must have been quadruple in numbers to the detachments taken from the gar. rison of Kingston.

Captain Gray, Deputy Quarter Master General, was killed close to the enemy's Block House. In him the Army have lost an active and intelligent Officer. Returns of killed and wounded have not yet been received from the corps:

We hope to morrow to see the picaroon in this port, as a Brig of War sailed this day, and most probably will get sight of her before evening.

His Excellency the Commander of the Forces considers it an act of justice due to the detachment placed under the command of Colonel Baynes, to express his entire approbation of their conduct in the recent attack made upon Sacket's Harbour, at day break on the morning of the 29th instant; the regularity and patient firmness exhibited by the troops under circumstances of peculiar privation and fatigue, have been exceeded only by their intrepid gallantry in action, forcing a passage at the point of the bayonet through a thickly wooded country, afforded strong positions to the enemy, but not offering a single spot of cleared ground favorable for the operations of disciplined troops. The woods were filled with infantry, supported by field pieces, and an incessant heavy and destructive fire from a numerous and almost invisible foe, did not arrest the determined advance of the troops; who, after taking three field pieces, 6 pounders, from the enemy, drove him by a spirited charge to seek shelter, within the Block Houses of his enclosed Forts, and induced him to set fire to his Store Houses .-Unfortunately light and adverse winds prevented the co-operation of the larger vessels of the fleet; the gun.boats, under the direc. tion of Captain Mulcaster, rendered every assistance in their power, to support the landing and advance of the troops, but proved unequal to silence the guns of the enemy's batteries or have any effect on their Block-house, and it being found impracticable without their assistance and the cooperation of the ships, to carry their post by assault; the troops were reluctantly ordered to leave a beaten enemy, whom they had driven before them for upwards of three hours, and who did not venture to offer the slightest opposition to the re-embarkation of the troops, which was effected with perfect order. The Grenadier Company of the 100th Regiment, commanded by Captain Burke, to which was attached a Subaltern's detachment of the Royal Scots, led the column with undaunted gallantry, supported by a detachment of the King's, under Major Evans, which nobly upheld the high established character of that distinguished corps; the detachment of the 104th Regiment, under Major Moodie, behaved with the utmost gallantry and spirit, and their example was followed by Captain M'Pherson's company of Glengary Light-Infantry. The detachment of Canadian Voltigeurs under Major Herriott, behaved with a degree of spirit. and steadiness so as to justify expectations of their becoming a highly useful and valua. ble corps.

JUNE 4. FROM THE MONTREAL GAZETTE EXTRAORDINARY, JUNE 2.

Extract of a letter from a respectable Gen. tleman in Kingston, to his friend in Montreal, dated

KINGSTON, MAY 30, 1813. Ti Sta

"I have this moment, received the intelligence of the fall of Fort George, which was attacked by Ten Thousand men, and ultimately carried, but with the dreadful loss of Four Thousand of their army.

"General Vincent made a noble defence and effected a safe retreat with a small loss, after five or six hours hard fighting, to his depots about two miles in the rear of Fort George, where he made a stand to collect. his forces from above, and his hopes of driv. ing the enemy from the place."

By letters which we have seen, we learn that no more than 750 men of the British troops were engaged in the attack on Sacket's Harbour, of whom 150 were killed or wounded. Captain Gray, of the Quarter Master Generals Department, Capt. Blackmore and Ensign Gregg of the King's, were killed. Major Evans, Capt. Tyeth and Lieut. Nutall, of the same regt. Majors Drummond and Moodie, and Cap's. Shore and Leonard, of the 104th and Captain M'Pherson of the Glengary regiment were among the wounded.

Extract of a private letter, dated Montreal, June 2.

"Accounts are received that we have evacuated Fort George, and concentrated our whole force at Queeuston on the strong heights. This is not official, but I believe its correctness. Gen. Vincent seems to have withdrawn on the arrival of Dearborn's second expedition of about 2500, and menaced with 3 or 4000 from Lewis. ton, &c."

Five o'clock, P. M .- The Light House has just reported the Privateer to be the Teazer.

Lt. Ludlow, late 1st of the Chesapeake, died yesterday, at Ilis Majesty's Naval Hospital, of his wounds.
