If this separation in fact takes place, it will be the work of the present Gabinet-Such a separation alone is matter of substance. - The rest would be matter of form. We pray that neither may happen, but that Government may discern and realize in season the terrible reaction of public opinion among a free people, who find themselves betrayed and deceived by those who have been entrusted with their public concerns.

FROM WASHINGTON.

JANUARY 4, 1813 .- There are rumors still current here of pacific overtures to England. All I believe on the subject is, that some attempts will be made, or pretended to be made, at negociation, but more with a view of doing something to throw that blame if possible on her, and so make our war popular, and bring back the Clintonians to the war ranks, than with any sincere intention to make peace."

"JAN. 5 .- After keeping the bill to the very verge of the Constitutional limits, the President has signed the Law for augmenting our glorious Navy .- The American People cannot mistake the true cause of this hesitancy. He has also signed the bill for the rescue of our merchants from inevitable ruin.

"Another day has been consumed on the bill for

raising Twelve month levies.

"The large offices remain vacant:-It is now reported, that Mr. Jones, of Philadelphia, has been nominated to the Navy one.

JAN. 6 .- There has been much rattling among the dry bones of the friends of office-holders, jobbers, contractors, spies, and other consumers of the People's money, on account of a motion of Mr. RANDOLPH calling for the long roll of men in the pay of the public; but tranquillity has been restored by the rejection of the motion.

"The bill for raising 20,000 Yearling troops, and getting rid of a bounty of 16 dollars to each, still labors before the House."

HALIFAX, JANUARY 22.

The Maidstone has captured the American ship Violante, with a valuable cargo from Bordeaux; and the Pofctiers has taken the American brig Herald, with a rich cargo, from the same place. The Herald, had a French General, passenger, said to have been put on board by the Police at Bordeaux.

Several American privateers have been fitted from different ports in the Bay of Biscay; and one of them of 14 guns, was lately sent into Plymouth.

H. M. sloop Lightning has captured an American vessel from the coast of Africa, with gold dust, ivory, camwood, &c. to a considerable amount.

On the 6th inst. H. M. S. Poictiers was fallen in with off New-York, 30 leagues from the Hook.

The Minerva frigate with several vessels under her convoy for Bermuda, sailed from Portsmouth, England, November 9.

And whereas a suitable Form of Prayer has been composed by the Right Reverend and Honorable Bishop of Nova-Scotia, I do hereby authorise and appoint the same to be usedy on this solemn occasion, in all Churches, Chapels, and places of Public Worship

EASTERN FRONTIER OF THE UNITED STATES, Head Quarters at Eastport, January 7, 1813.

I am instructed by the General Commanding the eastern district to endeavour to stop all communications between the Subjects of the United States, and the Subjects of His Britannic Majesty; I therefore hereby notify to you that all persons coming to this Frontier from His Britannic Majesty's Provinces or Shipping, except by permission of the Commanding Officer of this Frontier, will be treated as Spies, or will be made Prisoners of War. While I strictly comply with my instructions, I am disposed to accommodate Persons of every description who may come in a legally authorised Flag of Truce, with a proper Officer, and on business of necessity in this Frontier, provided they strictly conform to the regulations adopted for these purposes. Flags of Truce will be received at LITTLE's Wharf, in Eastport. No person will be permitted to leave the wharf, or have communication with the inhabitants, without permission from the Commanding Officer of the Post. Packets and Letters will be inspected by an Officer before they are delivered to the persons to whom they are directed. This Letter will be handed to you by Lieutenant MACLAY of the United States Artillery, who will receive any proper communication you may think necessary to make.

POSTSCRIPT.

SAINT JOHN, FEBRUARY 8, 1813.

By an Express from Fredericton, arrived this morning, we have received Quebec papers to the 14th ult. in them we find the Americans are again assembling in force, on the horders of Lower Canada, with a view, no doubt, of making another vain attempt to conquer that Province.

QUEBEC, JANUARY 7.

On reading the extracts from the late American pas pers, and recollecting the events of the war, people will naturally conclude, that there is no longer any danger to be apprehended from the United States. It is a great fault to be too hasty in one's conclusions .--We ought to recollect that every thing which reaches us from that country, is tinged with the spirit of party; a spirit of falshood. The evils which now afflict the United States, those with which they are menaced, are however the natural fruits of an unnecessary war; a war repugnant to the interests and habits of nearly the whole community, and odious to the judgment and feelings of a great proportion of the intelligent men throughout the country. But whatever may be the extent of the divisions, misconduct, discontent, insubordination and misery, prevailing in the armed force of the U. States, while the men who have plunged that country into the war still, wield its resources, we are far from being exempt from danger; though it may be at a greater distauce than was at first imagined. It may be said, upon the whole, that, with a view to the final conquest of the Canadas, the Americans are the gainers by the experience of the campaign. It must have proved to the satisfaction of every body, that success cannot be obtained, nor the character of the country supported, without a regularly organised army; and with those who are for continuing the war, there can now be no longer any opposition to the sacrifices which are necessary to obtain such an army.

We have been in doubts whether we ought to suffer Gen. Smyth to give up his "visit to the tomb of Monta gomery," without one passing remark. Poor General. Smyth! he has indeed "strutted his hour upon the stage;" he has made his entry and his exit; his speech has been "full of sound and fury." When he dies, there ought to be engraved on his tomb, these words of his despatch: "I must not be defeated."
