NEW-YORK, SEPTEMBER 24. FROM FRANCE.

Yesterday arrived the schooner Grampus, in 28 days from Bayonne, France.

The armistice continued-negotiations were pending-but great military preparations were making on both sides.

Lord Wellington's army was within 6 leagues of Bayonne.

British troops were still besieging St. Sebastians.

A great battle was fought between Lord Wellington's and Soult's armies, on the 6th August, at the foot of the Pyrennees on the French side, and was visible from Bayon A letter from the latter place says "it proved very fatal to the French, whose loss is estimated at 15,000." Both armies afterwards to August 24, continued encamped in the vicinity of Bayonne. Soult occupied very strong positions, but it was thought possible he might be driven into Bayonne, which place was considered safe. The British held Passage. Bayonne was full of wounded soldiers.

The anniversary of "Saint Napoleon" was celebrated at Paris August 14.

Pampeluna continues besieged by a Snanish force under O'Donnell. The British loss was great in the attempt.

BOSTON, SEPTEMBER 28. Commodore Rodgers Arrived. FROM OUR CORRESPONDENT.

Office of the Newport Mercury, Sunday Evening, Sept 26th, 1813. J. This morning arrived in this harbor the U. S. frigate President, Commodore Rolgers, from a cruise of 5 months. We have been favored with the following account of her cruize:

May 8th, lat. 39, 13, long. 59, separated from the Congress.

9th June, lat. 42, 19, long. 32, 27, captured, the brig Kitty, from Newfoundland for Alicant, with a cargo of fish, ordered her for France.—(retaken.)

10th June, captured the British Packet Duke of Montrose, from Falmouth to Hallfax.

11th June, captured the British brig Maria letter-of-marque, from Newfoundland, bound to Spain with a cargo of fish; ordered her for France, and despatched the Duke of Montrose to England as a cartel, with the crews of the captured vessels on parole, being 78 in number.

June 12th, captured the British sch. Falcon, from Newfoundland, bound to Spain, with a cargo fish; ordered her for France. June 27, Arrived at Bergen, in Norway,

the distressed situation of which prevented our getting any supplies, except water, and sailed from thence 2d July.

July 13, captured, off North Cape, White Sea, British brig Jane & Ann, from N. Shields, for Archangel, in ballast and and destroyed her.

July 18, captured British brig Daphne, from Cork bound to Archangel, in ballast, and destroyed her.

July 19, was chased from our cruising ground, off N. Cape, by a line of battle ship and a frigate. From the lightness of the wind, and several shiftings of it in their favor, the chase was prolonged to 86 hours.

July 24, captured British whale ship Elisha Swan, returning from Greenland, with a cargo of fish and blubber-ransomed her, and put on board the crews of the captured vessels, which, together with her own crew, were permitted to proceed to England on parole, being 76 in number.

the British brig Alert, from Archangel bound to England, with a cargo of pitch and tar, and destroyed her.

Aug. 2, between the Ferro Islands and the coast of Ireland, captured the British barque Lyon, returning from a whaling voyage, with a cargo of fish and blubber; ransomed her, and sent the crew of the Alert, together with her own, being 62, to England on parole.

Aug. 30, lat. 47, 17, long. 46, 42, cap. tured the hermophrodite brig Shannon, from Antigua for London, with a cargo of rum and sugar-ordered her to the first American port.

Sept. 9, lat. 43, lon. 50, 26, captured brig Fly, from Jamaica to London, with a cargo of coffee, ordered her for the first American

Sept. 23, off Nantucket shoals, captured

H. B. M. schooner Highflyer, formerly of Baltimore, commanded by Lt. Hutchiuson 5 guns and 39 men; ordered her in.

The President was bound to Boston, but on obtaining information by the Highflyer that the Majestic and a frigate were in Bos. ton Bay, Com, R. then stood for this port.

Com. Rodgers obtained information of the loss of the American signals, from vessels which he spoke in the North Sea, which took him for an Englishman.

The President has kept the sea, until her provisions were nearly exhausted. She has seen no enemy's cruisers, except the squadron and schooner mentioned above. The crew of the President are all in good health.

The President and her prize the Highflyer proceeded this evening, up Providence river. Com. Rodgers has sent 216 prisoners to England on parole, and has my on board 54, including 5 officers.

Also arrived this afternoon, the Highflye Schooner, of 5 guns, Lieut. Hutchinson, tender to Admiral Warren, prize to the frigate President. Lieut. Hutchinson, supposing the President to be a British frigate, came on board, and informed Commodore Rodgers, that he was looking for the President, and as soon as he should obtain information of her, he should inform the commanders of the squadrons in the Sound, and in Boston Bay. He gave to Com. R. the private signals of the British Navy, and Admiral Warren's instructions.

The report that Com. Rodgers had taken the gun-brig Cruizer was incorrect. The Commodore in the N. Sea, was informed of the capture of the Chesapeake, with the American private signals. The Congress parted 5 days after sailing, and had not been met afterwards.

Com. R. had not sent ashore at Scotland. If he could have procured provisions he would have prolonged his cruise. The frigate has a quantity of dry goods on board.

Sept. 22, the frigate President parted from two of her prizes, an hermophrodite brig and a sch. loaded with rum, sugar, &c. Sept. 23, boarded a Swedish brig from Bermuda, (where she had been carried in and cleared) bound to Boston or Bath.

Movement of the Northern Army. We learn by a gentleman who arrived this town on Sunday afternoon, direct from Cumberland Head, which place he left on Tuesday last, (Sept. 21,) that Gen. Hampton, with the Northern Army, commenced his march from Cumberland Head, on Monday, and encamped the same evening at Odleton, 7 miles within the British lines; and about 40 miles from Montreal. 500 of the N. York Militia, then at Plattsburg, volunteered to cross the lines with Gen. Hampton.

RUTLAND, SEPT. 22. Col. Clark, we understand, has received orders from Gen. Hampton, to raise 1000 mounted volunteers, to be reported at Cumberland Head on the 24th inst. This looks like a speedy preparation for a comme ment of hostilities.

FROM NEW-YORK.

Left at Bordeaux, schooner Charlotte, of Charleston. At La Test, schooner Inca, of Baltin more. At Rochelle, ship Erie, and brig George of N. York. At Nantz, ships Galway, and Fanny, and schooners William & Volunteer, of do. schooner Chesapeake and Brutus, of Baltimore; brig Argus of Newburyport, to sail in a few days. The schooner Ellen and Emeline, and Marmion sailed a few days before for the U. States. July 29, off the Ferro Islands, captured The pilot boat Brothers from N. York, had not been heard of.

Capt. Stafford brings despatches from Mr. Warden for our government—The French Rochfort squadron, consisting of six 74's and ten frigates, were provisioned and neurly ready to sail. It was reported at Bordeaux when Capt. S. left there, that hostilities had commenced between the French and Russian armies. Austria is said to have

joined Frence. Sept. 3, in latitude 39, 40, longitude 36, 35, the Pilot, Capt. Stafford captured the the schooner Lilly, from Port-au-Prince, for London-took out a quantity of sugar, stores, &c. and let her proceed. Sept. 19, lat. 37, 26, long. 69, captured brig Mary. Ann, from St. Lucia for St Johns, N. B. with a cargo of 108 puncheous rum, and 147 hhds. of sugar; after having her in tow a few days, ransomed her for 4000 dls.
