Extract of an official Letter from Field Marshal the Duke of Vittoria, addressed to his Excellency Don Miguel Pereira Forjaz, dated Head-Quarters, Zubietu, 10th July, 1813.

" Since the Despatch I addressed to your Excellency on the 3d inst. Gen. Mina has informed me, that Gen. Clauzel had march. ed from Saragossa towards Jaca, but I have not yet heard of his arrival at that place.

The enemy's right has remained almost in the same position, which it took after passing the Bidassoa. The bridge of Irun has been destroyed by the Enemy. There is no doubt but that the Enemy have completely withdrawn their right and left wings to within the frontiers of France, although their centre still remains in force in the Valley of Bastan, in which on account of the strong positions it affords, and the richness of the Country, it appears they are determined to make a stand; for this purpose three divisions of the South have re-united there under the orders of Gen. Gazen.

Lt. Gen. Sir R. Hill, has followed up the Blockade of Pampelona; and also, continued to dislodge the Enemy from all his positions on the 4th 5th and 7th inst. with two Brigades of British Infantry, and one of Portuguese commanded by Lieut. Gen, the Hon. W. Stewart, and another Portuguese Division under the command of the Conde d'Amaranthe, the whole under the directions of the same Nobleman.

The last post that the Enemy occupied in the Porto de Maya, situate in a village of the same name, and Urdaz, was uncommonly strong; and the fog that came on in the afternoon was so thick that it was not possible for the Troops to advance one step from the place in which they were when it came on.

However, at last, the Enemy found themselves so vigorously pressed in this position that they were under the necessity of abandoning it, and retiring to within the frontiers of France.

In all these different actions the Troops conducted themselves remarkably well, and Lt. Gen. Sir R. Hill declared himself perfectly satisfied with the conduct of Gen. Stewart, and the Conde d'Amaranthe.

Since my last official despatch to your Excellency, I have received a letter from Lt. Gen. Lord Bentick, dated the 30th June last, and from information through other channels, I learn that the Duke del Parque retired from Xucar upon the 25th, without any loss, and has lately occupied the position of Castalla.

JULY 24. By this day's post we have received intelligence from Madrid, that Suchet was on his march to Catalonia through Tarragona, and that Clausel with 12,000 men was endeavoring to form a junction with him.

JULY 30. Latest News from the Allied Army. Lesaca, 19th July .- The Head Quarters are still in this village. The loss which the French army suffered in the battle of the 21st June, in money, baggage, horses mules, and various other things, has been calculated at 20,000,000 cruzades. The siege of St. Sebastians is carried on by the 5th English division of the army; Gen. Porlier and the partizan Pastor, have joined

the besiegers.

We have yet three fortresses to take in order to be masters of the North of Spain, viz. Santona, Pampelona and St. Sebastians. The siege against the latter place, is in the most forward state. On the 17th the Portuguese brigade of Gen. Bradford was ordered to attack the outer convent, which had been battered in breach, and where the batteries against the town were to be established; this brigade was supported by an English brigade; the convent was taken, and the French lost in this affair, 100 killed and 400 prisoners.

It is said, that Marshal Soult arrived at Bayonne on the 15th instant; if this be true, he must have come individually.

As soon as Lord Wellington removed his head-quarters to Lesaca, he forced the enemy to retreat from Vera, clearing these frontiers entirely of the French.

The head-quarters remained in Lesaca

on 21st July. Some letters mention that Soult had not arrived at Bayonne, but that he had issued on the 18th a proclamation to the army, which now may be called the army of the Gironde. In that proclamation they say, he vomits forth all the gall which he has been collecting since he left Seville.

The intelligence of evacuation of Valencia on the 5th inst, and of Sarragosa on the 9th, is confirmed by the arrival of the Post this day from Madrid.

It is evident from Lord Wellington's General Order, which we have inserted, that a part of his triumphant army has entered France-but at the same time we find from the removal of Head-Quarters to Hernani, near St. Sebastians, that his Lordship is determined not to leave that important fortress behind him, in possession of the Enemy; and is, therefore carrying on his operations against it with the utmost vigor, and would probably reduce it in a short time.

ToLOSA, JULY 12. A General Order of Lord Wellington's prohibits, in the strongest manner, any insult being offered, by the troops under his command, to the inoffensive inhabitants of France-since its publication, the people of Raya have readily furnished provisious to the troops which have entered France,-King Joseph arrived at St. Jean de Luz with 17,000 Infantry, and 3000 Cavalry, and threw bridges over the Bidassoa.

His Majesty's schr. Bramble sailed from the Chesapeake the 6th September, with Despatches for England.

Capt. PATTERSON, of H. M. S. Fox died on his passage, from Chesapeake Bay-His May, the 18th of October next, at 12 Corpse was brought in here, and at 12 o'clock on Wednesday, in erred with all the honors due to his rank.
