But here is the Treaty amazement! What? not a word about " free trade and sailor's rights!" Nota syllable about impressment! Not a word about the immunities of our flag ! No security against man-stealing ! Our complaints, said our Negociators, are essentially of a maritime nature; and have they stifled these complaints? Is the war at an end and the Canadas not ceded?

What, then, have we obtained? Why Peace. - Mr. Madison says to Great. Britain, give me but Peace and let me be off; grant me but this one request; stop the War; and let me get out of the hobble in which I foolishly involved myself .- Napoleon, on whom I depended, is gone; I have rained the national credit, give me but peace and not a word shall be said about the causes for which I declared war.

We do not question the policy of the ratification of this treaty-far from it. We cordially rejoice, and we are now confident that our present bright prospect is the inevitable consequence of the fall of Buona. parte; but for that we should have been forced still to continue the contest in support of his " liberty of the seas," of the principle that "a merchant vessel is a floating colony, not liable to search, and that places not fortified, harbors and mouths of rivers are not liable to blockade,"

With this denouement before our eyes, will not those who have questioned the justice of the war, will not those who have been ruined by it, those who have sustained its burdens, and who will probably, during their lives, be subjected to heavy taxes in consequence of it, now confess that it has terned out politic - very politic, and that federal predictions relative to the issue have been completely satisfied? OBSERVER.

STATE OF THE MARKETS.

NEW-YORK, PEB. 27, 1815 .- Never since the declaration of war, has there been such a stagnation of business, for during that time there was always speculators, who kept the market in constant agitation; but since the conclusion of peace (except a few ales immediately after its receipt) nothing of importance has been done; the probability is, we shall receive our first importations in foreign ships, and the uncertain state of foreign markets, is, no doubt, the reason of the present dulness of ours.

BALTIMORE, FEB. 24. - The changes which have taken place both in the increase and decrease of the prices of various articles in consequence of the peace, are not to be accounted for on any correct principles of mercantile reasoning. Many of the holders of foreign merchandize in their alarm have sold or rather sacrificed their goods at anction for a less price than they would cost the importer from the known prices in Europe. Flannels, calicos, and some kinds of muslins have been sold at less than half the prices obtained for them during the war.

Some articles of domestic manufacture are also depressed in price, more than circumstances would reasonably require, while some articles of produce have experienced an increase of price, which, although not so great in proportion, may not be fully justified, when the markets are more settled.

Our port is at present, as completely blockaded by the ice, as it was formerly by the British squadron; and the present weather will probably continue that obstruction some days longer than the time limited in the treaty of peace for captures to cease on our coast. This will afford time to the pred at merchant to consider and prepare for the most beneficial use of commercial liberty.

BOSTON, Febuary 25.

Captain Maude, of the British sloop of war Favorite, (which brought out the Peace Treaty) arrived at New-York on Wednesday last from Washington, and proceeded to the Hook ; -and was to depart for England, with the Ratified Treaty, the first favorable wind.

Commodore Decatur, Lt. Shubrick, Mr. (Champlain) Robertson, all late of the U. 8. frigate President, were landed at New-London, on Wednesday last from the Narcissus and Pactolus frigates, 14 days from Bermuda.

The Ratified Treaty of Peace has been communicated to Admiral Hotham, off New-Loudon-and the officers of the squadron have been invited by the citizens of New-London to the Peace Ball to be given in that city.

The news of Peace had reached Admiral Cockburn, at Amelia Island, 5th inst. The news of Peace reached Montreal on

the 14th instant, by, express in 61 hours from New York.

Just before the news of Peace reached the Niagara frontier, the British were said to have put a regiment of troops into the fort they hold on our side; and Gen. Drummond and Admiral Yeo had arrived in that vicinity.

FEBRUARY 28. FROM OUR CORRESPONDENT. Portsmouth, 26th Feb. 1814.

Last evening, arrived at this port, the privateer Champlain, Capt. Henry Salter, from a cruise of about 5 weeks, having sprung both of his masts. On the 18th inst. he captured a brig from St. John's, bound to the W. Indies, and on the 21st inst. another brig, from the same place, both laden with fish, lumber, oil, &c. for the W. Indies, which he has manned and ordered in. He has experienced one continued gale ever since he sailed, and never heard of the Peace 'till he arrived along side of the wharf. 17 prisoners brought in."

LONDON, DEC. 28. Foreign Politicians observe that at the Congress of Vienna, there is ingress, egress, and regress, but no progress.

On Monday soon after the Earl of Liverpool had laid the despatches from Ghent before the Prince Regent, and had taken his Royal Highness's commands upon them, Mr. Walsh, the King's Messenger, was sent off with all speed to Ghent.

Lord Castlereagh, we understand, will return to this country in time to meet the reassembling of Parliament, after the Christmas holy days, whatever may be the state of the Congress of Vienna, leaving the Earl of Clancarty as his Deputy.

We have authority to state that, notwithstanding the conclusion of Peace with America, Lieutenant General Sir George Prevost will demand a Court-Martial on his conduct, immediately on his arrival in England, in consequence of the charge preferred against him by Com. Sir J. Yeo, in his official letter to the Board of Admiralty, as published in The London Gazette.

Among other recent arrivals here, is that of Count Fontanelli, from Milan. He was an Italian General of Division and Minister at War under Bonaparte.

It is affirmed, that the Russian corps which are on their march for the borders of Turkey, and which will be under the orders of Gen. Bennigsen, will form an army of 120,000 men.

LONDON January 12. The accounts from Spain are to the 24th ult .- Every thing goes on there with the same consummate stupidity as ever-arrests continue daily.

It is reported, that, in the event of the ratification of the Treaty with America, Sir George Prevost will, agreeably to his own desire, be relieved from his command in the Spring .- Courier.

The Forth, Simpson, from Halifax to the Clyde, has been taken and burnt by an American privateer, within 30 miles of Halifax.

PLYMOUTH, Jan. 11. Put in here, dismasted, the Brothers, Nutter, from Halifax, bound to Newfoundland.

FALMOUTH, Jan. 12. Sailed the Lady Wellington Packet, for Halifax.

HUGH STEWART, Esq. of the Secretary of State's Department, charged with Dispatches to His Excellency Sir John Coape Sher-BROOKE, K. B. arrived in the Tamar.

HALIFAX, March 6. PROCLAMATION. By His Excellency Lieut. Gen. Sir John COAPE SHERBROOKE, Knight of the Most Honorable Order of the Bath, Lieut. Governor, and Commander in Chief, in and over His Majesty's Province of Nova. Scotia, and its Dependencies, Vice-Admiral of the same, &c. &c. &c.

John Coape Sherbrooke. WHEREAS by two Acts, the one passed in the 28th, and the other in 48th year of His present Majesty's Reign, power is given to the Governor, Lieutenant-Governor, or Commander in Chief, with the advice and consent of His Majesty's Council, to allow the Importation of certain enumerated Articles from the United States of America into this Province, for the use of the Inhabitants,

and also for the Exportation thereof. I have therefore thought fit, with the advice and consent of His Majesty's Council, to publish this Proclamation, hereby authorizing and empowering British Subjects for the space of three months from the date hereof, to import and bring into this Pro-

vince, from the United States of America in British built Ships or Vessels, owned and navigated according to Law-Scantling, Planks, Staves, Heading, Boards, Shingles, Hoops, or Squared Timber of any sort; Herses, Neat Cattle, Sheep, Hogs, Poultry, or Live Stock of any sort; Bread, Biscuit, Flour, Peas, Beans, Potatoes, Wheat, Rice, Oats, Barley, or Grain of any sort; and British Subjects, during the same period are hereby authorized and empowered to Export in British Ships, owned and navigated as aforesaid, all, or any of the said herein before enumerated articles, to any other of His Majesty's Colonies or Plantations.

GIVEN under my Hand and Seal at Arms, at Halifax, this 4th day of March, 1815, in the 55th year of His Majesty's Reign.


