We feel it due to ourselves to notice a paragraph which has appeared in the National Intelligencer, stating, that having published an incorrect statement of the capture of the President, we had afterwards made an apology.

This assertion we take the earliest opportunity of contradicting; the publication alluded to in the Intelligencer, was issued under an erroneous impression, that the account we gave of the concealment of the men on board the President, was incorrect, and we hastened to recall an aspersion which we were induced to believe was unfounded. Subsequently we have ascertained, that the original statement was correct; and we do not hesitate unequivocally to declare, upon the best authority, that sixtyeight men were concealed on board the President, and from other information we have obtained, are convinced the act was authorized by Commodore Decatur.

In behalf of the Magistrates, Merchants, and many of the Inhabitants of St. George, we beg leave to address you - We have seen, Sir, the ship you command, and her prize, the United States' Frigate President, captured after an arduous chase and hard fought action of two hours and an half; and to have seen them in their present state, is to be convinced of the gallantry and good conduct of yourself and ship's company. It has proved too, what we never doubt-

ed, that an American frigate of the largest class, is no match for a British ship like the Endymion. 29 la vice se

This address is not meant to convey any extraordinary gratulation-You have done no more than we were prepared to expect, but indeed with much less loss than was to be apprehended; for we all know that the spirit of America emanates from the spirit

of England. Permit us to add, that your modesty after victory, and your delicate treatment of a conquered enemy, have been no less conspicuous than your valour.

Accept from us, as a proof of our esteem of your conduct during and after the action, piece of Plate-which, while it commemorates your victory, bears with it our desire of peace with America.

To the officers of the Endymion's Gun-Room, we beg, through you, to present a Goblet as a mark of our esteem for their gallantry on this occasion, and to be attached to any ship which may hereafter bear the gallant name of Endymion.
