LONDON, Nov. 7. A melancholy circumstance took place yesterday, about two o'clock, at a public house in Tottenham-court.road : as a man in perfect health was eating his dinner, a portion of food entered the wind-pipe, and he expired almost instantaneously. Surgical aid was immediately procured, Mr. R. C. Griffith opened the larynx, extracted some chewed veal, and endeavoured, by inflating the lungs through the artificial opening, to restore life, but without success. The deceased was a poor man, and has left a wife, who daily expects to be confined, and two children.

Loss of the frigate STATIRA.

JAMAICA, Feb. 3.—The British frigate Statira, Capt. Swaine, convoying several transports, having on board the 27th regiment, from Bermuda, for the Missisippi struck on a shoal, off Henega, and went to pieces—her crew were taken on board the transports and carried to Jamaica.

BRIDGE. TOWN, (Barbados) Jan. 7.—At noon yesterday, II. M. S. Barossa arrived from Antigua.

It is satisfactory that we are acquainted with the recent capture of the American sloop of war Wasp, by the Castillian British brig of 18 guns, which it is reported, fell in with the enemy while cruising off Madeira, and took possession of the Wasp by boarding.

CHARLESTON, March 22. Interesting Anecdote of the late Lieut. Gen. Packenham.-We learn from a gentleman who conversed with an officer of the late British expedition against New-Orleans, that in the memorable battle of the 8th Jan. Gen. Packenham sent two of his Aids, successively, to the Hon. Col. M. of the 44th, to bring up his regiment to support the troops who had gained the right bastion of the American lines. The Col. was found in the rear of his regiment, which was advancing slowly, and made no effort to accelerate its movement. On learning this, Gen. Packenham immediately galloped to the head of the regiment, and in the act of cheering them on, received a mortal wound. Afterwards, Col. M. having come up, the Gen. brandished his sword over his head, and exclaimed,-" You cowardly villain, if I live till to-morrow, I will have you hanged." He shortly after expired. The Colonel has disappeared, and has not been heard of since.

January 20.

Letters from Lisbon, of the 30th Dec. announce, that the American privateers commit great depredations on the coast of that kingdom; they were uneasy about the fate of one of our Shoops of War, which was engaged near Cape St. Vincents, in a hard fought battle with one of those privateers, carrying 24 guns.

PARIS, December 17.

Those persons who recollect having read in the Newspapers of 1811, of a young A. merican, named ZERAH COLBURN, who had an extraordinary natural faculty for mental calculation, will learn with pl. asure, that this young man, who is now actually in Paris, has already given proofs of his prodigious talent for resolving the most com. plicated arithmetical calculations in the presence of persons the most capable of judging of this talent, we mean the members of the office of longitude, to whom he has been introduced, and to whom he has answered, on the spot, the following questions. What is the cube root of 1,879,080,904 ? He answered, 1,234-What is the square root of 5000? He answere i, 225, with a remainder of 271 .- What is the square root of 200,000 ? He answered, 447, with a remainder of 191.-What are the factors of the number 163,267? Ilis answer was, 12, 559 and 13 .- What are the factors of 97. 051 ? He answered, 75 and 2623. Many other questions were put to him to which he gave answers as correct as prompt. All the members present testified much satis. faction with and a lively interest for him.

Extract of a letter from Carthagena, dated 6th Feb.

"Tranquillity, which at first appeared to be entirely re-established, has only, unfortunately, been momentary. Three posts, with a quantity of specie, have been detained at Mompos. The people of the latter place are much dissatisfied that Peneres, who is a native of that town, should have been transported; but we hope that Gen. Bolivar, who is coming from Santa Fre, with 4,000 men, to take the command of the army of Magdelena, to attack Santa Martha and Maracaybo, will quell any distarbance."

FEB. 1.—By II. M. Ship Medina, which arrived on Tuesday last, we learn, that Rear-Admiral Durham, had received an official letter from Capt. Patterson of the Myrmidon, 20 gun ship, stating the capture, by that vetsel, off the Western Islands, of the American ship Wasp of 22 guns, after an engagement of two hours, during which, both vessels suffered very severely.

A small British schooner, tender to the ships of war below, arrived here yesterday, commanded by Lieut. Templeman, of the Orlando frigate. For what purpose she came up is not known, bat it is conjectured that an officer on board her has proceeded to Washington to make some arrangements in relation to the release of the slaves which are in their possession, taken from the lower countries of Maryland and Virginia.—Alexandria Gazette. 16/h Feb. 1815.

PARIS, JAN. 9.

Rauch, the Prussian sculptor, has returned from Berlin to Rome, where he had proposed to fix his last residence. The last piece of work he performed, was the tomb of the deceased Queen of Prussia. The monument was put on board of an English brig, in October last, to be conveyed round to the North. The brig was captured at sea by an American privateer ; but an English man of war subsequently fell in with and recaptured her, and she has since arrived at Cherbourg. When the season permits, this monument will be sent to Berlin by way of Elbe.

VIENNA, Jan. 15 .- It is said that Prussia notwithstanding all the arrangements which are proposed to her, is absolutely de. termined to hold the circle and city of Leip. sic. When once the fate of Saxony is fix. ed, the high powers will turn their attenti. on to the province on the left bank of the Rhine, and much warm and lively dissention is likely to take place. Those who ex. pect a speedy termination of the Congress, and who express an assurance that it will close in three or four weeks, are much deceived in their calculations. The Emperor Alexander has declared that he will not leave Vienna until all the great subjects are regulated in a definitive manner.

FROM EUROPE.

By the schr. Commodore Macdonough, arrived at N. York from Bordeaux, Fr nch papers to Feb. 4, and Belfast to Jan. 31, have been received. Nothing authentic is yet known as to the Congress of Vienna. Its protracted session shews that it has encountered difficulties.

The Lords Commissioners of the Admiralty of Great-Britain, have given notice, that the first moment the season will permit, they will grant convoys for Nova-Scotia, Bermuda, New-Brunswick, &c. And it is officially announced in the Loudon papers, that instructions have been sent out to the Governors, of New-Brunswick, Bermuda and Nova-Scotia, to permit English vessels laden with merchandize intended for the American market, to proceed to the U. States without first unloading, as soon as they shall have received information of the ratification of the Treaty on the part of the U. States.

The French Government have issued an order prohibiting the Slave Trade by French subjects, any where to the northward of Cape Formosa—affording protection to 1500 miles of coast.

A Bordeaux paper of 31st Jan. mentions, that the Phœnix, Capt. Easterby, from Charleston, had just entered the river, with a cargo of 600 bales of cotton and 700 bags of rice.

KINGSTON, (Jam.) Feb. 18.—His Ma. jesty's brig Onyx, of 12 guns, capt. Cobb, came to anchor at Port Royal yesterday from a cruise off Cape Maize, where she left the Thracian brig of 18 guns, Captain Carter.

On the afternoon of the 7th inst. while off Cumberland Harbor, the Onyx sent a boat to reconnoitre, when a large Am. sch. passed close by the boat and fired into her, by which Lieut. Stewart, first of the Onyx, received a ball in his right temple, which passed through the left eye, and one man was killed and three wounded. We are They had accounts in England that our frigates President, Constitution and Congress, had sailed in co. and that the British ships Newcastle, Leander, and Acasta, were looking for them. There was a report also of another Am. squadron being at sea, and several large vessels were ordered to seek it.

A Paris paper mentions, that several French vessels have been seut on the Slave Trade. Will the British take these vessels as they do those of Spain and Portugal engaged in the same trade ?
