

experience with regard to this point; but he had been informed by the Dean of the Archdeacon, that there was a case which might be considered as a precedent favourable to the right of profession, and which, therefore, it would not be becoming in him to surrender. The truth appeared to be, that these were a perfect equality of rank between the *servientes ad legem* and the *doctores legum civilium*; they proceeded in their respective Courts *pari passu*, the Serjeant taking precedence in *foro regni*, and the Doctor in *foro civili*. To establish this principle, he begged to read a pretty long extract from Sir H. Spelman's Glossary. All the ancient writers spoke in the highest terms of the dignity of Doctors of Civil Law, and one author enumerated no less than 130 privileges which belonged to them. Water-house and Oughton were the authorities to which he would principally direct the attention of their Lordships; and if, on consideration of them, they should determine for the right of his Learned Friend, he should cheerfully submit to their decision.

Mr. Serjeant Copley did not think the quotations adduced by his Learned Friend, proved any priority on either side, and were therefore not at all decisive of the question.

The Court was then cleared for about half an hour, when it was finally arranged that the point should be reserved—that Dr. Stoddart should open the pleadings, and that Mr. Serjeant Copley should then be heard on the general merits of the case.

Mr. Serjeant Copley, and afterwards Dr. Stoddart, then addressed the Court at great length for the respondent, contending that the evidence on the other side was wholly insufficient to support the plea, that Mr. Atkinson had procured the codicil in question to be made by exercising an under influence over the mind of the testator, or the general allegation that there was any deficiency of testamentary capacity, either at the time the original will was executed, or the codicil. At half past three the Court adjourned in order to allow time to the Counsel for the respondent to compress the points of their defence into the narrowest compass, as the Court cannot sit later than Tuesday next.

#### GEN. HALKET'S BRIGADE.

This gallant brigade was honored with several visits from the illustrious chief. In one he inquired "How they were?" The answer was, that two thirds of their numbers were down, and that the rest were so exhausted that leave to retire, even for a short time, was much desirable; that some of the foreign corps, who had not suffered, might take their place. General Halket was told that the issue depended on the steady, unflinching front of the British troops; and that even a change of place was hazardous in the extreme. He impressively said, "Enough, my Lord, we stand here till the last man falls."

One anecdote more of this glorious brigade I cannot withhold. I have no apology to make for the length of my narrative; I feel that every one who reads of Waterloo, will agree with me in opinion, that it is impossible to dwell too long upon the engrossing theme. A gleam of the gentler affections is hailed with tenfold sympathy, when for a moment it gilds an interval of the empire of the sterner virtues in the warrior's bosom. It is like the breathing of the softest flute after the clang of a thousand trumpets; or the downy contact of the halcyon's breast which stills the stormy sea. In the midst of their dangers, this band of heroes had their attention called to a very affecting scene of private friendship. Two of the officers were the more closely attached to each other, as they were not on term, of perfect good understanding with the rest of the mess; owing to their having opposed some arrangements which the rest thought expedient, but which it was expected would be attended with some expense; and at the same time concealed most honourably, the real grounds of their opposition to the general voice; that, besides their own families, they had each two sisters to support; a consideration which assuredly they could not have pleaded in vain. The similarity of their circumstances most naturally cemented their friendship; which was quite a by-word in the regiment. After doing their duty calmly through nearly the whole of the murderous day, they found themselves unhurt at a late hour in the evening; when one of them playfully called to the other, who stood at a little distance, "I always told you they never would hit me. They never did it in Spain; and they have not done it to-day." He had hardly spoke, when he was shot dead on the spot. His friend stood for a few moments motionless; then burst into tears; flew to the body, threw himself down beside it, and sobbed over it inarticulately repeating several times "My only friend!" The officer who related the affecting story, told me, that so completely did the scene overcome every one who witnessed it, that there was not a dry eye among them.

The widows of Marshals Bessiers and Duroc, have proceeded to Vienna, to make claims of possessions of their late husbands in Italy.

Capt. Ferrier arrived at Alexandria, from Rotterdam spoke on the 8th Aug. at sea, the British brig *Bucephalus*, in 32 days from St. Helena, and was informed by the boarding officer, that Bonaparte had been sick, but had recovered, and was then employed in writing his life.

HAVANA, AUG. 9. Yesterday His Excellency the Viceroy of Mexico, sailed from Vera Cruz, in the *Diana*, with the other vessels of war and transports, which had put back on account of the calms which prevail in the gulph of Mexico at this season of the year.

Capt. *GEORGE*, from Havana, reports, That the orders lately received from Spain, for augmenting the duties, &c. had given much dissatisfaction to the people, and had made the new Governor unpopular:—That three Spanish vessels had lately arrived in Cuba, with about 600 slaves, from the coast of Africa; which narrowly escaped the vigilance of the British cruisers:—and that a Spanish brig, from Philadelphia, with 270 barrels of gunpowder on board, had been captured by a Carthaginian privateer and blown up.

We also learn, that a fleet of African (slave) traders, sixteen in number, fast sailers, and well armed and manned, sailed for the coast about fourteen days since.
