LONDON, JUNE 9. Yesterday we received two days Paris papers, being to Thursday last .--- The meeting of the diet at Frankfort is postponed, difficulties in the affairs of Germany being visible. The Emperors of Austria, Russia, and the King of Prussia meet at Toplitz on the 15th of July. The King of Bavaria has rejected the advice of his ministers to reduce his army; on the contrary, he intends to augment it. Our private letters of the fifth from Paris say, " the maintenance of this formidable military force is entirely owing to the councils of Eugene Beauharnois and Prince Wrede. Bavaria leans more to the side of Austria than to that of the Northern Powers. The Paris news consists chiefly of accounts of reigious ceremonies, and particulars respecting the marriage of the Dake of Berri, which will take place on the 17th inst.

The Princess Charlotte, we regret to state, has been so much indisposed as to be confined to her chamber at Camelford house. Her R. Highness had a cold on Wednesday, but having promised to attend the performance at the Hanover-square rooms, for the benefit of the royal society of Musicians, and being fearful her absence might be injurious to the charity, she very humanely determined on going. About the middle of the second part, her Royal Highness found her indisposition increase, and returned, accompaneid by her royal consort. Dr. Bailey and Mc. Walker were sent for, and they have pronounced that her Royal Highness has a very bad cold, accompanied with some fever ; but they are not apprehensive of the least danger. Her Royal Highness had a vein opened on Thursday in one of her arms, enjoyed a comfortable sleep, and was in consequence much better. The marriage of the Duke of Gloncester with the Princess Mary is finally settled ; and has been formally announced to the different branches of the royal family; the solemnization is to take place about the 15th inst. either at Carlton-house or the Queen's palace ; the honey-moon is to be passed at his seat at Bagshot.

## From the NEW-YORK EVENING POST.

## THE COMMERCIAL TREATY

Which the Administration, with an effrontery that must astonish, boast of having concluded with Great-Britain, and which they proclaim to a delude. People, as one of the trophies of their glorious war, is thus spoken of in one of the late English prints that happens to lie before me:---

" The Commercial Treaty we have formerly inserted, and, on it finally passing into a law, we have no hesitation in stating, that it will have the most beneficial effect on the commerce of Great-Britain, and is, in every respect, the most favorable for every settlement and colony belonging to the empire. The direct trade is too well known to admit of a comment ; the indirect traffic, the trading between our North-American settlements and the West-India colonies, is of much interest, and is now assuming a consequence of which the Legislature of Great-Britain seems perfectly aware. Some days ago, the official communication to the Admiral on the North-American station was published, strictly to prevent all American vessels from fishing on the shores of our settlements, or from landing to cure on the territory of Great-Britain ; and that there could be no misunderstanding, as the fishers could not plead ignorance the second season. The American flag is also excluded from our West-Indies possessions ; the whole of the beneficial trade of supplying the West-Indies with provisions, lumber, &c. is thus allowed only to British vessels and British capital," Such is the light in which the British view this Commercial Treaty; as valuable in various lights, and as best possible for their North-American possessions. They enumerate the advantages they have obtained over us, and the enumeration is not a chimerical one. It appears from the above that the British government has set itself in earnest to work, to secure the benefits of this treaty, as respects the fisheries. The last Salem Gazette informs us that 42 fishing vessels have arrived at Marblehead since the 2d of May, with 611,000 fish, being the greatest fares ever known in that place ; but, it will be recollected, that some of these vessels narrowly escaped capture and detention, for fishing where they had no right to fish, but which they formerly enjoyed, merely as a privilege or courtesy, under an article in the treaty of 1803, but which we have now lost by its not being recognized in the treaty of 1813. or by the late Commercial Convention. Our vessels were indeed permitted to come home, but they were warned how they attempted to fish on the coast or in the harbour of Newfoundland another season, upon pain and penalty of what may fall thereon. We now perceive in the above extract that this warning has been given under the authorily, of the government. We see too in this extract much exultation that henceforth we shall not be allowed to trade to the West-Indies. The experiment is now making whether the provinces. of Canada and Nova-Scotia cannot supply the wants of her West-India Islands independently of any aid from the United States. An experiment which will prove most disastrous to the eastern States, and which they owe to the late glorious war, and the glorious manner in which the Administration have terminated it --- But ebough for the present .--- This unwelcome subject will

The Algerines are stated to have broken the treaty entered into with Lord Exmouth ; seized some English vessels at Oran, and sent the British Vice Consul at that place, with their crews, captives to Algiers. This act of perfidy on the part of these barbarians, will, it is presumed, speedily meet with the most signal vengeance. Courier.
