A PROCLAMATION.

WHEREAS by Act of Parliament passed in the Forty-eighth Year of His present Majesty's Reign, Power is given to the Governor, Lieutenant Governor, or Commander in Chief of this Province, with the advice and consent of His Majesty's Council, to allow the importation of certain enumerated articles from the United States of America into this Province, for the purpose of re-exporting the same—I have therefore thought with the advice and consent of His Majesty's Council, to publish this Proclamation, hereby authorising and empowering British Subjects, for the space of six months from the date hereof, to import and bring into this Province from the United States of America, in British built Ships or Vessels, owned and navigated according to Law; Scantling, Planks, Staves, Heading-Boards, Ringles, Hoops or Squared Timber of any sort; Horses, Neat-attle, Sheep, Hogs, Poultry, or Live Stock of any sort; Bread, Flour, Peas, Beans, Potatoes, Wheat, Rice, Oats, Barley, &c. Grain of any sort; and British Subjects during the same period, are hereby authorised and empowered to Export in British Ships, owned and navigated as aforesaid, all or any of the said grain before enumerated articles, to any other of His Majesty's Colonies or Plantations.

GIVEN under my Hand and Seal the eighteenth day of JUNE, in the Year of our Lord one thousand eight hundred and sixteen, and in the fifty-sixth year of His Majesty's Reign.

WOOD.

WANTED for the use of His MAJESTY'S Troops, &c. in this Garrison, from one thousand five hundred, to two thousand CORDS of merchantable HARD WOOD, to consist of Maple, Black & Yellow Birch, White Ash, and Beech, to be delivered into His MAJESTY'S Fuel-Yard at this Post, such quantities as shall be required by the Officer in charge. The WOOD to be properly inspected and measured by a Person duly sworn for that purpose, at the expense of the Contractor, and the whole to be completed by the 1st day of APRIL, 1817.

Sealed Proposals for supplying the above, will be required at this Office until the 15th day of July next, when the lowest offer, if approved of, will be accepted. Payment to be made upon delivery of every five hundred Cords, in Cash or Bills of Exchange at the current rate, at the option of the Officer in charge of the Commissariat at Saint John.

Unexceptionable security will be required for the due performance of such Contract as may be entered into.

At a Court of General Sessions of the Peace holden at The Province Hall in Fredericton, in and for the County of York, on the 13th day of June, A. D. 1816.

ORDERED, that the Regulations respecting the Ferry from FREDERICTON to MONCTON, and across the NASHWALK, made at the General Sessions of the Peace, holden in June, 1815, be rescinded, and in lieu thereof, that the following Rules and Regulations be made and ordained, viz:—

That constant attendance be given by the FERRY-MAN, at the said Ferries on every day in the week from Sun-rise until nine o'Clock at night, and if any Person shall be detained at the said Ferries by the neglect of the Ferry-man, or by his absence, unless from unavoidable circumstances, the Ferry-man shall forfeit and pay the sum of ten shillings, to be recovered and applied as by Law directed.

That a good and sufficient SCOW and BOAT shall be always in readiness at the said Ferries, and not used for any other purpose than as FERRY-BOATS; And that the Boat used for foot passengers shall be always kept clean, under the like penalty of ten shillings for each and every offence.

That the following Rates and Fares, and no greater may be taken at said Ferries:—*to wit,*

For every Foot Passenger,	7½d
For a Horse or Cow,	9d
For an Ox,	1s
For Hogs, Young Cattle & Sheep,	3d
For a two wheeled Carriage,	2s6
For a four wheeled Carriage,	3s

And that half the above Fares be taken for crossing the Nashwalk.

And if any greater sum or sums shall be taken or demanded by the Ferry-man than the Rates and Fares above stated, he shall forfeit and pay the like sum of ten shillings for each and every offence, to be recovered and applied as by Law directed.

At a Court of General Sessions of the Peace, holden at the Province Hall, in Fredericton, in and for the County of York, on the 13th day of June, A. D. 1816.

The following Rules and Regulations are made for the better government and management of the MARKET established in the Town of FREDERICTON:—

1st. The Regular MARKET HOURS shall be from SIX in the morning until TWO in the afternoon of every day in the week (*Sundays excepted*) and on SATURDAY the MARKET shall be open in the Afternoon from THREE o'Clock, until SUN-SET.

2d. That no Fish, Fresh Meat, or Poultry of any kind, or Butter, shall be sold in any private STALL or SHAMBLES, or in any part of the Town of Fredericton until the same shall have been regularly exposed for sale in the MARKET-HOUSE for the space of TWO HOURS, under the Penalty of twenty shillings for each and every offence.

3d. That no Person shall purchase any Fish, Fresh Meat, or Poultry, of any kind, or Butter, in the said MARKET for the purpose of selling the same again, until after the same shall have been exposed for sale in the MARKET, for at least TWO HOURS under the penalty of twenty shillings for each and every offence.

The following Law of the Province is published for the information and government of all concerned:—

An Act against Forestallors and Regraters.

I. BE it enacted by the Governor, Council and Assembly That from and after the publication hereof, whatsoever person or persons shall buy or cause to be bought any Victuals of any kind whatsoever, coming by land or water towards any Market or Fair already established or that may hereafter be established in this Province, to be sold in the same again, (except at the distance to Ten miles at least from the place where such Market or Fair is to be held or kept) or shall make any bargain, contract or promise for the having or buying the same or any part thereof, or shall make any motion by word, letter or message or otherwise, to any person or persons, for the enhancing the price or dearer selling any kind of Victuals or Provisions for the use of Man, coming by land or water towards any Market or Fair as aforesaid, shall be deemed and adjudged a Forestaller.

II. And be it further enacted, That whatsoever person or persons shall by any means regrate, obtain or get into his or their hands or possession in any Fair or

Market in this Province, or on board any vessel in the the harbour of Saint John, any corn, hay, butter, cheese, fish, mutton, lamb, veal, beef, pork, poultry or game of any kind, or other dead victuals whatsoever, or any roots, fruits, or vegetables whatsoever, that shall be brought to such Fair or Market, or shall be on board such vessel for the supply of the Markets of the City of Saint John to be sold, and do sell the same again in any Fair or Market, Shop or Stall, holden or kept in the same place, within One Month after purchasing or receiving the same shall be accepted, reputed and taken for a Regrater or Regraters.

III. And be it further enacted, That any person or persons who shall be guilty of Forestalling or Regrating, contrary to the intent and meaning of this Act, and shall be convicted thereof by the Oath of one or more credible witness or witnesses before any three of his Majesty's Justices of the Peace for the County where the offence is committed, or the Mayor or Recorder and two of the Alderman of the City of Saint John, when the offence shall be committed in the same City, shall be fined at the discretion of the said Justices and the said Mayor, Recorder and Aldermen respectively, in any sum not exceeding Ten Pounds, and non-payment of his or their Fine shall suffer imprisonment at the discretion of the said Justices and the said Mayor, Recorder and Alderman respectively, not exceeding Two Months for each and every offence; one moiety of the said Fine and forfeitures to be for the use of the Poor of the Town or City where the offence shall be committed, and the other moiety to him or them who shall sue for the same.

AT a COURT of GENERAL SESSIONS of the Peace holden at the Province Hall, in Fredericton, in and for the County of York, on the 13th day of June, a. d. 1816.

ORDERED that the Commissioners of Highways, Overseers of the Poor, and Collectors of the several Parishes do regularly on the first day of the January Sessions in each and every year, deliver their respective Accounts with Vouchers; and in default of so doing, that they be considered as delinquents, and be proceeded against accordingly.

Ordered that Copies of this Order be sent to the Clerks of the respective Parishes with directions that they notify all the parties concerned.

AT a COURT of GENERAL SESSIONS of the Peace, holden at the Province Hall in Fredericton, in and for the County of York, on the 13th day of June, a. d. 1816.

WHEREAS it appears that the number of TAVERNS heretofore Licenced within the County of YORK, is far greater than is necessary for public convenience, and many Persons have obtained Tavern Licences for the sole purpose of selling Spirituous Liquors, without having the means of furnishing the requisite accommodation for TRAVELLERS which is found a great Public injury, and destructive of the Morals of the People: RESOLVED therefore, that the following Regulations be adopted with regard to the granting of Licences for Taverns, in future, within the County:—

1st. That in future no LICENCE for keeping a TAVERN within the Town of Fredericton, be granted to any Person unless such Person shall be able to prove to the satisfaction of the Court, that he can furnish at least, Two good Beds, Four suitable stands for Horses, Two separate Rooms, and such other accommodations for Travellers and others who may require it, as shall appear to the Court to be necessary.

2d. That no LICENCE be granted for keeping a TAVERN in any other part of the County unless the Applicant shall be able in like manner to prove to the satisfaction of the Court his ability to furnish at least, Two good Beds and Six Stands for Horses, One Private Room, and such other accommodations for Travellers, as the Court may judge expedient.

3d. That no Licence be granted to a MILLER at any Grist Mill.

4th. That no Licence in future, be granted for a less sum than forty shillings.

Ordered that the preceding regulations be forthwith published in the Royal Gazette, and also in Handbills to be distributed throughout the County, that all Persons concerned may be duly apprized thereof; and govern themselves accordingly.
