" Newport, (R. I.) June 18, 1816. "Dear Miss, -Under the most painful sensations am I about addressing myself to you, on a subject the most delicate to a feeling heart, more especially to a heart broken by the neglect and cruelty, of a once fondly attached and tender husband; yes, Miss, all that women could wish in a husband, was Amos B. HARVEY, once to me. Perhaps you may be surprised at receiving a letter from a person unknown to you, but I trust that my being the wife of Mr. H. united with a sincere desire of saving an innocent female from ruin, will be a infficient apoligy.

Ten years, the 25th of last April, I was legally married to Mr. Harvey, he was selected by my heart, I truly loved him, and had every reason to believe I was sincerely beloved by him: at that time, and for some time after we were married, he remained at home with me, following his occupation which is a Printer; at length, business being very low, and not sufficient to support us, he turned to the sea, which calling he has pursued ever since. He used to be very punctual in writing every opportunity, and always was happy to return to me, until the last four years.

"The 4th day of last April, four years since, Mr. H. left home, seemingly with great reluctance, promising to return as soon as he possibly could, as he knew the anxiety and distress I always suffered when separated from him, as he was my all, and my whole soul was wrapped up in him .- The first year, of the said four, I as usual received several letters, all couched in the same affectionate style, the last dated at Lisbon, stating that he should go from there to Pool or Leith, and then home; at the expected time I was looking with the greatest anxiety: O God! how often has my soul been harrowed up with the fear of his being in prison, or dead, little suspecting that his heart was estranged from the wife of his bosom. Three long, and painful years, I heard not . one word from him-until last August I heard of his being in Boston; he wrote to me by a gentleman we were both, well acquainted with: in consequence of that letter I went to Boston to see him, as he said his business would not permit him to come to me; with great joy and pleasure I went to him; he received me with every mark of conjugal affection, with tears lamented being so long from me, and assigned as a reason for it, that he had been imprisoned a great part of the time, and his circumstances such that he was not able to come home, or send any thing for my support. I staid with him in Boston until he was ready to sail for Halifax; but after I returned to Newport, I received a letter from him, that he had not sailed, but was on the eve of sailing; he then repeated what he promised me in Boston, that he would write to me after his return to Halifax, and would send me goods, articles for clothing, and money to discharge his debts .- Accordingly, I received a letter from H. dated 4th Octr. informing that unfortunately he had been cast away, that then he could send me nothing, that he was obliged to stay in H. until his insurance became due, which was payable in sixty days,

and then he should return to me, and never meant to

leave me again, but quit the seas entirely, and with me

retire into the country; this pleased me. - O! how cruelly have I been deceived !--- How is it possible that such duplicity can rest in the heart ! Dear young woman, think not that I feel any hardness in my heart against you, because you, have attracted the heart of Mr. H. No, surely I do not, but rather pity that you have, like myself, been so basely deceived; and I pray to Almighty God, that you may be spared the pangs I now feel --- for this purpose do write this, hoping it may reach you in time to defeat the purpose of a wicked
