WHEREAS by Act of Parliament passed in the Forty-eighth year of His present Majesty's Reign, Power is given to the Governor, Lieutenant-Governor, or Commander in Chief of this Province, with the advice and consent of His Majesty's Council, to allow the importation of certain enumerated articles from the United States of America into this Province, for the purpose of re-exporting the same...

A Proclamation.

The following extract from an Act of Parliament, is published for the information of the FERRYMEN in this Province:--And Notice is hereby given that prosecutions will be commenced against all Persons who shall in future offend against the said Act.

ANDREW PHAIR, Postmaster. STATUTE made and passed in the 9th year of the Reign of Queen ANN, Chap. 10. Sec. 29. "And for as much as the Post must necessarily cross several Ferries in North America, in which the Ferry-men give great delays, and sometime have endeavored to exact money from them notwithstanding the same have been always free for the Post: Be it therefore enacted by the authority aforesaid, that no Deputy or Agent of such Postmaster General travelling with any mail of Letters shall pay any thing for passing or re-passing any Ferry within any of the Colonies or Plantations of Her said Majesty in North America aforesaid, but such Ferry-men shall forthwith, within one half hour after demand, convey such Deputy on pain of forfeiting for every such offence, the sum of FIVE POUNDS, to be recovered in any Court of Record within any of the Provinces or Colonies in North America, by bill, plaint, or information, wherein no Essoin, Protection or Waiver of Law shall be allowed; one moiety thereof to Her Majesty, her Heirs and Successors towards the support of the Government of the said Provinces, and the contingent charges thereof: and the other moiety to the Postmaster General who shall sue and prosecute for the same, together with full costs of Suit."

Regulations respecting the granting of Licences to cut Pine Timber.

NO Licence to be granted to cut Timber on Land reserved for the use of the Crown.

LICENCES to be granted only to British subjects, with condition to be forfeited if assigned to Aliens, and every Licence to specify the quantity to be cut, and to be limited as to time; and no Timber fit for the Navy to be permitted to be cut for private use.

NO Licence to be granted to cut Timber on Lands for which application has been made for Grants, and every applicant for a Licence, to describe particularly the Land on which he wishes to cut, and the quantity of Timber, and accompany his application with a Certificate, that the Land has not been applied for to be granted.

ALL applications for Licences to be handed in the first place to the Deputy Surveyor of the Woods, who, if he thinks fit to recommend the application, will lodge it in the Secretary's Office, to be laid, in the usual manner, before a Committee of His Majesty's Council for consideration; and any three Members of the Council to be a Committee for the purpose of considering the applications in question.

AT a Special Session of the Peace holden at the County Court House in Fredericton in and for the County of York, on Wednesday the 6th of August, 1817, for the Purpose of regulating the ASSIZE of BREAD in the Town of Fredericton,

Ordered that from and after Saturday the 9th inst. the ASSIZE of BREAD be as follows:--viz.

THE Shilling Wheaten Loaf to weigh Two Pounds Twelve Ounces, and the Shilling Rye Loaf to weigh Four Pounds and other Loaves in proportion.

ORDERED that for every offence in Baking and Vending any Loaf of Bread under the weight abovementioned, the Person so offending shall pay a fine of ten shillings to be recovered upon conviction, before any one of His Majesty's JUSTICES OF THE PEACE on the oath of one or more credible witness or witnesses, or view of the Justice and levied by Warrant of Distress and Sale of the Offenders Goods; and when recovered, (after deducting the costs and charges) to be paid into the hands of the overseers of the Poor of the Parish of Fredericton.

ORDERED that the respective Bakers be furnished with a Copy of the above regulations, and that they be published in the Royal Gazette.

All accounts agree, that in England Commerce and Manufactures were rapidly resuming their former activity; and in some places exceeded, any former period:--That provisions had fallen to peace-and-plenty prices; and that the industrious were finding steady employment.

Generally speaking the harvest had been abundant throughout Europe; and songs of joy had every where succeeded to the murmurs of complaint.

Europe was overloaded with specie--Its value, of course, had depreciated. In Paris, good notes were discounted at less than five per cent--In Amsterdam and London at four; and at Hamburg at three and a half per cent per annum. The Bank of England had given intimations that it would shortly discount at four per cent.

AMERICAN NAVIGATION ACT.

This day commences the operation of the important act passed during the last session of congress, concerning the navigation of the United States.

It appears from the eastern papers, that considerable difference of opinion prevails among the merchants in that quarter, as to the construction of the first section of the act. We have been favored with a copy of the circular issued on this subject from the treasury department, which is subjoined for the satisfaction of those concerned.

CIRCULAR.

Treasury Department, 29th Sept. 1817.

SIR--Inclosed you will receive a copy of the Act of Congress, "concerning the navigation of the United States," passed the 1st day of March last, which is to take effect on the 1st day of October next. The first section of the act makes an important change in the commerce of such foreign nations with the United States, as have in force regulations of a similar nature.

To secure uniformity in the execution of this measure, and to render the change imposed by it as convenient to those whose interests are to be affected, as the provision of the act will admit, the term country, in the first section, is considered as embracing all the possessions of a foreign state, however widely separated, which are subject to the same supreme executive and legislative authority. The production and manufactures of a foreign state, and of its colonies, may be imported into the United States in vessels owned by the citizens or subjects of such state without regard to their place of residence within its possessions. Gold and silver coin, and bullion, are not considered goods, wares or merchandize, within the meaning of the act, and may, therefore, be imported into the United States in foreign vessels, without regard to the place of production or coinage.

A list of foreign states known to have in force regulations which subject them to the operation of this act, is subjoined.

To ensure uniformity in the execution of the 3d, 5th and 6th sections of the act, it is expedient that, in all cases where proof is exhibited, on oath according to their provisions, the witnesses should be cross-examined by the collector, whose duty it is to decide, for the purpose of avoiding imposition and detecting evasion.
