PROVINCIAL VACCINE INSTI-TUTION-NEW-BRUNSWICK.

S it appears, that, notwithstanding the anti-variolous properties of the Cowpox have long since been established beyond all doubt, the practice of Vaccination has frequently been neglected in the Province of New-Bronswick; and that some obstacles have prevented its general use: the formation of a Public Institution, with a view of obviating those difficulties, and averting the calamities which are to be expected from the prevalence of Small-pox, cannot fail to be attended with the most beneficial effects.

In a country where the Small-pox has rarely been known, and where there exist some thousands who have no security against its attacks, the extent of the evil which might result from the casual introduction of this disease, is scarcely calculable; and the hazard to which the community is exposed from this source, owing to the vast concourse of emigrants arriving in the Province, recent occurrences render sufficiently obvious.

A Vaccine Institution is, therefore, now formed under the auspices of His Excellency the Lieutenant-Governor and the Members of His Majesty's Council, with a Committee at each station, for the purpose of carrying into effect the objects of the Institution.

No other conditions are required from persons Vaccinated than regular attendance on the days appointed, until the progress and character of the Vaccine pustule be ascertained ; --- a circimistance of the greatest importance, in order to prevent the introduction of a spurious disease.

Charges of Vaccine Lymph will be furnished to Country Practitioners, free of expense; who are requested only to send lists to the Secretary, of the persons, Vaccinated, agreeably to the manner above directed.
