The English Mail for July, arrived at the Post Office yesterday afternoon, bringing London dates to the 9th of that month, but they furnish us with little more than we were previously in possession of.

Extract of a Letter from New-York, dated July 31st.

"The price of Plaster of Paris has advanced 25 per Cent. in France, in consequence of the exclusion of that article from Nova-Scotia and New-Brunswick. The price in France is now 3 1/2 to 4 dollars per ton."

POSTSCRIPT.

Free Press Office, 5 o'clock a. m.

The Grace Packet arrived last night with the July Mail in 38 days from Falmouth; our files of Papers are down to the 9th July from which we have made Extracts; but they are extremely barren.

LONDON, JUNE 29.

There has been much rioting in Holland in consequence of the dearness of provisions; the mob had compelled the Corn dealers to sell at the prices it fixed.

JULY 4.

The Regent steam-packet, bound in Margate, was burnt to the water's edge, off Whitstable. Crew and passengers saved.

The cause of the fire is stated to be as follows: The gale of wind being strong, blew the chimney fire away, and the wood-work, which is nearly breast high from the deck, at the bottom of the flue, for the purpose of keeping the people near the chimney from burning themselves, caught fire; the men in throwing the buckets over for water to put it out lost them, consequently the fire was not checked, and the captain immediately made for land, and got all the people and crew, and luggage, safe ashore; but the vessel is almost entirely consumed.

JULY 5.

WATSON, and the other persons lately acquitted of High Treason, were to have dined together on Monday next, at Pentonville, to return thanks for the interest taken by their friends in their fate on the occasion of their trial. Yesterday the dinner was put off sine die, on account, as it is said, of the illness of HOOPER, whose life is again thought to be in danger.

JULY 7.

Yesterday and this morning we received the Paris Papers of Thursday and Friday last. The price of grain still continues to fall. In the department of Pay de Dome, the sack of wheat has fallen from 70 to 40 francs, and in other quarters in a similar proportion.

The accounts from Madrid state, that there was a confident expectation of an amnesty in favour of all the proscribed Spaniards.

The Duke of CLARENCE was so much better on Saturday as to be up and sit in his drawing-room at Bushy.

JULY 8.

We received this morning the Paris Papers of Saturday last. They continue to give accounts of the fall in the price of Grain, and of the favourable appearance of the Harvest.

DEATH OF MR. PONSNEY.

We feel much regret in stating, that the melancholy apprehensions respecting this Gentleman were confirmed by his departure this morning, at ten minutes past six o'clock. The late Right Honourable GEORGE PONSNEY was born on the 5th of March 1755. He was appointed Lord High Chancellor of Ireland, March 23, 1806, which office he resigned. He was Member for Tavistock. He was married on the 18th May 1781, to Lady MARY BUTLER, eldest daughter BRINSLEY, the second Earl of BELVEDERE, by whom he had several offspring. He was highly esteemed in private life, as well as in the important office which he filled in Ireland.

As the Leader of Opposition he held forth a laudable example of dignified manners, temperate eloquence, powerful reasoning, illustrated by extensive learning, and an exemption from the narrow spirit of Party.

DIED] At her Son's House, in this Town, on Wednesday the 13th inst. Mrs. HANNAH MILLER, relict of Stephen Miller, Esq. deceased, aged 82 years. Her illness had been severe for the last four months with extreme pain, which was borne by her with the steadiness and fortitude of a Christian. She was a woman of great humility, and of singular piety. Her connections feel her loss an irreparable one.
