prices of this day week, but inferior sorts were very dull, and from 3s. to 4s. per quarter cheaper. Real fine Barley and Malt supported their prices, but discoloured New Barley was 3s. to 4s. cheaper. Boiling Peas and Beans were dull, and Grey Pease were from 2s. to 3s. per quarter lower. The sale of Oats was dull, having a large supply, and from 2s. to 3s. per quarter lower. In other kinds of grain there was no alteration.

On Wednesday the Diana transport arrived at Portsmouth from Quebec. She brought home some mechanics and a body of seamen from the Lakes to be discharged

from the service.

The Madagascar frigate has been commissioned to supply the place of the Niger on North American station. The Niger, although she is a new ship (built of fir,) must be either broken up there, or sent home immediately for that purpose. Capt. JACKson and his officers will remove into the Madagascar.

ANUARY 21.

Some German papers which arrived last night contain two articles of considerable about 2,500 Soldiers on board, under conimportance. The first of these relates to the Crown Prince of Sweden, Bernadotte. The Nuremberg paper talks of a Note presented by the Russian ambassador at Paris to the French government, upon the treatment, of Bernadotte by the latter. The Note is said to dwell upon the services rendered by him to the alliance. He joined it sincerely and honourably, and he powerfully contributed to the victory of Leipsic. To be sure he did most powerfully indeed! As all the Monarchs, continues the Note, view him as the heir to the Throne of Sweden; the Emperor of Russia requests the French government to treat the Crown Prince conformably to his dignity, and to send an ambassador to Stockholm.

It cannot be denied that this is a very politic step of the Court of Petersburgh---for if any change were to take place in Sweden unfavourable to the succession of Bernadotte, Sweden might revert to her ancient policy which bound her to France. Whereas by the succession of Bernadotte, supported so openly by the Court of Peterburgh, Sweden may become as closely connected with Russia as she formerly was with France.

This exchange will commence on or before Monday the 3d Feb. next; and all standard silver coin of the realm, however defaced or reduced in weight, by use, will be received in exchange for the new coin, by tale, as its nominal value.

CONDITION OF IRELAND.

At the interesting public meeting at Harold's Cross, Dublin, on the 15th Jan. to take into consideration the present dreadful state of the country, and the best mode of relief; Mr. Norris, Jr. in seconding the resolutions, made the following melancholy statement from the most authentic sources. "As for Ireland he thought the condition of it truly deplorable. Some people estimated the population of its capital at two hundred thousand souls. It has been lately stated in documents prepared by persons who have been employed to enquire into the condition of the poor, that there are no less than 74,000 of these, absolute beggars, and living upon the bounty of the charitable, are called the lower order. CATHOLICS.

The petition adopted at the late Catholic aggregate meeting, in Dublin, is the same which was drawn up and presented in 1812, and signed by the lords and gentlemen acceders. The following clause of domestic nomination, is the only addition :---

"In thus addressing the legislature, we are naturally desirous to conciliate all opinions, and to obviate all objections; and we entertain a conscious conviction, that all impartial opinions will be conciliated, and all rational objections to our emancipation be defeated, by the measures of domestic nomination of our bishops—a measure in which our prelates have declared their readiness to concur; and which, if introduced by the proper authority in our church, would meet with the most cordial approbation of the Catholic people of Ireland.

BOSTON, March 22.

The Caroline, arrived at Savanah, sailed from Cadiz Jan. 12. On the 6th Jan. a fleet of 40 sail of Spanish Transports, with voy of 2 frigates and 3 sloops of war, sailed for Vera Cruz, where they were to remain until the arrival of another fleet, which was to sail about the middle of February, first to stop at Havanna, and afterwards to form a junction at Vera Cruz-from whence they would proceed for the Spanish Maine. The object of this expedition was not made known at Cadiz, but was generally believed to be destined against the Patriots.

His Britannic Majesty's schr. Misloeto, of 8 guns, sunk in the late heavy gales, off Rottingcean. She had a complement of 40 picked men, commanded by Capt. Blake. Every person on board perished. Lon. P.

His Britannic Majesty's sloops Telegraph and Jasper were totally wrecked in a tremendous gale on the night of Jan. 19, near Plymouth, E. The Capt. of the Jasper and a boy happened to be on shore---the remainder of the crew (68) all perished, except one man, with several woman and children. Only one man perished on board the Telegraph.

NEW-YORK, March 24.

Extract of a letter from the Commandant of Marines at Santa Martha, to a gentleman in Nassau, dated 9th Feb. via Savannah.

" Bolivar has been entirely defeated on the river Unars, between Barcelona and Cape Codera. He has disembarked upwards of 900 men, and has lost more than 500. He was wounded, and escaped by flight with Arismendi, pursued by the cavalry. royal troops consisted of 550 men. Seven hundred muskets, a piece of cannon, and 20,000 cartridges, with balls, drums, standards, the writing desk of Bolivar, in which was his picture, and his feather, fell into our hands."

Reign of Queen ANN, Chap. 10. Sec. 29, " And for as much as the Post must necessarily " cross several Ferries in North America, in which "the Ferrymen give great delays, and sometime " have endeavored to exact money from them not-" withstanding the same have been always free for " the Post : Be it therefore enacted by the authori-" ty aforesaid, that no Deputy or Agent of such " Postmaster General travelling with any mail of "Letters shall pay anything for passing or repass-"ing any Ferry within any of the Colonies or " Plantations of Her said Majesty in North Ame-" rica aforesaid, but such Ferrymen shall forth-" with, within one half hour after demand, convey " such Deputy on pain of forfeiting for every such " offence, the sum of FIVE POUNDS, to be reco-" vered in any Court of Record within any of the " Provinces or Colonies in North America, by bill, " plaint, or information, wherein no Essoin, Pro-" tection or Wafe: of Law shall be allowed; one " moiety thereof to Her Majesty, her Heirs and "Successors towards the support of the Govern"ment of the said Provinces, and the contingent " charges thereof: and the other mojety to the " Postmaster General who shall sue and prosecute " for the same, together with full costs of Suit.

From the City Gazette, April 9. We learn from-Halifax, that the Legislature of Nova-Scotia have voted a sum of money towards defraying the expence of the continuance of a Packet across the Bay of Fundy, and it now only remains for the appropriation made in this Province, to be employed for the mutual intercourse and advantages of both.

By a vessel arrived from Moose Island this morning, we learn, that three vessels viz. the Betsy, Dudgeon; Lucy, Rogers; and American Lines, and were discharging Plaister, which was selling at Six dollars per ton. We hope the necessary steps will be taken to bring offenders to justice without delay, and thereby baffle the expectation of the American speculators of getting that article a Lubec, the Laws of the British Provinces notwithstanding.

Fire! On the 2d instant, about noon, the Dwelling House, of Mr. JARVIS, WORDEN, at the upper end of the Long Reach, was discovered to be on fire, and before timely assistance could be rendered, the whole range of buildings were razed to the ground. The fire is supposed to have originated from the roof, by some sparks falling thereupon. By this act of Providence, Travellers are deprived, for the present, of a great public accommodation, (it being one of the best houses of entertainment on the river St. John) and an industrious worthy member of the community, wrested of a great part of the fruits of many years industry.

Melancholy !--- One day last week, Mr. Robert Haggis, about 21 years of age, a native of Yorkshire, fell from the mast-head of the schooner Messenger, and was so much hurt as to occasion his death the same evening.
