Meeting of the Allied Sovereigns.

CIRCULAR.

Of the Ministers of the four Courts which had signed the Treaty of Paris of the 20th of November, 1815, expedited by order of their Sovereigns to the Ministers Plenipotentiary accredited to the different Foreign Courts, in the course of May 1818.

"SIR—The Allied Sovereigns who have signed with France the Treaty of the 20th of November, 1815, being resolved to meet in the approaching autumn, for the purpose, in conformity with the 5th Article of the said Treaty, to take into consideration in concert with his Most Christian Majesty, the internal state of France; and subsequently to determine, whether the military occupation of the frontier provinces of that kingdom might cease, or if it ought to be continued; my colleagues and myself have received the orders of our respective Cabinets, to apprise you immediately of the motives of this meeting. There exists no doubt but that the under-mentioned articles reserves to the Allied Sovereign the exclusive right of alone deciding the important question which is the subject of it. However, their Imperial and Royal Majesties, willing to avoid every unfounded interpretation that might tend to give to their meeting the character of a Congress, and to remove at the same time the intervention of other Princes and Cabinets in the discussions, the decisions of which is expressly reserved for themselves: have given their commands to the conference of Paris to make known, by the organ of the Ministers and Envoys accredited at other Courts and States, the resolution they have taken of declining every overture contrary thereto, which might be addressed to them with regard to it, and of not admitting any Plenipotentiary who might be sent to the place destined for their meeting.

"In exercising a right which is exclusively reserved to them by the Treaty of 1815, the Allied Sovereigns by no means desire to draw towards them the negotiations proceeding in Paris, London, and Frankfurt, which ought to be determined in the places where the conference had been established, and under the intervention

of all the affairs, have been invited to take a part in them.

"In consequence, Sir, I have the honour of informing you of this unanimous determination of the allied Sovereigns, that you should express yourself to the same effect every time the Government to which you are accredited should express a desire to send some person, or to take part, directly or indirectly, in the deliberations reserved exclusively for the decision of the allied Courts.

"In case circumstances should afford you an opportunity of entering into these explanations, you are requested to add to the motives of right and convenience which justify the measures now adopted, all the delicacy and respect proper for representing it in the same views and the same sentiments which have dictated it.
