A Proclamation.

THEREAS the General Assembly of this Province stands prorogued to the second Tuesday in December next; I have thought fit further to prorogue the said General Assembly, and the same is hereby prorogued to the first Tuesday in February next, then to meet at Fredericton for the dispatch of Business.

A Proclamation.

THEREAS by Act of Parliament, passed in the forty-eighth year of His present Majesty's Reign, power is given to the Governor, Lieutenant-Governor, or Commander in Chief of this Province, with the advice and consent of His Majesty's Council, to allow the importation of certain coumerated articles from the United States of America into this Province, for the purpose of re-exporting the same, I have therefore thought fit, with the advice and consent of His Majesty's Council, to publish this Proclamation, hereby authorising and empowering British Subjects, for the space of Three Months from the date hereof, to import and bring into this Province from the United States of America, in British built ships or vessels, owned and navigated according to Law, Scantling, Planks, Staves, Heading Boards, Shingles, Hoops, or Squared Timber of any sont, Bread, Biscuit, Flour, Peas, Beans, Polatoes, Whee, Rice, Oats, Barley, or Grain of any sort; and British Subjects, during the same pemod, are hereby authorised and empowered to export in British ships, owned and navigaled as aferesaid, all or any of the said herein before enumerated articles, to any other of His Majesty's Colonies of Plantations. -

Given under my Hand and Seal, at Saint John, the eleventh day of September, in the year of our Lord one thousand eight hundred and eighteen, and in the fifty-eighth year of His Majesty's Reign.

EAST INDIES.

(From the Calcutta Mirror of April 29.) We have received letters, dated camp before Chandah, 8th April, and Hingin Ghaut, some marches distant from Chandah, 10th April. The force under Colonel Scott has laid siege to the place, which is represented as strong. On coming to the ground before it, a body of 500 of the enemy made their appearance, and were immediarely pursued. They were, however, too far in advance to be overtaken, and the pursuit was relinquished. They composed the advanced guard of Bajee Row; and intelligence having reached Colonel Scott that the Peislawa himself was within six miles, and was stated to have taken post in the village, awaning Colonel Scott's appearance, his troops were put in motion. Unluekily, the intelligence proved false, the troops having advanced without seeing or hearing any thing more of the Peishwa's movements.

This rebellious Chief appears, as one of our correspondents writes, to be gified in a wonderful degree with the power of locomotion; for, says he, at one time he is close to Hussingabad, the next day he is at Chandah, at Almontee the next, at Booranpoor the next, close to Guallo the next, and I suppose you will have the pleasure of seeing him at Calcutta very shortly. in regard to the strength of his army are as various as the reports of his locality. They vary from 1000 to 160,006 fighting men, and from one to eighty guns; but one correspondent states, that according to the accounts most credited in the camp, he is accompanied by about 30,000 men, and 30 guns.

The force before Chandah is said to consist of the Madras troops under Colonel, Scott, with the 6th and a squadron of the 8th Bengal Infantry. That under Colonel Adams consists of the 5th cavalry, two grenadier companies of the 2d battalion of the 10th, six companies of the 1st battalion of the 19th, and five companies of the light battalion - a force, we are persuaded, sufficiently strong to chastise the Peishwa, should they have the good fortune to overtake him.

Our letters from Colonel Adams's camp mention, that it was thought the troops under Colonel Scott would join the Hussingabad force. The letters from Chandah state, that at present the two forces were only 20.

miles apart.

Chandah is said to be a very strong place, and a large populous town. It is surrounded by two walls, and defended by sixty-five guns, with a fort in the middle. It is said that a large quantity of treasure is lodged in it, which we hope will soon reward the brave. On approaching it, Col. Scott's force was fired upon. It is conjectured at the camp before Chandah, that the Peishwa had proceeded to the north-west, and of course his object is to join Scindiah.

In the mean time, it is said that effectual measures have been adopted by his Excellency the Marquis of Hastings to ensure the tranquillity and submission of the newlyconquered provinces. Major General Sir David Ochterlony is understood to have been invested with high powers by the Governor-General, and the head-quarters of this gallant officer will, it is said, be fixed somewhere in the centre of Rajpoortana. We trust we may therefore augur most favourably for the future, and calculate on that part of India enjoying a state of peace and prosperity to which it has been a stranger.

IMPROVED BREED OF CATTLE.

From the Portland Gazette of September 29. We understand the extraordinary Westbrook Cattle are now on their way to Brighton, where they will be exhibited at the ensuing cattle show. The stock now consists of a cow, two heifers and two bulls. One of the heifers, two years and five months old; weighs 1821 pounds, and girts seven feet and three inches; the other heifer, fifteen months old, weighs 1192 pounds, and girts six feet and four inches, The young bull, two months and three days old, weighs 330 pounds, and girts four feet and one inch. They are not more remarkable for their size than handsome formand other good qualities. -We sincerely hope our enterprizing farmers will avail themselves of the present opportunity of viewing these wonderful animals, as they pass through their several towns. that they may be convinced of the very important advantages that may be derived from a good breed of caule. We are assured that these cattle have had no extraordinary feeding to make them attain their present size-the average increase weight of the young bull is nearly three pounds and seven ounces per day, and has been fed with nothing but the milk which he has sucked from the cow.

Duting the first month, the cow gave from six to eight quarts of milk per day more. than the calf would suck. These cattle appear to form a class of an entire new breed, produced by crossing the breeds of the best cattle that could be obtained from Europe, and shews the important advantages to be derived from crossing the bread of imported cattle, which appear to improve wonderful ly in this country-more especially in the
