The Deputies replied, that they had much declined since France and Italy were shut against them.—As for Italy," replied the Emperor, "I did it, but then it is my duty to take care of the interest of my people. It were to be wished that there were Treaties of Commerce between all Nations, and I am well inclined to conclude such."

FREDERICTON, (N. B.)

22D DECEMBER, 1818.

On Friday morning last this town was alarmed by the cry of *Fire!* which was found to issue from a dwelling-house, the property of the Miss ALLENS, and occupied by them. The engines were immediately drawn to the scene of destruction, and every effort was made by the inhabitants and military to extinguish the flames, but to no effect. In the space of two hours the building was razed to the ground: several articles of furniture, together with beds and bedding, were consumed. The fire originated in the upper part of the building, (occasioned, we understand, by the parting of a stove-pipe which run through the garret) and had got to a considerable height before it was discovered. The house was situate in the upper part of the Town, and no buildings near it, except the barn, which, by great exertion, was prevented from receiving the slightest injury.

London papers have been received in New-York to the 22d October, which state, that "Her MAJESTY was still alive; but no hopes were entertained of her recovery."

Prince Leopold arrived at Lausanne on the 30th October, whence he continued his route for Berne, where he will visit his sister, the Grand Duchess Constantine of Russia.

Captain Barrie has been appointed to the command on the Lakes of Canada, in place of Sir Robert Hall, lately deceased.

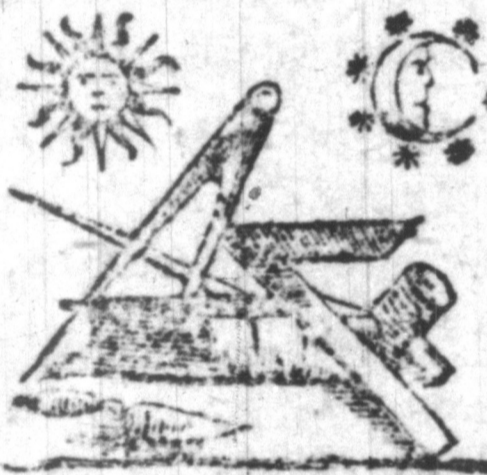
