G. S. SMYTH A Proclemation.

HERE AS by Act of Parliament, passed in the forty-eighth year of His present Majesty's Reign, power is given to the Governor, Lieutenant-Governor, or Commander in Chief of this Province, with the advice and consent of His Majesty's Council, to allow the importation of certain enumerated articles from the United States of America into this Province, for the purpose of re-exporting the same, I have therefore thought fit, with the advice and consent of His Majesty's Council, to publish this Proclamation, hereby authorising and empowering British Subjects, for the space of Three Months from the date hereof, to import and bring into this Proviuce from the United States of America, in British built ships or vessels, owned and navigated according to Law, Scantling, Planks, Staves, Heading-Boards, Shingles, Hoops, or Squared Timber of any sort, Bread, Bisci ii, Flour, Peas, Beans, Potatoes, Wheat, Rice, Oats, Barley, or Grain of any sort; an I British Subjects, during the same perio d, are hereby authorised and empowered to e xport in British ships, owned and navigates I as aforesaid all or any of the said herein be fore enumerated articles, to any other of His Majesty's Colonies or Plantations.

POLICE INTELLIGENCE.

MANSION-HOUSE.

An Odd Scene. - The Lord Mayor, in the course of his business, was interrupted by a sarlor, a showman, and a monkey, who arrived at the Justice-room, with a great multuode behind ibem:

The monkey was making a most hideous noise, and the sailor and showman, who had been arguing on their way to the Mansion-House, were so completely absorbed in the subject of dispute, as not to take notice, for some time, of the authority presiding. The monkey, however, was more respectful in his manners, and seemed to have a due impression of the dignity of the Magistrate before whom he was brought.

His Lordship having noticed the respectful demeanor of the monkey, called upon the sailor and showman to follow the example of the animal, who at that moment began to exhibit some of his most amusing trickssuch as pulling the showman's nose, untying his cravat, dragging open his waistcoat, &c.

The Lord Mayor desired that if there was any complaint to be made it should be proceeded upon. The sailor said he and the monkey were the injured party; the showman was the aggressor.

His Lordship seemed to think that the monkey could be as well able to explain the motter as either of his companious, and this

conclusion appeared to be just, for while the features of the men were agitated with passion, the monkey's was as grave as those of a philosopher.

The monkey kept his eye fixed upon the Lord Mayor, and at the conclusion of every sentence from his Lordship, uttered a pier-

cing cry. The sailor at length made his complaint. He stated that he went into Gilman and Arkin's exhibition of wild beasts in Bartholomew Fair, and while he was looking at the curiosities he recognised the monkey, which was now before his Lordship, to be his own property. He had purchased it for four or five dollars at St. Kitt's, some months agos and upon his arrival in this country, he had lost it at Portsmouth. Upon entering the show he immediately told the keeper that it was his monkey, and have it he would. The keeper refused to give up, and declared that his master had bought it fairly for one pound.

The showman here got into a high passion with the monkey, who had seized him with such violence by the nose as to make him roar out. The animal growing more and more averse to the controll of the keeper, held his paws out to the sailor, and moaned

pueously.

The Lord Mayor said, the only way for him to decide upon a case, in which there was positive assertions on both sides, was to leave the matter to the monkey himself. His Lordship then directed that the monkey. should be placed upon the table, and that each party claiming him should use his powers of fascination, in order to ascertain to whom the monkey was most attached.

The monkey was put upon the table, but narrowly escaped death, from an attack made upon him by a dog, a constant visitor at the Mansion House. Having escaped this danger, the Lord Mayor marked the effect of so important an adventure, and seeing that the monkey fled to the arms of the sailor (who showed most concern) for protection, and that the animal throughout had evinced towards him the greatest attachment, he thought he was the rightful owner. The desired experiment, however, was now made, and the showman put a piece of stick into the monkey's paw, and desired him to shoulder arms. Instead of obeying this order, the monkey struck the keeper on the head; and then threw it in his face.

The sailor next called upon the animal, saying, Jack, " look sharp, and make a salam to his Lordship." The monkey in-Statilly stood erece en wis tri & his paws to the top of his head, and made a low bow to the Lord Mayor in the Turkish style. He then hugged and fawned upon the sailor as before.

" If any thing else is necessary," said the sailor, " to prove him mine, I can shew There is a hole in one of his ears which I bored in St. Kill's, for it is fashionable for the bucks to wear an ear-ring there. His left paw is marked by a fishing-hook, and part of his tail is bitten by a parrot that used to quarrel with him." These marks were observed.

The Lord Mayor advised the showman to give up all claim to the monkey, but he refused. The sailor refused to part with the monkey, and the monkey would not part with him. The disputants at length left the Office, the mankey clinging to the neck of he sail , in the most affectionate manner
