Apprehensions having been justly felt for the safety of two London ships bound here, via Halifax, with the general fall supply of Goods, it is with pleasure we are enabled to state the arrival of one of them (the Castle-rough) at Halifax, on the 13th instant, after a passage of 91 days from the Downs. We regret to say that no tidings have yet been received of the other expected ship, (the Earl Fitzwilliam) which sailed prior to the 1st September.

It may be of moment to many Persons in trade at this place, from whence large amounts of smoked Fish, Grindstones, and other Merchandize, liable to *ad valorem* Duties, are constantly shipped to the United States, to be reminded that by an Act of Congress, of 20th April, taking effect the end of October last, it is provided, that "All Goods from a foreign Country, imported into the United States, that pay *ad valorem* Duties, must be accompanied by an Invoice attested by the Shipper before the American Consul, (where there is one,) or a Notary Public, otherwise the Goods will be sent to the Public Store and there appraised."

RICHMOND, (VA.) DEC. 8. INTERESTING.

To the Editor—(received last night)—From a Correspondent in Washington, Dec. 6.

It is stated with great probability of truth, that the long contested question between this country and Great Britain, relative to the improvement of seamen, has been finally adjusted. The law of the United States in regard to seamen being the basis of arrangement—whose provisions no doubt are familiar to you. This event derives a particular interest from its immediately ensuing the war, of which it is no doubt a consequence. However it may in part be properly ascribed to the sentiments now avowed by Great Britain towards the United States, which are of the most friendly kind.

It has been proposed to refer the documents respecting the trial and execution of Arbutnot and Ambrister, to the committee on Foreign Relations; but some members consider the subject as already before that committee; and the proposition was postponed indefinitely.

The National Intelligencer expresses some doubts respecting the validity of the trial, and some regret at the precipitate execution of Mr. Arbutnot and Mr. Ambrister by Gen. Jackson. Those editors very properly wish, that as the prisoners could not have escaped, the order for their execution had been suspended, until the will of the President could have been known.

TREATY WITH ENGLAND.

We are happy to announce to our readers the intelligence which has been received since our last paper, of the signature of a Treaty in London embracing all points of controversy between the United States and Great-Britain. The American Ministers Plenipotentiary to the Courts of London and Paris respectively, Mr. Rush and Mr. Gallatin, signed it on the part of the United States, and Messrs. Goulbourn and Robinson on the part of Great-Britain. The negotiation had reference to further regulating that portion of our commerce provided for in the convention which will expire in July next, the general trade of the two countries and every other interest and unsettled point between them, particularly the question relating to the improvement of seamen—to the fisheries and boundaries. The Treaty has not yet arrived in this country, and therefore the provisions which it contains will not probably come to our knowledge for some time; at any rate we are assured by the National Intelligencer, it is not a mere prolongation of the Convention of 1815, as had been supposed.

If the Instrument contains satisfactory stipulations made in the space of only two months upon all subjects of difference heretofore existing between the two nations, and which have kindled the flames of war between them—it will place the United States upon higher ground than they have ever yet reached. It will place our commerce upon a permanent basis—and for a long period yet to come will secure a good understanding between Great-Britain and America.

SENATE.

To the Senate of the United States. In compliance with a resolution of the Senate of the 25th of last month, requesting to be furnished with such information as may be possessed by the Executive, touching the execution of so much of the first article of the late Treaty of Peace and Amity between his Britannic Majesty and the United States, as relates to the restitution of Slaves, and which has not heretofore been communicated. I lay before the Senate a Report made by the Secretary of State, on the 1st. inst. in relation to that subject.

The Secretary of State, to whom has been referred the resolution of the Senate, on the 25th ultimo, requesting information not heretofore communicated, relating to the restitution of slaves, conformably to the first article of the late Treaty of Peace between

the United States and Great Britain, has the honor of reporting to the President of the United States, that the difference of construction given by the two Governments to that part of the first article of the Treaty, and the claim of the citizens of the United States to indemnity for Slaves carried away contrary to its stipulations, from one of the subjects of negotiation now pending in England; which negotiation having commenced towards the close of the month of August, no report of its progress has yet been received at this department, from the Plenipotentiaries, to whom on the part of the U. S. it has been committed.

FROM SOUTH AMERICA.

Captain Bourne, of the brig *Hippomenes*, who arrived this morning in 19 days from Curraoco, informs us, that the brig *George Washington*, Capt. Prait, from Margarita, has been captured, and the cargo condemned. He reports, that Lord Cochrane arrived on the 12th November, at the Testigos, with one ship of 64 guns, one of 32, 2 of 20 guns each, and a tender of 10 guns. He also reports that Sir Gregor M'Gregor sailed about the same time with three thousand men to join Gen. Bolivar.—In consequence of this news there was great rejoicing at Margarita. Admiral Brion, with a considerable force, was at Margarita, and was making preparations to attack Cumana.
