

PRINCE EDWARD ISLAND.

The following extracts will shew the grounds of the misunderstanding which recently took place between Governor Smith and the House of Assembly in Prince Edward Island.

From the Address of the House to His Excellency.

NOVEMBER 5.

"We are particularly thankful to your Excellency, for the expression of your readiness to co-operate with us in measures for the advancement of the welfare of this Island; and we assure your Excellency, that nothing shall be wanting on our parts, to effect such measures as may conduce to that end, without suffering our deliberations to be retarded either by party spirit or personal animosity, of which your Excellency appears to be apprehensive. The gracious bounty of his Royal Highness the Prince Regent, and his determination to reduce the Quit Rents exigible in this Island, has been received with such sentiments by all ranks of Proprietors here, that while it has enhanced their gratitude has more firmly cemented their attachment to the Person and Government of our beloved and most gracious Sovereign; at the same time we regret that it becomes our duty to state to your Excellency that the measures which were adopted here during the last winter to enforce payment of his Majesty's Quit Rents upon the original or old Scale, have produced the most distressing effects, particularly upon the lowest classes of the community, arising chiefly from the ruinous costs and expenses thereby incurred, when it appeared to the Inhabitants of this Colony by your Excellency's Proclamation dated 1st October, 1816, that there was to be "a fixed Scale" and a new rate of Quit Rent to commence.

"We thank your Excellency for ordering the Public Accounts to be prepared and laid before us, to which we shall pay all due attention, and hope that this Branch of the Legislature will at no distant period, in common with our neighbouring Colonies, have a Constitutional controlling power over at least part of the public Monies of this Island.

"We are so truly sensible of the want of good Roads that we shall heartily do all in our power for their improvement, and deeply lament that the efforts of two branches of the Legislature, during the last Session of the General Assembly, held in this Island, failed in meeting with your Excellency's concurrence, when they presented a Bill grounded as we understand on an Act now and for many years in force in the Province of Nova Scotia, which has rendered the Roads excellent throughout that Province, and which Bill, besides affording us Goals in two of our Counties, would have highly improved the Roads in the third.

"The Inhabitants of this Island, are infinitely indebted to Providence for conferring upon them the blessing of an abundant crop this season, and we hope, that with honesty, frugality and industry, it will be acknowledged by them with gratitude to that Supreme Being from whom all blessings flow.

"We are happy to learn from your Excellency that the very important object of Printing the Laws of this Island, has been accomplished, and we are confident that the benefits resulting therefrom will be generally felt.

"We also return your Excellency our sincere thanks for your determination to meet such Bills as many be laid before you during this Session with very calm consideration, pure constitutional principles, and an earnest to do good, and hinder evil, as we are convinced such disposition in your Excellency, will best accord with the genuine principles of our incomparable Constitution.

A Message from His Excellency the Lt.

Governor by Mr. Carmichael, Private Secretary, viz.

"Desirous as the Lt. Governor is at all times to put the best and most favourable construction upon every action of the House of Assembly, he nevertheless from a sense of propriety, feels compelled to decline receiving the Address from them, intended to be presented this day, on the ground of its containing unconstitutional animadversion, he therefore regrets that the appointment for two o'clock of this day must stand annulled.

To the Speaker.

On motion of Mr. Townsend, seconded by Mr. M'Neil, ordered, that a Committee be appointed to prepare an Address to his Excellency upon the subject of his Message of yesterday, stating the substance of the Resolution of the House upon that Message, and praying to know when he would be pleased to receive the Address of this House in answer to his Excellency's Speech, delivered at the opening of this new Assembly, and that, Mr. Townsend, Mr. Worrell, and Mr. Solicitor General, be accordingly appointed to draw up the same.

Mr. Townsend Chairman of the Committee, appointed to draw up an Address to his Excellency, upon the subject of his Message of yesterday, reported, that the Committee had drawn up an Address accordingly, which they had directed him to present to the House; and he read the same in his place, and afterwards delivered it in at the Clerk's Table, where the same was read, and is as followeth, viz:--

To His Excellency Charles Douglass Smith, &c. &c. &c.

May it please your Excellency,

"WE, the House of Representatives, in General Assembly convened, desirous of maintaining the most perfect cordiality of sentiment and good understanding with your Excellency, and equally anxious that all our proceedings should be conducted with strict Parliamentary correctness, and be couched in proper, respectful, and constitutional language, have with those views, taken your Excellency's Message of yesterday into our most serious consideration; the result of which is, that we cannot find that the intended Address to your Excellency, referred to in that Message, contains any unconstitutional animadversions whatever: We, therefore, beg leave to request, that your Excellency will be pleased to inform us, when your Excellency will receive the Address of this House, in answer to your Excellency's Speech, at the opening of this Assembly.

Assembly-Room, Nov. 7th, 1818. Ordered, that Mr. Townsend, Mr. Worrell, and Mr. Solicitor-General, do wait upon his Excellency with the foregoing Address.

The Committee appointed to wait on his Excellency with the Address of the House, in answer to his Excellency's Message of yesterday, having waited accordingly, returned, and reported, That his Excellency was pleased to say that the House would, on Monday next, receive a communication through their Speaker, in reply to their Address.

MONDAY, Nov. 9.

A Message from his Excellency the Lt. Governor, as followeth, viz:--

Charles Douglass Smith Lt. Govr.

"The Lieut. Governor, in reply to a communication presented on Saturday the 7th inst. from the House of Assembly, laments they should have thought proper again to press the reception of the Address, which he had given so definitive a reply upon. Did the objection to receiving it arise out of personal feeling alone; he would have a pleasure, and even a pride in sacrificing it to maintain political union; but the question is far different, involving a constitutional principle of the first importance, and therefore a point that cannot possibly be conceded.

"The Lt. Governor trusts this matter will not interrupt the harmony he so much desires, and repeats to the House the assurance of his unaltered, and unalterable disposition, to co-operate with them in measures for the public welfare.
