A Proclamation.

ATHEREAS by Act of Parliament passed in the Forty-eighth year of His present Majesty's Reign, Power is given to the Governor, Lieutenant-Governor, or Commander in Chief of this Province. with the advice and consent of His Majesty's Council, to allow the importation of certain enumerated articles from the United States of America into this Province, for the purpose of re-exporting the same -- I have therefore thought fir with the advice and consent of His Majesty's Council to publish this Proclamation, hereby authorising and empowering British Subjects for the space of Six months from the date hereof, to import and bring into this Province from the United States of America, in British built ships or vessels owned and navigated according to Law; Scantling, Plank, Staves, Heading-Boards, Shingles, Hoops, or Squared Timber of any sort; Horses, Neat Cattle, She p, Hogs, Poultry, or Live Stock of any sort; Bread, Biscuit, Flour, Peas, Beans, Potatoes, Wheat. Rice, Oats, Barley or Grain of any sort; and British Subjects during the same period, are hereby authorized and empowered to export in British ships owned and navigated as aforesaid, all or any of the said herein before enumerated articles, to any other of His Majesty's Colonies or Plantations.

THEREAS it has been represent-Regulations lately published respecting the dingly. cutting of Pine Timber, sundry Persons are now engaged in cutting Timber on Lands expressly reserved for His Majesty's use, pretending to have permission under Licences which are no longer in force:---These are, therefore, to require all such Persons immediately to desist from cutting Timber, or in any way trespassing upon Lands reserved for the King's use, in any part of this Province; and any person who shall be found so trespassing, after the date hereof, will be forthwith prosecuted.

THEREAS by an ACT of the General Assembly of this Province, made and passed on the eleventh day of March last, the Lieutenant Governor of Commander in Chief of this Province for the time being is authorized and empowered; "whensoever it shall appear and be made "known to him, that an ACT made and passed in the Province of Nova-Scotia, " for the encouragement of the Trade of that " Province in PLASTER of BARIS o-"therwise called GYPSUM, shall have ceased to operate and shall be no longer in " force in that Province," by and with the advice and consent of His MAJESTY'S Council by Public Proclamation to suspend the further operation and execution of the Act made and passed in the fifty-sixth year of His MAJESTY's Reign, intituled " An "ACT for the encouragement of the Trade of this Province in PLASTER of PA-RIS otherwise called GYPSUM," un til His MAJESTY'S Royal Pleasure shall be signified respecting the same .---

And whereas it does appear and has been made known to me, that the said ACT of Nova-Scotia above mentioned, has been repealed, and is no longer in force in that Province; I DO THEREFORE, by and with the advice and consent of His Majes TY's Council, hereby suspend the further operation and execution of the said ACT made and passed in the Fifty-sixth year of His MAJESTY's Reign, intituled, " an " ACT for the encouragement of the Trade " of this Province in PLASTER of PA "RIS, otherwise called GYPSUM," until His MAJESTY'S Royal Pleasure shall be signified respecting the same---whereof all persons whom it may concern, will take ed to me that, notwithstanding the due notice, and govern themselves accor

Regulations respecting the granting of Licences to cut Pine Timber.

TO Licence to be granted to cut Timber on Land reserved for the use of the Crown.

LICENCES to be granted only to British subjects, with condition to be forfeited if assigned to Aliens, and every Lin of this Province stands prorogued cence to specify the quantity to be cut, and to be limited as to time; and no Timber he for the Navy to be permitted to be cut for private use.

> No. Licence to be granted to cut Timber on Lands for which application has been made for Grants, and every applicant for a Licence, to describe particularly the Land on which he wishes to cut, and the quantity of Timber, and accompany his application with a Certificate, that the Land has not been applied for to be granted.

ALL applications for Licences to be handed in the first place to the Deputy Surveyor of the Woods, who, if he thinks fit to recommend the application, will lodge it in the Secretary's Office, to be laid, in the usual manner, before a Committee of His Majesty's Council for consideration; and any three Members of the Council to be a Committee for the purpose of consucring the applications in question,

And Applicants for Licences are further notified that the FEES to be demanded by the Surveyors of the Woods, are now fixed at twenty shillings for each Licence, and that no other Fee or Emolument is to be demanded or taken excepting the usual Fees in the other Departments through which the application for a Licence must pass.
