Communication from the Duke of Clarence. Lord CASTELREAGH rose and said, that in moving the Order of the Day for the House again resolving itself into a Committo on the Message of the Prince Regent,

Before the Report of the Committee of last night was brought up he wished to state to the House, that after what had passed yesterday --- after the vote on the proposition which he felt it his duty to submit to the Committee -- a proposition founded on a patient and minute investigation by those who were best quali-House. But after full consideration of the faithless chieftains. subject, his Royal Highness had instructed him to submit to the House the view which his Royal Highness was disposed to take of the opinion of the House---for he must consider the opinion of the Committee to be the opinion of the House. His Royal Highness felt, that as the acceptance of any provision by the House must be necessarily accompanied by an increase of establishment, on his part, such an increase of establishment could not be made by him out of the provision which the House was disposed to grant, without incuring embarrasments which it must be the very end and object of such provisions to obviate. Under all these circumstances (continued the Noble Lord,) and with these feelings and no other, his Royal Highness has authorised me to declare, that with much deference to the judgement of the House, as testified by the vote of last night, his Royal Highness feels himself obliged to decline availing himself of the provision intended for him by this House .- (This intimation was received with loud cries of hear, hear, from all parts of the House.) He, (Lord Castlereagh) thought it would be convenient for the. House to have this communication delivered at the present stage of the business, as it would assist the House in disposing of the Report; for he must add, that it was not intended to take any additional step in it, as the object for which it was proposed was now to be considered as abandoned. He should now, therefore, propose to proceed to the Order of the Day for the Committee on the Message.

Here there was a loud call from the Opposition to proceed to the Report.

Lord CASTLEREAGH said he meant now to propose the Committee.

The Order of the Day for the Commitbeen read, on the motion of Lord CASTLE-REAGH the House resolved itself into the Committee.

Lord Castlereagh then, after some intraductory observations, moved, that an additial yearly sum of £6000 be granted, to make a suitable provison for His Royal Highness the Duke of Cambridge on his marriage; it was carried by a majority of

She had been due some days, and her arrival without letters created a considerable degree of disappointment to the merchants in the City Just after her departure from the Brazils, she fell in with two Insurgent privateers, by whom she was immediately attacked. The Captain, after maintaining a very unequal contest with them for a considerable time, endeavoured to get away, but could not effect his purpose, they having the wind of him. Finding it impossible any any longer to maintain the combat, he was compelled, before they boarded him, to sink the Mail. The privateers kept possession of him for some time; and he states further, that they even held a consultation whether they should sink the packet, crew, and all. He, however, succeeded in dissuading them from this nefarious purpose, and they left him after plundering every thing they could find. The privateers first advanced upon him under Spanish colours, which enabled them to near him, and prevented his making any advantage of the fleetness of his vessel.
