FREE PORT ACT. [MAY 8, 1818.]

THEREAS, by an Act passed in the 47th year of his Majesty's Reign, intituled, " An Act for permitting until the 25th day of March, 1809, and from thence to the end of the next Session of Parliament, the importation of certain enumerated Articles into the British Colonies on the Continent of North America, from the United States of America, and the exportation of other enumerated Articles from the same Colonies to the said States ;" which said Act was continued and extended by an Act, passed in the 49th year of His Majesty's Reign, intituled, " An Act to autherise His Majesty to permit, until the 25th

to the subjects of any Soy. or State in amity with his Majesty, to export from the said Ports, so to be appointed for that purpose, Gypsuli, Grindstones, or other produce or manufacture of the said Provinces, and also, any produce or manufacture of the U. Kingdom, or of His Majesty's Colonies on Plantations in the West-Indies, or any Goods whatever, which shall have been legally imported into the said Provinces, any thing in any Law to the contrary notwith-

V. PROVIDED always, and be it further enacted, that none of the aforesaid Articles shall be exported from the said ports, so to be appointed, to any Foreign country. or place in any Foreign vessel, unless such Foreign vessel shall belong to the country to which the said articles shall be exported. VI. And be it further enacted, That it shall and may be lawful for His Majesty, by and with the advice of his Privy Council, to make such rules and regulations for the Importation and Exportation of Goods * and Commodities as aforesaid, at the said ports, with such penalties and forfeitures for the breach thereof, as shall seem fit and necessary to his Majesty, by and with the advice aforesaid.

VII. And be it further enacted, That this Act shall continue in force during the space of three years from and after the passing of the same; and until six weeks after the commencement of the then next Session of Parliament.
