

FREDERICTON, 25th Dec. 1819.

AT a MEETING of the MEMBERS of the Society for Promoting Christian Knowledge, residing within the Parish of Fredericton, in the County of York, in the Province of New-Brunswick, (being a part of the Diocese of Nova Scotia,) The Hon. JOHN MURRAY BLISS in the Chair:

The Society's statement of the objects of District Committees being read, and the sanction of the Right Reverend the Bishop of NOVA-SCOTIA having been heretofore obtained, and under that sanction a District Committee formed, (although rather imperfectly,) Resolved, that the said Committee be now established for Fredericton and its Vicinity, to be called the Fredericton District Committee, in conformity with the Rules and Orders of the Society, and to be in future under the following local REGULATIONS.

If it be at any time deemed expedient to open the Committee,

That this Committee be open, as permitted by the Rule of the Society, No. IV, only to persons who subscribe at least Half a Guinea annually, to the use of the District, and

That this Committee do meet at the County Hall, in Fredericton, on the first Monday in the Months of January, April, July, and October:

That the Chair be taken at 12 o'clock precisely; but that if four Members be not then present, the Committee do adjourn, and notice be sent to the several Members of an adjourned Meeting to be held within eight days:

That at the first General Meeting in each Year, a President be nominated, whose office shall continue for the ensuing Year; and that at the same time a Vice-President, a Treasurer, and Secretary, be nominated for the same period; and in case of any vacancy happening within the Year, the same shall be supplied at the next Quarterly or Special Meeting, notice of such vacancy being previously given:

That the President, or Vice-President, or Members of the Committee, have power to call a Special Meeting, giving at least eight days notice of such Meeting, and of the object of it:

That the accounts of the Treasurer and Secretary be open to inspection at all General Meetings, and be audited annually at the Quarterly Meeting in January:

That a local Depository of Books for the supply of the District and of the Members of the Society, be formed at Fredericton, under the direction of the Committee:

That the Books be placed under the care of Mr. Jeddiah Slason, who shall, without reference to the Committee, comply with the request of any Member of the Society, for Books, under the restrictions prescribed by the General Rule, No. XV, and report the same at the next General Meeting:

That an account of the state of the local Depository be regularly kept, and be laid before the Committee at every General Meeting.

Resolved, that the Honorable Thomas Wilmore be requested to accept the office of President; the Honorable J. M. Bliss, Vice-President; Mr. Jeddiah Slason, Treasurer; Reverend James Milne, Secretary.—And that the same persons continue in office until the General Meeting in January, 1820.

Resolved further, that this Committee do meet on the first Monday in next Month. JAMES MILNE, Secretary.

Resolved further, that the Reverend Mr. Somerville be requested to solicit Subscriptions and Contributions in aid of this Committee, within the limits of the vacant Parishes he is appointed to visit.

LONDON, DECEMBER 3.

There are, it seems, forty frigates now upon the stocks, or ordered to be laid down. May it be hoped, that the American scale will be considered in the structure of every one of them? Some of the most painful of our historical recollections are those, which place before us the unequal contests of British with American frigates. There had been means enough, even before this late war, to know the force of the latter, for nothing is more public than ship building; it must be carried on close to navigable channels; and the eye of every seaman readily compares the length and breadth of one ship with another. Yet, with all this opportunity for preparation, not a single frigate existed in our navy equal to the American rate. Surely this will not be the case hereafter. The subject should, however, be mentioned in Parliament, and the money refused unless the frigates are built upon proper scales. A delicate confidence is more tolerable in any matter than in this.

DECEMBER 12.

The Paris papers mention, that his Majesty, on Saturday last, accepted the resignation of Count Corvetto, Minister of Finances; and that M. Roy, Minister of the Chamber of Deputies, has been appointed his successor.

The private letters from Paris speak well of Mr. Roy's character. As a politician, he classes with the temperate friends of constitutional liberty. He is said to be a man of independent fortune, of a firm and upright mind, with a competent knowledge of financial affairs, and a disposition to practise the most rigorous economy of the public money. The merchants and capitalists of France appear to be gratified by this appointment. But, in fact, the state of the funds was, such as to render some change in the administration of the finances a matter of expediency; and the public feeling was so strong upon the subject, that the Ministers could scarcely have made a choice which, on comparison, would not have been considered a good one. The five per cents on Tuesday last, was 68f. 50c.
