The unexpected and truly melancholy death of our illustrious Governor in Chief. will be known at Halifax, before this letter gets to hand, and the circumstances attending it will probably be detailed in the Newspapers; you will find them of the most afflicting kind, as there can be no doubt that he died of that most horrid of all complaints, the Hydrophobia. It is some time since he went to explore the upper Province, the remotest settlements of which he visited, and the most beneficial results were anticipated from the local knowledge he had acquired, and the plans which he had projected. All his family had assembled here to meet him on his neturn, which had been fixed for Saturday the 23d. A Levee and Drawing Room had been announced for Monday, and on the following evening, the Citizens were to give a Ball and Supper to Lady Mary .---Races were fixed for Monday and the following days. On Saturday and Sunday no intelligence having reached us, Lady Many became very anxious, knowing her father's persevering character, and that he never failed, when he had appointed a day; but it was not until the Monday morning, when an express arrived, that the Duke's illness was known, and to some it must have been then known that he could not recover; but in general it was supposed to be a temporary indisposition arising from fatigue in travelling through a new country; the next morning, however, universal dejection prevailed: his remains had arrived during the night at La Chine, and were brought to town: his death having occurred at Richmond on the Saturday preceding. Steam Boat Malsham was immediately prepared, and after securing the body in a leaden coffin, at neven o'clock in the evening, the procession moved from the Government House to the Boat : the Garrison was under arms, and formed the sides of the procession, preceded by the music of the 37th regiment. Upwards of 10,000 inhabitagets followed, and the whole was solemn and impressive; the Boat soon after got under way, and proceeded down the River for Quebec. Several reports were in circulation respecting the origin of his disease, but it is now ascertained, that on his way up, while at William Henry! (where he staid a few days) a tame Fox, which had been much worried by the dogs, had birten the Duke in his attempt to soothe it. The first symptom of the disease appeared on the Monday preceding his death while at dinner; he wished to drink wine with one of the party, he found he could not drink, and that there was something offensive in the smell of the wine; he, however, continued at table, and observed that he would be better before they rose from it. He continued his route, but the symptoms became stronger as he proceeded; all this time he made every exertion that the human mind is capable of, to struggle against the disease, and though filled with horror at the sight of the water, he resolutely stepped into the Canoe; but there he could not long remain, his agony was too great, they approached the land, and he darted into the woods, where he could no longer see the water: he insisted upon proceeding by land, and, as he went on, every appearance of water on the road, threw him into agony. On Friday he suddenly came in sight of the river, it was too much for him, and he darted away till he gained a barn, where he threw himself down, and remained in great torture for some time, when his suite succeeded in removing him to a house, where he died the following morning. He, during his locid intervals, declared his conviction he could not recover, desired he might be buried at Quebec, and gave directions upon some public measures. The scene at the Mansion House where his Daughters staid, can be more easily imagined than expressed, when those affectionate Girls heard the fate of their fond and indulgent Father :-- In him they have lost all but the consolations of religion."-- Halefax Royal Gazette.

Resolved That it is the opinion of this meeting, that the most eligible method of assisting needy Emigrants, who cannot go upon lands to be allotted to them by Government, during the ensuing winter, will be to take measures without delay, to have them hutted on some of the uncultivated lands in the neighbourhood of the City, where they may be enabled to provide their own fuel, and, if necessary, may be occasionally assisted with provisions—Some of the proprietors of these lands being present at the meeting, and giving their consent to any Emigrants being hutted on their lands, and supplying themselves with fuel for the winter, and taking a crop the ensuing season, from any land they may clear, gratis.

Resolved, That this Meeting be adjourned to Monday next, at 12 o'clock, at the City Hall, when all Persons friendly to the objects of the Meeting, are earnestly requested to attend, for the purpose of choosing a Committee of management, and making any modifications or alterations in the proposed plan that may be deemed expedi-
