November: I have thought fit by and with the advice of His Majesty's Council, to prorogue the said General Assembly: and the same is hereby prorogued to the third Tuesday in January next ensuing, then to meet at Fredericton for the dispatch of Business.

LONDON, Oct. 2.

The health of her Royal Highness the Duchess of Clarence is very much improved since her arrival at Dover Castle. They intend continuing their residence at this place for some weeks longer. Her Royal Highness did not suffer, as was reported, by her late indisposition, so as to remove the hopes, that at no distant period she may give an heir to the British Throne.

OCTOBER 6.

A serious quarrel is said to have arisen out of the Carlsbad conferences between the King of Bavaria and the Elector of Hesse; the former having obtained at Carlsbad the cession of Hanau, and the latter declaring that he will not give up a single village of his territory. It is added, that in conse quence of this difference, troops were marching on both sides.

OCTOBER 8.

The man interesting article of foreign news is the result of the conferences at Carisbad, which has been published in the shape of a series of proportions by the Austrian minister; all these propositions have been adopted by the assembled ministers of the German States.

The election of the Lord Mayor has terminated in a way which illustrates in a very striking manner the diversity of feeling between the members of the Livery and the persons who composed the late Common Halls. Alderman Bridges, who, from the beginning to the end of the election, would not be suffered to address a single sentence to the assembly in Guildhall, was on Wednesday returned by a majority of 1033 over his competitor Alderman Wood.

The Wardmote of the Householders of Cheap has been the first assembly to reject the violent resolutions against the magistrates and yeomanry of Manchester, which have been so industriouly offered to all the public meetings that could be collected throughout the empire. It is not necessary to assign any auxiliary metive for so plain a duty as this refusal. But it is worthy of observation that this is the first assemble which has tolerated a defence of the Manchester gen tlemen. This example has been followed by Westminster. The panish of St. Martin in the Fields has avowed in a public de claration, its abhorrence of the violence and ciamour used to overturn the constitution, and to annihilate the cheering hopes held out by our pure religion to the humble believer. Other parishes will no doubt follow

this patriotic example. The assemblies of the Reformers follow each other in a rapid succession, and take care to report their important proceedings with a prolix minuteness which bids defiance to the limits of a weekly paper; but this like most other inconveniences creates its own remedy; and as the meetings grow frequent, they become monotonous, their

interest grows stale, and their reports tedious. The Committee of 200 are again at work .- We have learnt that they are privately circulating the following hand-bill.-SMITHFIELD THIRD MEETING
