G. S. SMYTH. A Proclamation.

HEREAS it appears to me by the statement of the Receiver Geof His Majesty's Casual Revenue in his Province, that no monies have come to his hands for Fines and Forfeitures incurred, and other dues belonging to His Malesty within the same :

I have therefore thought fit, by and with the advice of His Majesty's Council, to isue this Proclamation, hereby requiring all His Majesty's Officers in this Province, to whom the same doth belong, that they omit not at their peril, but do forthwith transmit to the said Receiver-General, all and every abstract or account of Fines, Forfeigures. andother dues belonging to His Majesty as hey are by Law required to do, and which ley or either of them may have heretofore time hereafter as the same may be incurred r arise, regularly transmit abstracts or acounts thereof to the said Receiver-General. And further, that the said Officers do pay which may now be in or hereafter may come | Executive Council of the said Province. to their Hands respectively for His Majes-

And the law Officers of the Crown are hereby enjoined to prosecute according to Law all persons who shall disobey this Proclamation,

A PROCLAMATION.

And Whereas by letters patent, under the Great Seal of our said Province, bearing date at our Castle of Saint Lewis, in our City of Quebec, the twenty-seventh day of April, in the present year of our reign, we have nominated, constituted and appointed, JEAN THOMAS TASCHEREAU, MI-CHEL LOUIS JUCHEREAU DUCHES-NAY, and GEORGE WATERS ALLSOPP, Esquires, to be Commissioners, to hear and determine all applications that shall or may be made to them, by persons holding or claiming to hold Lands as aforesaid, for Grants thereof, under the Great Seal of our said Province.

Now therefore know ye, that we do hereby notify and require all persons holding, er claiming to hold, Lands in the said Inferior District of Gaspe, to present their claims thereto before the said Commissioners, at Douglass Town, Percé, New Carlisle, Bonaventure, New Richmond, Carleton, and Ristigouche, from this date to the first Sepiember next, and at Quebec at any period within fifteen months next after the date of these presents, to the end that such claims may be heard and determined, and that Grants under the Great Seal of our said Province may be made.

REMOVAL OF THE NAVALESTABLISH-MENTS.

The intelligence of a local nature, received by the packet, is most extraordinary and unexpected. We had already seen with regret and astonishment our vessels excluded from the ports of a neighbouring nation,our rights relinquished by the adoption of a course of policy, which permits foreigners to frequent the harbours and bays of this colony, and to take and cure fish upon its shores; -but we never could have imagined, that one of the finest foreign Yards in His Majesty's dominions was to be abandoned; and its buildings consigned to ruin and decay. Such however is the fact; -and it is this day our unpleasant duty to announce to the public, that the stores in the Naval Hospital are to be removed to Bermuda, and the officers and people of that department are to be discharged, with the exception of a clerk, a porter, and one labourer, and that the Dock Yard is to be placed upon the same establishment as that of Gibraltar which we believe has an officer and six la-

We view this measure, in common with every well wisher to the Province, with sorrow and concern; not that we think this colony does not contain resources within itself, which if called into action by the united energies of its population, would be amply sufficient for the support and prosperity of its inhabitants; but because we consider the dismissal of the people to whom these departments have hitherto yielded support, and who are, generally speaking, old and faithful servants of Government, as an act pregnant with the most serious consequences to themselves and their numerous families; that it is withdrawing a large sum of money from circulation, at a period when the commerce of the country labours under the most extreme depression: - and also that it must be viewed as demonstrating the near approach of that period, when this Province will be torn from the British diadem.

It has long been the opinion of well informed men, that Government in making Bermuda a naval depot, contemplated the possibility of ultimately losing these Provinces, and was therefore desirous of guarding against the pernicious consequiences, which might result to the other colonies in the western hemisphere in consequence of that event, by having a place whose insular situation, together with its natural and artificial defences, would at all times offer a retreat for the British sleets. But it could scarcely have been contemplated that in the midst of peace and security, the navalarsenal at Halifax on a reduced scale, would be destroyed, and its stores removed to a place difficult of approach, liable to the fevers and tempests of a West India climate, and where the expence of victualling the persons employed by government, amounts to treble the sum which would be required in this Province. concealed to avoid being served with the or- Besides all this, the Dock Yard at Bermuda dinary process of Law, with an intention of is by no means complete, and the approach to it is rendered extremely difficult, and even dangerous, owing to the intricacy of the navigation; and notwithstanding the immense sums which have been expended, a vessel cannot be hove down without much risk, and must be righted should a fresh breeze spring up from any point in the compass from north-east round to south-west.
