FOR the information of persons who have, or may become Subscribers to assist the Welch Families, the Committee state, that it will be requisite in order to form a permanent establishment to enable them to construct Huts to shelter their families before the Winter sets in. These Huts constructed in the simplest manner, (that is to say, round logs 15 feet long, laid up 7 or 8 feet high, covered with back; a door and one small window; the chimney of mud and sticks, or stone; to say nothing about the floor) will cost at least, £8 for each; then allowing only £7 more for Provision, &c. for the families on an average, from the present time till they get their first crop, which will be a year at least, it will take \$300 to settle 20 families. To persons acquainted with the difficulty of forming new settlements the above sums will not appear extravagant, particularly when it is known that most of the families are very destitute -- that they are going ten or twelve miles into the wilderness, where there is not the least sign of cultivation, and where it will be impossible to get employment to procure subsistence without abandoning the settle-

These statements are to show that it was the intention of the meeting to put the families in a way to become useful Settlers, by furnishing those means, without which, however small, they could by no means move on their lands. That it was not their intention to make them idle, or to damp their exertions by giving too much, for they were well aware that on the industry of the settlers, the prosperity of the settlement must ultimately depend. It was their design to assist and stimulate industry not to destroy it : And it is evident, without some effort to assist them, the settlement could not have been formed, as the families had already began to disperse for the want of encouragement.

There have also been objections to confining the purposes of the society to the Welch and not to emigrants in general. The Welch families were the particular objects of the meeting, because they had been some time in town---lands had been surveyed for them, and they appeared particularly in want of some assistance to enable them to commence settling. Their families were straggling through the Streets or crowded in Barns; the season for peeling bark to cover the huts was nearly, if not already expired, and the business admitted of no delay. For these reasons it could not be expected that the meeting should at once take up a subject of such general importance to the Province.

The Committee, however, believe they are correct in stating, that should the subscriptions amount to more than is necessary for the above purposes, it was the intention of the meeting to apply the overplus to the assistance of emigrant settlers in general.

The Committee are thus particular, because they are convinced it is the want of understanding the design of the meeting that has prevented several Gentlemen from giving it their support.

The Subscriptions at present, amount to about £135 besides a large quantity of clothing received. As the Papers were dispersed through the Town, the names of Subscribers could not be inserted at

BOSTON, JULY 20.

Further extracts from foreign papers received by the Rubicon, from Havre.

Some changes says a letter from Frankfort, in the form of government, are expected in the different states of Germany. Austria appears immoveable in the midst of the general agitation. They wish to maintain the aristocratic institutions in the two kingdoms of Saxony and Hanover. But it is not believed they can succeed.

Germany appears much agitated --- in every part the principles of just and free government are canvassed and supported. They are now occupied in the second Bavarian assembly on the important discussion upon the introduction of the trial by jury---the publicity of the courts, as well of civil as criminal jurisdiction --- nothing is yet decided. (In some parts of Europe, the courts are not open to the Public---the prisoner, the Advocates, and the Judges, are only allowed to enter the room.)

In Hesse-Darmstadt, the deputies of the commons assembled to deliberate on grievances, in spite of the prohibition of such assemblies. The government has taken new measures to hinder such meetings.

The inhabitants of Bavaria on the Rhine have been alarmed by the report of the demand of a great German Power to take possession of Laudan, and garrison it for the future. These rumours it is thought will be contradicted.

The second Bavarian chamber have agreed almost unanimously, to introduce jury trials and to make courts public --- they have petitioned the King to propose such a law.

EMIGRANTS-EASTPORT.

The town of Eastport, Maine, having recently suffered by foreigners, the Selectmen and Overseers of the Poor have advertised that they will prosecute every one who shall introduce poor or criminal foreigners, contrary to the law of Feb. 1794, which

"That if any person shell bring and leave any poor and indigent person in any town or district in this Commonwealth, wherein such pauper is not lawfully settled, knowing him to be poor and indigent, he shall forfeit and pay the sum of Twenty Pounds for every such offence .-- That it any Master or other person, having charge of any vessel, shall thereafter bring into, and land, or suffer to be landed in any place within this Commonwealth, any person, be-

fore that time convicted in any other State; or in any foreign country; of any infamous crime, or any for which he hath been sentenced to transportation, knowing of such conviction, or having reason to suspect it; or any person of a notoriously dissolute, infamous and abandoned life and character, knowing him or her to be such, shall, for every such offence, forfeit the sum of One Hundred Pounds .--- And that the Master, or any other person having charge of any vessel arriving at any place within this Commonwealth with any passengers on board, from any foreign dominion or country without the United States, shall make a report in writing, under his hand of all such passengers, their names, nation, age, character and condition, so far as hath come to his knowledge, to the Overseers of the Poor of the town or district, at or nearest to which such vessel shall arrive. And every such master or other person, that shall neglect to make such report, or that wittingly and willingly make a false one, shall for each of those offences forfeit the sum of Fifty Pounds."

MONTEGO BAY, JULY 3.

"His Britannic Majesty's frigate Euryalus, of 36 guns, Capt. Hushisson, appeared off our harbour on Tuesday afternoon. Her commander having come on shore, we learned that he had been to Margaritta, and had found that Island in a state of perfect uproar and confusion. -- Jolli, it seems, had insisted upon his being appointed Commander-in-Chief of the Patriot naval forces, and had hoisted the French flag at the foremast of his vessel, while Brion, as emblematical of their enmity, displayed the English ensign on board of his ship. Jolli, however, had been put under arrest, and was to be brought to trial for his mutinous conduct."

KINGSTON JAMAICA, June, 26,

It was currently reported at Curacoa, and generally accredited that Jolli, who commanded Brion's flag ship, had been sentenced by a Court Matrial to be shot, in consequence of which the seamen of the Independent squadron were in a complete state of insubordination and mutiny.

Bello, in 13 days.

A letter from Porto Bello, received in this city, states that sixty artizans, who had been in M'Gregor's army, had commenced business at Panama; that about sixty privates of the same army, mostly Irishmen, had enlisted in the Spanish Regiment of Catalonia, and their officers had been marched to Darien.
