The Turks, on their entrance. found Parga a desert; and the only signal that marked their reception, was the smoke of the funeral pyre, in which its late inhabitants had consumed the bones of their forefathers .-- The unfortunate Emigrants are now principally at Corfu waiting, as houseless wanderers, the distribution of the miserable pittance of £48 per head, obtained for them by their protectors which is to be called. a compensation for the loss of their property, their native soil, and social existence. Thus has closed this memorable negociation in a scene of calamity which the most lively imagination could not have anticipated; but which, until some new enormities shall have effeced the recollection of it, will rouse noainst the Councils and Counsellors of this empire the antipathy and indignation of mankind."

## EMIGRANTS.

Ta MEETING, holden at the Jerusalein Coffee-House on Saturday evening last, in behalf of Emigrants, after examining the destitute state of the Welch families and the amount already obtained for their relief, it was resolved, that those persons who have not yet contributed to assist them, should be waited on with the subscription list and solicited to contribute for that purpose,

28th September, 1819.

It must be evident to every reflecting person, that it is of the utmost consequence to get as many of the destitute families, at present among us, as possible on their land before winter, for if they remain in town there will not be employment for them; and as they would not be left to perish outright, a subsistence, however miserable, must be afforded them, either by individual charity or at the expence of the parish. The Overseers of the Poor have their hands full already, the present rates are paid with extreme reluctance, and no friend to the country can wish to have the number of unproductive persons augmented. House room, 100, would be difficult to procure—few persons, however willing to assist the distressed, would like to admit families whose hallits are so different from their own, into their houses. It is evident, then, that it would cost more to furnish the poorest shelter and fuel (to say nothing about food, for less of which will serve when children are kept warm) for a family in town, than it would to feed them in the woods, where they would have plenty of fuel and be kept warm. The consumption of wood also would there be a great advantage, as it would clear sufficient ground to raise potatoes for the next year; it would not only be keeping their families comfortable through the winter, but promote the means of future subsistence. - This is not all, but by remaining in town their habits and morals may be affected; the want of a steady occupation and encouragement, might destroy industry, give them a distaste to the steady life of a husbandman, and lead them into idleness and knavery, or what is worse, drunkenness.

To prevent those evils-to assist and stimulate industry—to procure shelter and food for the destitute—to strengthen the arm of government - and to add to the real strength and prosperity of the Province, by assisting and settling a number of families of good morals, of sober and industrious habits, and whose sole occupation must be husbandry : - these are the motives which the friends of the emigrants have in view,

which they are endeavouring (though under many discouragements) to accomplish, and in which they hope to succeed; and they feel confident that those motives require but to be known to ensure them the support of a large portion of the community.

To the Free and Independent Electors of York County.

GENTLEMEN, The period is near at hand when you are to shew your prudent discrimination in the choice of persons to represent your County in the Legislative Assembly of the Province.
