On the representation of the Captains commanding the large ships in ordinary on the Canadian Lakes, Warrant Officers have been appointed to ail vessels; some of which are large first rates, as the following list, which we have been favored with, will shew. This is a wise measure, and ought to have been adopted sooner. We hear, also, that an extra number of Warrant Officers are to go out for the purpose of providing for casualcies.

Ships and Vessels on Lake Ontario, 1816. MANCHESTER .--- A Declaration of Loyaliy and account in Church and State, signed by above a thousand of the Inhabitants of Manchester, was on Monday presented to the Prince Regent. A hope is expressed in this declaration, " that the wisdom of the Prince Regent's Councils and the authority of the British Legislature, will permanently secure from violation and abuse, privileges, which are so dear, (as the freedom of the Press and the right to Petition) to the heart of every Briton." Referring to the conduct of the Magistrates, it is remarked, that -" It will be obvious to every one who gives the subject a calm and dispassionate attention, that the Magistrates and others of our fellow-townsmen, who have been so wantonly assailed with insult and abuse, are solely withheld from vindicating themselves from these calumnious aspersions by a firm and magnanimous sense of public duty, by a determination not to suffer any personal feelings of injury and insult to betray them into those premature disclosures, which might defeat the salutary ends of public justice." OCTOBER 80.

We lay before our readers, this day, an ample account of the proceedings which took place yesterday at Norwich, where the Norfolk County Meeting was held. pursuant to a requisition, signed by the Duke of Norfolk, and other Noblemen and Gentlemen. The space which we have been anxious to devote to the meeting uself, must necessarily circumscribe our comments upon it. To our great surprise, his Grace the Duke of Norfolk was not there himself. No cause was assigned for his absence. The meeting was not numerous ; scarcely three thousand persons being present. Lord Albemarle opened the business in a speech, which vchemently insisted upon " a revolution being at hand,"

The language of the Declaration is sound and constitutional. Whilst, on the one hand they recognize the undcubied right of the subject to meet and discuss grievances, they, on the other, deprecate the alarming abuse of this right which has lately taken attachment to the King and Constitution, and their deep abhorrence of the impiety and sedition so widely disseminated of late in speeches, painphlets, and newspapers ; but they pledge themselves to resist, to the utmost of their power, all attempts to subvert the Constitution and overawe the Constituted Authorities.
