are assault of those who contended that congress alone possessed the right to dicide on the question of war or pleace. Suppose gen. Washington had at that time attempted to make war, as your commanding general has done, do you believe that men who called themselves republican, would have attempted, as on the present occasion, to justi'y a clear, palpable and manifest usurpation on the powers of congress, by an appeal to the law of nations ? Or, do you believe this new tangled notion of the immutable principles of self-defence would have protected from public indignation a convicted violator of that sacred instrument? The patriots of that day were honest, upright and eulightened statesmen. You held among them yourself a station which does honor to character, talents and principles. With them as a reward for supporting with ability and firmness the correct principles of the constitution, you have risen to the highest stations within the gift of your country. Remember the principles to which you owe your political honors. Compel those devendent on you to respect them. A president of the United States may avail binself of the talents of his cabinet, but he must in every case, exercise his own judgment. He is alone responsible. If party distinction shall cease, and all honest men unite in supporting the bear interests of our country, let the basis of union be that construction of the constitution for which the republicans of 2798 successfully contended, and on which construction the people have pronounced in a voice too clear to be misunderstood, by elevating to the highest office in their gift almost in succession, its ablest defenders .---Let every officer under your control be made to know and feel that the constitution is the supreme law: that military usurpation is of all others most odious to freemen, as most dangerous to liberty.

Mr. Printer,

Sir. --- Certain writers in your paper have lately taken up the subject of the dissolation of the House of Assembly for no other purpose than to give their opinions for and against the measure. They have taken upon themselves to probe the wound, without applying any remedy. But on the contrary view have irritated and influend it, so that a high state of fever must be the inevitable consequence. My view of the subject is quiedifferent. As a private Citizen, most incerely desirous of seeing my native Province proceed with harmony in its rapid strides towards perfection, I regard the late exercise of the prerogative of the Chief Magistrate, as one of those human events, which, spearing at first sight to be a serious evil, turns out in the end to be productive of the greatest good. Let us not trouble ourselves with vain endeavors to prove that His Excelency acted with precipitation, or the house of Assembly unconstitutionally : -- the event happened and cannot be undone. What then should be the course of every man of sense?--- Why he should now consider, that, he has had once more thrown into his hands, that invaluable privilege of a British Sul-Jest, the choice of a Representative; and that it is a sacred duty, due to himself, to his family and to posterity, to exercise it with deliberation and judgement; he should lay aside all party spirit and animosity, all selfish and interested views, and he should resoive to give his vote to that man only, whose talents are respectable, whose principles are

independent, and whose patriotism is known. He should moreover instruct his Represensacive and enforce it upon him as a condition of his election, to have always in view the proposal and support of measures for the amelioration of the people and of the Country. He should constantly look around him to see whether, any and what improvements can be made for the public good; whither, for instance, it would not be a measure of the first magnitude in the scale of national prosperity; and of individual conveniency, to remove the Seat of Government from the SEQUESTERED Village where it has heretofore been held, to the Metropolis of this Province, this populous, flourishing, and patriotic City: a City at once the residence of enterprising and wealthy Merchants, of professional men of great talents, of ingenious and industrious mechanics, the constant resort of our own and neighboring country Gent'n, farmers, &c. for the purposes of that Trade, which has been, is, and will be, the true source of the prosperity, riches and ultimate establishment of every part of the Province.

The removal of the Seat of Government would of course bring with it, that of the supteme Courts of Justice, a removal most devoully to be wished, for the sake of public justice; the personal conveniency of the Lawyer and his Clients; the dispatch of business and the saving of enormous expences. I only mean at present to describe the general outlines of a great and important plan, which admits of strong colouring, and altho' I am aware that great opposition will be made to the proposition, supported by brilliant talent and personal interest, yet I will not shrink from the combat; let the subject receive as it merits, cool and dispassionate reasoning; in my mind, the public benefit cries aloud for the change; times and circumstances render it expedient, and if the next year does not bring it to bear, I VIRGINIUS. will venture to predict that, it must and will happen at no very distant period.

> Thus Mr. Printer, you will see, it is not my desire to squabble about who was right or who wrong in the late question; my object is to extract good out of evil. The day of election draws nigh and I wish all constituents to reflect upon the importance of choosing such men only as have the good of their Country at heart.
