Extract of a Letter from Port Glasgow, dated 27th April.

" Business continues in a very distressed state in Great-Britain. A House in Manchester failed last week. by which failure an individual house in Glasrow will lose nearly £200,000, and should this depression continue, the Timber trate must suffer with the rest.

"Two expresses have been sent over land to Calcutta-one from Glasgow, and one from Liverpool. for the purpose of countermanding the orders for Cotton from that quarter, and consequently the ships now there, must return in ballast -the amount baid to each of these Expresses for the performance of the journey, is £3000."

London dates by the English mail which arrived resterday at the Post Office, are to the ath ult.

Mr. Grattan's motion for a Committee to consider the state of the laws, excluding Catholics from a participation of all civil rights, with a view to their repeal was brought forward on Monday in the House of Commons. The motion was seconded by Mr. Croker in a speech which made a very powerful impression. It was opposed by Mr. L. Foster, and at a late hour of the night, defeated by a majority of two. The numbers being according to some calculations-noes 248-ayes 246; according to others-noes 243-ayes 241.

A plot to poison the Emperor of Austria has been timely discovered at Mantua, and has called forth nany observations. The plot was to have been executed at Rovigoe More than two hundred persons have been arrested in consequence.

London, May 1.

The Leeds papers notice the alarming decrease of upward of 240,000 yards of cloth in the manufacture of this year, as compared with last.

The calculation in the city is, that within the last nine months, not less than 8,000,000 of money have been lost by the speculators in corn and cotton

The general revenue, since the end of last quarter, is said to be falling off £90,000 weekly.

The Prince Regent has had a very severe attack of the gout. The following Bulletin was issued on the 20th Abril :-

The Prince Regent has less pain in his left hand and wrist. The gout showed itself actively yesterday evening in the right foot. His Royal Highness, however, has passed a more tranquil night, and is altogether better this morning.

" Windsor Castle, May 1. "His Majesty's bodily health continues to be good, and he is generally in cheerful spirits, but his Majesty's disorder in undiminished."

THE PATRIOTIC CITY AND SEQUESTERED VILLAGE.

Mr. LUCKIN.

I have to make an apology for omitting to pursue this subject according to the intention held out by me in my last communication. Having some Timber concern at the Wapskahagen, about 150 miles above the Sequestered Village, I have been necessarily absent, and my visit to the Patriotic City since my return, has al e taken up some time. I shall now proceed ----

I find the Freeholder has been emitting a little more light through the medium of the Star. We are not only informed of the " paternal care and solicitude of the Crown" (rather a brilliant conceit I must confess) but we are told " the situation of a Metropolis is of no consequence ! " " My argument is, (says the Freeholder) that wherever the " Metropolis is, there should be the Seat of Govern-"ment"!-I wish, Mr . Lugrin, the Freeholder (who appears to be very condescending and good natured) would have the goodness to let us know what constitutes a Metropolis .- And while he is about it to inform us which is the Metropolis of the United States, and when and by what means it acquired that rank The argument (as he calls it) of some people would be that wherever the Seat of Government is, there is the Metropolis. Petersburg in Russia is but about a century old and is now that Metropolis of the Empire. formerly Moscow had that rank but she lost it, and when ? -- not until the number of Houses in the former exceeded that of the other ? ---According to the Freeholder's argument, Petersburg never ought to have been the Seat of Government. Whatever notions may be entertained by the wise Freeholder, I am of opinion that the Situation for the Seat of Government is of great importance .- So thought Peter the Great when he founded Petersburg .- So thought the Government of the United States when Washington was built " for the Metropolis"--- and so thought the Government of the State of New-York when Albany was fixed on for the Seat of Government, because it was situated more in centre of that large and populous State, than the City of New-York, which was formerly the Seat of Government. But to return to the point of digression : I have paid the promised visit to the Patriotic City, and find it to be increasing in population and wealth -. The Free-Port Act is likely to be of great advantage to its Trade --- It is a flourishing place, situated at the mouth of a very fine River, which is the principal source of its consequence - The Harbour is not equal to Port Roseway or Shelburne in Nova-Scotia, but the River is every thing to the City. I rejoice at the prosperity of the City ; but I confess I do not like to see the City ettempting, in the person ofits Champion, the Freeholder, to exalt itself by degrading other parts of the Province, and particularly the sequestered Village-That Fredericton is not a City, is very certain, and it is much to be lamented that it is not, because it has not the inestimable blessing which the Patriotic City possesses, of choosing its own Justices of the Peace every year It is astonishing how niggardly Governments are in parcelling out benefits to the People !-- I believe the City of New-York and the Patriotic City are the only two who enjoy the privilege of choosing their own Justices every year-I mean a choice by the People at large - In those two Cities every Freeman or in other words, every man who lives in either of the Cities may have a chance of either electing, or being elected a Justice every year. In this sequestered Village we are obliged to submit to the Justices appointed by the King, and how can His Representative know as well what is good for the reopic as they can themselves ? I remember hear-

GIBRALTAR, APRIL 3.

Some of the American squadron have been here these few days, and have insulted some of the Officers of the 64th Regiment, and sent challenges, and two duels, fought on the neutral ground the day before yesterday. In the first, a Captain of the 64th was wounded in the thigh, at the third shot; he is doing very well however. The next affair was between another American officer and Capt. Johnson, of the same Regiment, who wounded the American the second shot, but slightly, and again struck him, on the fourth shot, in the groin, and it is reported he is since dead.---Another duel took place in Samst George's Cave yesterday, at 4 o'clock, between Capt Dixon, of same Regiment, with another American Captain, and wounded the American the first shot, on the head; the guard came to take them prisoners, and the American endeavouring to get away from the guard, being weak with loss of blood, fell and cut his face. Notwithstanding the duel, Capt. Dixon borrowed a horse from a gentleman, mounted the American on it, and proceeded with him all the way to Ragged Staff, where the Am. boat lay. The guard at that place were going to stop him. but Capt. Dixon told the guard to take him and let the American go, as he had given his word of honour that he should not be stopped. - They sloop of war is moved this morning to Algiers.
