DREADFUL CRIME!

Very few of our readers will have read of a more horrid, diabolical, and coolly premeditated murder, than that which is described in the following extract of a letter from Pictou.

Extract of a Letter from Pictou, dated August 26, 1819.

" I mentioned in my last the dreadful fate of poor Campbell and his Wife. Suspicion having fallen on their Son, Donald, he has been arrested, and undergone two examinations—on the first he denied all knowledge of the circumstances connected with the death of his Parents on the second, bowever, in consequence of his wife having given to the Magistrate a different account of the period he was absent from home, to that given by him, he voluntarily confessed : That he left his dwelling on Monday with the full determination of setting fire to the house of his Father, and burning him and his Step-Mother-that he wandered from one house to another until Thursday, planning how he might best accomplish his object. On the evening of that day he approached his Father's house, and stood listening to the conversation of the old people until near eleven o'clock, when they retired to rest. He then procured some withs from bushes at no great distance, and a stick of about four feet long: the latter he placed across the door-way, then twisted the withs. put them through the handle of the latch and round the stick, and secured the door so effectually, as he supposed, that it could not be opened; and, the door secured, there was no way of escape for his Parents, there being no windows to their cottage. The fire which he had brought a distance of half a mile, from where some persons were burning land, as it is termed, he placed on the roof of the house, it immediately communicated to the building, and he returned to the bushes to witness the completion of his plans. Before the flames however had reached the lower part of the house, he discovered that the old man and his wife had forced the door, and effected their escape out of the house. He saw them endeavouring to save what articles they could from burning---his heart at the instant, became softened, and he resolved to assist them. He went towards the spot : his father, the moment he was recognized by him, charged him with having set fire to his dwelling, and, taking up a stick, obliged him to quit the place. He returned to the bushes---stood looking at the old people saving their furniture -- saw, he said, his father go into the house, he thought to bring something out---he did not return, and supposed he was suffocated. He then went up to his step-mother, struck her on the head with a stick, and she fell to the ground --- she raised herself up, and requested to be carried towards the house-the assisted ber, and she fell into the fire.

The above is the substance of Donald

Campbell's confession.

A Mr. M. Intosh, who lived about half a mile off, heard the cries of a person in distress, and saw the house was on fire---he ran to the spot--- Donald observed him coming, and concealed himself in a field of grain. M. Intosh saw the body of Mrs. Campbell lying at the threshold of the door; it was very much burnt; he removed it to some distance, and afterwards went to alarm the neighbours. Donald then left his place of concealment, viewed the fire for a few miputes, and then set off for his own house, about 12 miles distant, where he arrived the next morning about ten o'clock. On his way he was met by several persons, and questioned respecting the scars which were uron his face, about which he told different

His Wife, on his entering the House, and her observing, as she expressed terself upon her examination, " that he did not lo k as he had b fire looked," said to him---" Have you had any quarrel with your Father ?--- where have you been ?- -- how did your face become scorched ?" --- To which he replied, that he had had no quarrel with his Father—had been reaping for him, and that the Sun had scorched his face. A Messenger soon after arrived, to inform him of the accident, as it was then supposed to have been, and, taking care not to alarm him too suddenly, told him that his Father was very ill, and that his house had been destroyed by hre. He hastily asked several times, if his Father was in life. At 12 o'clock he left his home for his late Father's Farm, lottered on the road all the day, and reached the

place early the next morning: he found a number of persons there, and, among them, Mr. M Intosh, by whom he was instantly seized, charged with the murder of his Parents, and given in custody to those standing around him, by whom, however, he was very foolishly allowed to escape. He skulked about the woods, between his own Farm, and that which had been occupied by his Father, until the news reached Pictou town, and he was soon after apprehended by persons who went in search of him."

FERHAT on Sunday the 9th day of May last, I was discovered by the Pilot Boats while cruizing off Point Escuminac, a Schooner, about 15 miles distant, and bearing E.N.E. from E cuminac; and upon coming up alongside of her, was found to be a Vessel of about 60 tons burthen, having no person on board, water logged, no sails nor rigging of any description, nor spars, except the two lower masts and bowsprit. The water being discharged, three Pilot Boats towed her in from sea, and up Miramichi River about two miles above the Custom-House, where she now lays on the beach in safety -no person appearing as yet to claim her -no name.
