His Majesty's Officers in this Province, to whom the same doth belong, that they omit not at their peril, but do forthwith transmit to the said Receiver-General, all and every abstract or account of Fines, Forfeitures. they or either of them may have heretofore neglected to do; and that they do from time to time hereafter as the same may be incurred or arise, regularly transmit abstracts or accounts thereof to the said Receiver-General. And further, that the said Officers do pay over to the said Receiver-General all monies which may now be in or hereafter may come to their Hands respectively for His Majesty's use.

And the law Officers of the Crown are Law all persons who shall disobey this Pro-

clamation.
