The LIEUTENANT-GOVERNOR having received by the English February Mail (which arrived here at 6 o'clock yesterday afternoon) official accounts of the demise of His late Majesty of blessed and following Declaration, viz. glorious memory, and of the accession of His present Majesty King GEORGE the FOURTH, to the Imperial Crown of the United Kingdom of Great-Britain and Iscland, and the Dominions thereunto belonging: directions were immediately given by His EXCELLENCY, for the Proclaiming of the King with the requisite solemnities and ceremonics.

Preparatorythereto, at 10 o'clock this morning, minute Guns commenced firing from the Artillery Park, (the Standard hoisted half mast high) and continued for two hours; the Church Bell tolling the whole of the time, in honor of the memory of our late Most Gracious and dearly beloved Sovereign. At 12 o'clock His Excellency went in state to the Province Hall, where the troops in Garrison were paraded; and after the Members of His fate Majesty's Council had taken the Oaths of Fidelity to His present Majesty, and the like Oaths were administered to the Lieutenant-Governor, His Excellency took his seat in Council, in presence of a large assembly of the Magistrates and Officers of the Government, Civil and Military, and of the principal Inhabitants of the Town and Vicinity: when the following official communications were read by the Secretary :-

CIRCULAR.

Extract from the London Gazette Extraordinary -- Monday, 31st January 1820.

SIR,

It is my painful duty to inform you in of the Demise of His Majesty King George the Third. This melancholy event took place at His Castle of Windsor, on Saturday the 29th ultimo, at 35 minutes past eight o'clock, p.m. It will be satisfactory to you to learn that His Majesty, whose strength had gradually declined for some weeks, expired without the least apparent suffering. His present Majesty was proclaimed on the 30th ultimo, as announced in the enclosed Gazette, which also contains His Ma jesty's Most Gracious Declaration in Council.

His said late Majesty should hold any Office, Civil Warrant, or Authority, continue and be entitled in all Respects, notwithstanding the Demise of His said Majesty, to hold and enjoy the same : But nevertheless the same should be held or enjoyed only during the Pleasure of the King or Queen who should succeed to the Crown upon the Demise of His said late Majesty; and the Right and Title to & same. hold and enjoy, the same under the Authority of the said Act, should be determinable in such and the like Manner by the King or Queen who upon the Demise of His said late Majesty should succeed to the Crown, as the Right or Title to any Office, Place, or Employment granted by such succeeding King or Queen, during Pleasure, would by Law be
